Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Mad Engine Global, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of Plan

The following description of Mad Engine Global, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401(k) retirement plan available to all employees of the Mad Engine Global, LLC (the "Company") with the exception of union employees, nonresident aliens, and leased employees. Employees are eligible to participate on the first day of the month after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute between 1% and 90% of their annual compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Company makes a safe harbor matching contributions equal to one-hundred percent (100%) of the first four percent (4%) of eligible compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company in the form of discretionary matching or non-elective contributions. Contributions are subject to certain Internal Revenue Code (IRC) limitations. There were no discretionary matching or non-elective contributions made in 2024 or 2023.

Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by Reliance Trust Company which includes mutual funds and a stable value common collective trust.

Participant accounts

Each participant's account is credited with the participant's deferral contributions and allocations of the Company's contributions, plus a proportionate interest in the investment earnings or losses, and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their deferral contributions, rollover contributions, and the Company's safe harbor matching contributions plus earnings or losses thereon. Participants become fully vested in Company discretionary matching and non-elective contributions and related earnings after three (3) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or 50% of their deferral and rollover contribution accounts. The minimum amount that can be borrowed is \$500. The loans are secured by the balance in the participants' account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is repaid ratably through payroll deductions.

Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive account distributions in the form of a lump sum payment or installments over a period of time as defined in the plan document. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½.

Forfeited accounts

If an employee terminates before his or her Company matching or non-elective contribution accounts have become fully vested, such portion of the account is forfeited. Forfeitures may be used to pay plan expenses or used to reduce future employer contributions.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Certain investment related expenses are included in the net appreciation in fair value of investments.

Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value common collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued as the NAV of units of the bank collective trust. The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimating fair value. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments included interests in certain mutual funds and a stable value common/collective trust offered by Reliance Trust Company, the trustee as defined by the Plan. These investments and related investment transactions qualify as party-in-interest transactions. The Plan's record-keeper was ADP Retirement Services and therefore related transactions qualify as party-in-interest transactions. Fees paid by the Plan for eligible expenses on transactions totaled \$103,581 and \$93,708 in 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax status

The IRS has determined that the Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed ADP Retirement Services of such in a letter dated October 6, 2020. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 9 - Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Approximately 17% and 16% of the Plan's investments were invested in the American Funds 2045 Target Date Retirement Fund as of December 31, 2024 and 2023, respectively.

Note 10 - Subsequent events

Plan management has evaluated subsequent events through July 21, 2025, which is the date that the financial statements were available to be issued.
