Summary Annual Report

This is a summary of the annual report for Deborah A. King MA & Associates, Inc. Employee Profit Sharing Plan Trust 480910358 for December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a profit sharing defined contribution plan a single-employer plan.

Basic Financial Statement

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$467,027. These expenses included \$466,857 in benefits paid to participants and beneficiaries and \$170 in administrative expenses. A total of seven persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$4,753,842 as of December 31, 2024, compared to \$4,984,733 as of January 1, 2024. During the plan year the plan experienced a decrease in net assets of \$230,891. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$236,136, including employer contributions of \$153,779, income of \$49,976, from the sale of assets, and earnings from investments of \$32,381.

Information Regarding Plan Assets

The U.S. Department of Labor's regulations require that an independent qualified public accountant audit the plan's financial statements unless certain conditions are met for the audit requirement to be waived. This plan met the audit waiver conditions for 2024 and therefore has not had an audit performed. Instead, the following information is provided to assist you in verifying that the assets reported in the Form 5500 were actually held by the plan.

At the end of the 2024 plan year, the plan had \$4,753,842 in assets held by Stifel.

The plan participants receive year-end statements from Deborah A. King MA & Associates, Inc. that confirm the above information.
