Opinion

We have audited the financial statements of the DeLong's, Inc. NOTES TO FINANCIAL STATEMENTS (CASH BASIS)

1. DESCRIPTION OF THE PLAN

The following description of the DeLong's, Inc. Employee Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The DeLong's, Inc. Employee Health Care Plan provides health benefits to eligible employees of DeLong's, Inc. (the Company). The Plan was established July 1, 1983, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company administers the Plan through a third-party administrator, who acts as claims processing agent. The Plan's third-party administrator is Meritain Health, Inc. The Company provides other administrative services to the Plan without charge.

Benefits: The Plan provides health benefits (hospital, surgical, major medical), medical and dependent care Flexible Spending Accounts (FSA's), and life insurance for eligible employees and their eligible dependents. Eligible employees are defined as those employees of the Company that are regular full time employees who have provided at least twelve weeks of service. Coverage will be effective on the first Sunday following twelve weeks of employment. Covered health benefits are defined in the Plan document.

The life insurance coverage is fully insured through premium payments the Plan makes to an insurance carrier. The health coverage is a partially self-insured arrangement with a reinsurance policy to cover individual health claims greater than pre-established limits, subject to certain provisions. Claims are processed by the third-party administrator but responsibility for payments to participants and providers is retained by the Plan.

Effective January 1, 2024, the Company adopted and implemented the DeLong's Inc. Flexible Benefits Plan (FSA Plan) for the exclusive benefit of eligible employees, which is wrapped into the DeLong's Inc. Employee Health Care Plan. The purpose of the FSA Plan is to allow eligible employees to pay eligible qualified medical and dependent care expenses using pre-tax dollars. Covered benefits are defined in the FSA Plan document. Benefits paid are limited to the amount contributed by eligible employees during the year. Additionally, any excess contributions during the year that are not offset by eligible qualified expenses are forfeited to the Plan. The Company administers the Plan through a third-party administrator, Meritain Health, Inc.

Contributions: The Plan is funded by premiums from the covered employees and contributions from the Company. Employee premium contributions are based on established rates for the coverage selected by each employee and are withheld through a salary-reduction plan. The Company is required to fund the costs not covered by employee contributions and other sources. The contributions are based on the amount necessary to provide the benefits outlined in the Plan and are determined annually by the Company. The Company's policy is to contribute the maximum amounts allowed as a tax deduction by the Internal Revenue Code. Under present law, the Company is not permitted to deduct amounts for future benefits to current employees and retirees. All funds are used to pay the benefits on eligible claims and the necessary administrative costs.

Contributions to the FSA Plan are made solely by covered employees. Contributions were limited to the lesser of earned income or \$3,050 for the medical portion and the lesser of earned income or \$5,000 for the dependent care portion of the FSA Plan for the year ended December 31, 2024.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The Plan maintains its financial statements on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions and other amounts due the Plan are recorded when they are received and deposited, not when they are earned. Expenses are recorded when they are paid, not as they are incurred. As a result, statements of plan benefit obligations and changes in plan benefit obligations are not included in the financial statements.

Plan benefits: The Plan is a self-insured welfare plan with a reinsurance policy obtained through an insurance company to cover individual claims over a pre-established dollar limit (\$75,000 for 2024 and 2023) with no aggregate limit in 2024 or 2023, subject to certain provisions. The Plan's liability for health claims incurred but not yet reported and claims reported but not yet paid at December 31, 2024 and 2023, is estimated by the third-party administrator to be approximately \$268,000 and \$106,000, respectively (unaudited). There are no post-employment or post-retirement benefits provided by the Plan.

Stop loss: Premiums for stop loss insurance are included in reinsurance premium expense while stop loss refunds are netted with claims paid in the accompanying statements of changes in net assets available for benefits (cash basis).

Estimates: The preparation of the financial statements in conformity with the cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events: Events that have occurred subsequent to December 31, 2024, have been evaluated through July 21, 2025, which represents the date the Plan's financial statements were approved by management and therefore available to be issued.

3. TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter dated November 30, 1984, from the Internal Revenue Service. The Plan has subsequently been amended. However, the Plan sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, provided the termination does not diminish or eliminate any claim for any benefit to which a participant has become entitled prior to the termination of the Plan.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Cash and cash equivalents are held with parties-in-interest, and certain fees are paid to parties-in-interest.
