The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cornerstone Bank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Note 1 **Description of Plan**

The following brief description of the Cornerstone Bank 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Cornerstone Bank (The Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Compensation Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

Employees must attain age 18 to make Elective Deferral Contributions and receive Matching Contributions. Employees must complete 1,000 hours of service within a 12-month period to receive Safe Harbor Contributions and Profit Sharing Contributions. In addition, an employee must complete 500 hours of service during the Plan Year and be employed on the last day of the Plan Year to receive the Profit Sharing Contribution unless the employee terminates employment during the Plan Year due to death, disability or attainment of Normal Retirement Date.

Entry Date

Participants may enter the plan on the first day of the calendar month coincident with or next following the time they meet the eligibility criteria for Elective Deferral Contributions, Matching Contributions, Safe Harbor Contributions and Profit Sharing Contributions.

Contributions

Participants may elect to defer up to 75% of their Compensation on a pre-tax basis. They may also elect to make Roth contributions to the Plan on an after-tax basis. The Company will make a Matching Contribution in an amount equal to 50% of the employee's contributions that are not in excess of 6% of their Compensation. The Company may, in its sole discretion, make a Profit Sharing Contribution in an amount determined by the Company. The Company made a Profit Sharing Contribution in the amount of \$571,024 for the year ended December 31, 2024. The Company will make additional Safe Harbor Contributions to the Plan in an amount not less than 3% of Participants' Compensation. Participants may also contribute amounts representing distributions from other qualified plans (Rollovers).

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's Matching Contribution, Safe Harbor Contribution, allocations of the Company's discretionary Profit Sharing Contribution and plan earnings. Allocations are based on participant's earnings or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan.

Vesting

Participants are fully vested in their Elective Deferrals, Rollover Contributions, Qualified Non-elective Contributions and Safe Harbor Contributions. Vesting in Matching Contributions and Profit Sharing Contributions is based on Years of Vesting Service in accordance with the following schedule:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than One Year	0%
One Year but less than Two Years	20%
Two Years but less than Three Years	40%
Three Years but less than Four Years	60%
Four Years but less than Five Years	80%
Five or More Years	100%

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$67,157 and \$53,856 respectively. These accounts can be used for any permissible method that's described in the plan document. During the year ended December 31, 2024, forfeiture amounts of \$33,707 were reallocated to participants.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loan's are secured by the vested account balance and the interest rate will be comparable to the current interest rates charged by financial institutions for similar loans. Payments will be made through payroll deduction every pay period. The maximum number of loans outstanding at any one time is 1.

Payments of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or equal installments as defined in the Plan Document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. A terminated employee with a balance of more than \$1,000 but less than \$5,000 may either elect to receive this distribution in cash or roll over the distribution to an IRA or the qualified plan of your new employer. In the event of attaining age 59-1/2, participants are entitled to all of their elective deferrals, safe harbor contributions and their vested percentage of matching contributions and non-elective employer contributions. Participants may receive a distribution on account of hardship from all accounts that are fully vested, except your qualified non-elective contribution account and safe harbor contribution account.

Plan Termination

The Employer may amend, terminate or merge the Plan at any time. However, no such action may permit any part of the Plan Assets to be used for any purpose other than the exclusive benefit of participants and beneficiaries or cause any reduction in the amount credited to your account. If the Plan is terminated, all amounts credited to your accounts will become 100% vested.

Note 2 Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America require management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Compensation Committee determines the Plan's valuation policies utilizing information provided by the Investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related Company matching contributions, safe harbor contributions, and profit sharing contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivables are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Fees and expenses for general plan administrative services (for example, recordkeeping services and custodial services) may be charged to the Plan or paid by the Company. These fees and expenses may be charged to participant individual accounts if not paid by the Company and/or included in investment-related fees and expenses. How the expenses are charged to participant accounts will depend on the nature of the expense. Some fees may be charged as a fixed dollar amount per participant or as a percentage amount spread across the account balances.

Subsequent Events

The Company has evaluated subsequent events through July 22, 2025 the date which the financial statements were available to be issued.

Note 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that priorities the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 "Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access."

Level 2 "Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability."

Level 3 "Inputs to the valuation methodology are unobservable and significant to the fair value measurement."

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value into transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 Information Certified

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certificated as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the custodians of the Plan).

Note 5 Tax Status

The Plan uses a pre-approved plan document sponsored by Ascensus LLC which received an advisory letter from the IRS, dated June 30, 2020, stating that the document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believes the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company). Empower Annuity Insurance Company of America maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$717,090 and \$908,027, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

The contract permits the insurance company to terminate the agreement with 60 days advanced written notice.

Note 7 Related Party and Party-in-Interest Transactions

Plan investments include mutual funds and a guaranteed investment contract managed by Empower Annuity Insurance Company of America, the custodian, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 8 Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
