## *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Hemenway & Barnes 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

### 1. Description of Plan

The following description of the Hemenway & Barnes 401(k) Plan (the “Plan”) provides only general information about the Plan’s provisions. Hemenway & Barnes LLP (the “Partnership”) is the plan sponsor. Hemenway Trust Company LLC is an affiliated entity under the common control of the Partnership, which adopted the Plan in 2010. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of the Partnership and Hemenway Trust Company LLC after attaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The plan administrator is responsible for oversight of the Plan. The Plan’s Investment Committee determined the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the plan administrator.

#### *Contributions*

Eligible participants may make pre-tax elective contributions and Roth 401(k) contributions of up to 100 percent of eligible compensation as defined by the Plan, subject to certain Internal Revenue Service (“IRS”) limitations after completing two consecutive months of service. All newly eligible participants are auto enrolled into the Plan at a 3% deferral of eligible compensation.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, which for 2024 is \$7,500. Participants may contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans, as defined by the Plan. Participants direct the investment of their contributions into various options offered by the Plan. The Plan currently offers mutual funds, a common/collective trust, and self-directed brokerage accounts through which participants are able to invest in a variety of securities, including stocks and mutual funds.

Under the provisions of the Plan, the Partnership will make a safe harbor employer contribution to participants who have completed two months of service. The Plan’s safe harbor employer contributions are equal to 3% of a participant’s eligible compensation. The Plan also provides for a discretionary employer matching contribution to eligible participants who have completed one year of service. The discretionary employer matching contribution is determined by the Partnership annually. There were \$685,679 and \$1,464,148 of employer safe harbor and employer discretionary contributions, respectively, paid for the year ended December 31, 2024.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions and partnership contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Discretionary employer contributions are subject to vesting. For purposes of determining vesting of discretionary employer contributions made under the Plan, all years of service with the Partnership are included in determining the participant's vested interest.

A participant's discretionary employer contribution is fully vested after three years of credited service with the Partnership in accordance with the following schedule:

### *Notes Receivable from Participants*

A participant may borrow from their vested account balance subject to the administrative rules of the Plan. Any note receivable will not be approved to a participant in the amount which exceeds 50 percent of their account balance. The minimum note receivable amount is \$1,000 and the maximum note receivable amount is \$50,000, reduced by the excess of the participant's highest outstanding participant note receivable balance during the 12-month period ending on the date of the note receivable over the participant's current outstanding participant note receivable balance on the date of the loan. A participant may not have more than two notes outstanding at a time. Notes receivable are permitted for any reasonable purpose and loan refinancing is not permitted. All notes receivable will be considered a directed investment from the account of the participant maintained under the Plan. As such, all payments of principal and interest made by the participant will be credited only to the account of such participant. Certain direct fees are charged to the participant to set up and maintain the note.

The notes receivable bear interest at a fixed rate determined by the plan administrator (the Wall Street Journal prime rate plus 2 percent), which was 9.50 percent and 10.50 percent at December 31, 2024 and 2023, respectively. Note receivable terms may range up to five years unless the note receivable qualifies as a home loan. A home loan is a loan used to acquire a dwelling unit which, within a reasonable time, the participant will use as a principal residence. A home loan may be repaid over a period not exceeding 10 years.

### *Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant, or a participant's beneficiary in the case of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum or in periodic installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are eligible for in service distributions from participant deferral accounts after attaining the age of 59 1/2. Certain participants are required by law to receive minimum distributions by April 1 of the year following the year they turn 73.

### *Hardship Withdrawals*

A hardship withdrawal may be authorized by the Partnership in an amount up to 100 percent of the participant's contributions. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS, and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$409 and \$7, respectively. These accounts are first used to reduce plan expenses and any forfeitures that remain shall be used to offset future employer discretionary contributions and future employer matching contributions. Plan expenses were reduced by \$9,098 from forfeited non-vested accounts for the year ended December 31, 2024, see Note 5.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, the custodian, and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, respectively. Delinquent notes receivable are reclassified as distributions based upon terms of the plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid directly by the Partnership. The Partnership pays certain professional fees and other expenses related to the Plan; therefore, such expenses are not included in the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### *Subsequent Events*

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial N.A. ("Alerus"), a qualified institution as defined by ERISA, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

### **4. Fair Value Measurements**

The Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

### ***Mutual Funds***

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### ***Common Stocks***

Common stocks are valued at the closing price reported on the active market on which individual securities are traded.

### ***U.S. Government Securities***

U.S. government securities are valued at the closing price reported in the active market in which the individual securities are traded.

### ***Common/Collective Trust***

Units of a bank collective trust are reported at NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the security liquidations will be carried out in an orderly business manner.

### 5. Related-Party Transactions and Party-in-Interest Transactions

All plan investments are in the custody of Alerus, the trustee of the Plan as of December 31, 2024; therefore, any transactions between Alerus and the Plan qualify as party-in-interest transactions. The Plan made direct payments to Alerus totaling \$9,072 which are included in administrative expenses during the year ended December 31, 2024.

All plan investments are managed by iCapital, LLC, an investment advisor; therefore, any transactions between the Plan and iCapital, LLC qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees incurred by the Plan for investment advisory services were \$118,949, of which \$9,098 were paid from forfeited non-vested accounts for the year ended December 31, 2024, and are included in administrative expenses during the year ended December 31, 2024.

Total administrative expenses paid by the Plan during the year ended December 31, 2024, were \$128,021. The Partnership pays directly any other fees related to the Plan's operations. The Plan extends notes receivable to participants which are also considered party-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer discretionary contributions.

### 7. Tax Status

The Plan adopted a pre-approved plan document (formerly referred to as a "volume submitter" defined contribution plan document) sponsored by Alerus, who has received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the preapproved plan is qualified under Section 401(a) of the Internal Revenue Code ("IRC"), and therefore, the related trusts are tax exempt. Although there have been amendments to the Plan since receiving the most recent opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been made in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax provisions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2024 there were not any audits in progress for any tax periods.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
