Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Paradigm 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Plan Description

The following description of the Paradigm 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that was established in 2006 by Paradigm Acquisition Corp. (the Company) to provide benefits to eligible employees, as defined in the Plan document. Effective September 1, 2024, eligible employees are automatically enrolled in the Plan with a deferral amount of 5% of their eligible compensation, unless the employee elects otherwise. The Plan is subject to the applicable requirements of the Internal Revenue Code (the IRC), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration: The Company has appointed a 401(k) Investment Committee (the Committee) to manage the operation and administration of the Plan. The Committee has appointed Fidelity Management Trust Company to act as the trustee of the Plan and to serve as the third-party administrator. The Company has adopted an on-line enrollment process for participants in the Plan, which provides that participants directly input contribution amounts or percentages to be contributed to the Plan.

Contributions: Each year, participants may elect to contribute between 1% and 90% of their eligible compensation, as defined in the Plan document, up to the maximum allowable under the IRC which was \$23,000 and \$22,500 for the Plan years 2024 and 2023, respectively. All contributions are withheld by the Company from each participant's compensation and deposited in the appropriate investment funds as directed by the participants. Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participants aged 50 or older before the close of the calendar year may also elect to make additional catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations, which was \$7,500 for the Plan years 2024 and 2023. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Each year, the Company may make discretionary employer matching contributions as defined in the Plan document and as approved by the Board of Directors. In 2024 and 2023, the Company elected to match 50% of each eligible participant's contribution up to 6% of the participant's compensation, limited to a maximum discretionary employer match of \$3,000 in each year. The Company may also make discretionary profit-sharing contributions as defined in the Plan and as approved by the Board of Directors. The Company did not make any profit-sharing contributions for the 2024 and 2023 Plan years.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings or losses. Allocations of Plan earnings or losses are based on participant account balances, as defined and managed by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Participants may change their investment options at any time.

Payment of benefits: Upon termination of service, retirement, death or disability, a participant or beneficiary may elect to leave their account balance in the Plan or receive their total benefits in (a) a lump-sum amount equal to the value of the participant's vested interest in their account in the form of a rollover or cash distribution or (b) installments. The Plan requires the automatic cash distribution of participant account balances that do not exceed \$7,000.

Additionally, under certain circumstances, the participant is allowed to withdraw funds from the Plan. Participants over age 59½ are also entitled to receive a distribution of all or any portion of their vested account balances. Retired participants also have the option of delaying the receipt of benefits. The payments for retired participants, however, are required to begin no later than April 1 following the end of the year in which the participant reaches age 73.

Notes receivable from participants (participants' loans): Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of one-half of their vested balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are secured by the participant's vested balance. Such loans bear interest at the available market financing rates and must be repaid within a five-year period, unless the loan is used for the purchase of a principal residence in which case the loan must be repaid within a 10-year period. Participants may only have one loan outstanding at any time. Outstanding loans on December 31, 2024, and 2023 carry initial interest rates of prime plus 1%.

The Company determines the collectability of loans on a periodic basis. The determination is made based on the terms of the Plan document and the related Plan policies and procedures. If notes receivable from participants are deemed to be uncollectible, they are written off and reflected as benefits paid to participants in the financial statements in the year the determination is made.

Vesting: Participants are immediately vested in their contributions and any discretionary profit-sharing contributions and safe harbor matching contributions allocated to their account plus actual earnings thereon. Vesting in discretionary Company matching contributions plus actual earnings are 50% vested after one year of continuous service with the remaining 50% vested after two years of continuous service.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts may be used to reduce Company contributions and to pay reasonable administrative expenses. For the Plan years 2024 and 2023, \$78,515 and \$81,109, respectively, were applied from the forfeiture account to pay part of the Company's discretionary matching contributions. Total amounts held in the forfeiture account were \$3,228 and \$17,288 on December 31, 2024, and 2023, respectively.

Administrative expenses: All reasonable administrative costs and expenses may be paid by the Plan or charged directly to the participant's account, unless some or all are paid at the discretion of the Company. Expenses paid directly by the Company are excluded from the Plan's financial statements. Certain fees paid by the participant for trustee administrative services are included as a reduction of the return earned on each investment fund. Additionally, loan set up fees and distribution processing fees are paid directly by the participant. Administrative expenses totaling \$160,295 and \$163,700 were recorded for the Plan years 2024 and 2023, respectively.

Subsequent events: The Plan Administrator has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Accounting estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for loan losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan payments and the loan is deemed a distribution, based on the terms of the loan document, the participant's loan balance is reduced, and a benefit payment is recorded. Deemed distributions for the Plan year 2024 and 2023 were \$105,553 and \$2,545, respectively.

Investment valuation and income recognition: Investments of the Plan are held by Fidelity Management Trust Company and invested based solely upon instructions received from participants. The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Money market fund: Shares of the money market fund are valued at quoted market prices that represent the net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts consisting of mutual funds, common stock and money market funds that are valued based on quoted prices in the active markets on which they are traded.

Common collective trust (CCT): The CCT is valued at NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay the withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments as of December 31, 2024, and 2023.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Net change in fair value of investments: Realized and unrealized appreciation or depreciation in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation or depreciation, or on the last day of the year for unrealized appreciation or depreciation.

Risks and uncertainties: The Plan provides for various investment options which are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's investment options include funds that invest in securities of foreign companies which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Payment of benefits: Benefits are recorded when paid.

Note 4. Fair Value Measurements

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2: Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in active markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable, are supported by little or no market activity and are significant to the fair value measurement. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The descriptions of the valuation methodologies used for assets measured at fair value are discussed in Note 2. There have been no changes in the methodologies used as of December 31, 2024, and 2023.

Changes in fair value levels: The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the Plan years 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

The preceding measurements described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets classified as Level 2 or Level 3 of the fair value hierarchy as of December 31, 2024, and 2023.

Note 5. Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by a company affiliated with Fidelity Management Trust Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Certain fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund. The Plan also makes loans to participants.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6. Income Taxes

The Plan has adopted a pre-approved plan sponsored by FMR LLC. The pre-approved plan provider has received an advisory letter dated June 30, 2020, from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan advisory letter has been relied upon by the Plan. The Plan has been amended after the date of the advisory letter; however, the Plan Administrator believes that the Plan is designed and is currently operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination or Modification

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA and its related regulations. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.
