(1) Description of Plan

(a) General

Park Place Behavioral Health Care 401(k) Plan (the “Plan”) is a defined contribution plan covering all eligible employees of Osceola Mental Health, Inc. (d/b/a Park Place Behavioral Health Care) (the Company). Although the Plan was established effective January 1, 2011, formal operations commenced on October 1, 2011 when all of the assets associated with the Company’s participation in a previous multi-employer plan were transferred to the Park Place Behavioral Health Care 401(k) Plan.

(b) Contributions

Under the Plan, each eligible participant may elect to make a contribution in amounts determined by them generally not to exceed \$23,000 (plus a catch-up contribution limited to \$7,500 for individuals age 50 or older). Employees are eligible to participate in the Plan once they have attained the age of 21 and have completed one year of service. Employees may elect to participate on the first day of each month during the Plan year. Employees elect the investment vehicle(s) with the Trustee in which their contributions and employer contributions are invested.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan also contains employer profit sharing, safe harbor and matching contribution features. Both the profit sharing and matching contributions are provided at the discretion of the employer with the amount of contribution determined and set on a yearly basis. The Plan also provides for a safe harbor contribution which is equal to 100% of the first 3% of salary deferral plus 50% of the next 2% of salary deferral. For the year ended December 31, 2024 the employer elected to make contributions to the Plan of \$204,885.

(1) Description of Plan (Continued)

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Payments of Benefits

Upon termination of service, a participant may receive the value of the participant's vested interest in his or her account in a lump-sum amount or in installments.

(e) Participant Notes Receivable

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer from the investment fund to the participant notes fund. The term of the loan does not exceed five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.5%. Principal and interest are paid ratably through payroll deductions.

(f) Vesting

Vested rights to Company profit sharing and matching contributions accrue for employees who have worked 1,000 hours during the Plan year. Vesting accrues at 20% per year beginning after the participant's second year of service, with full vesting accruing at the end of year six. Forfeitures of Company contributions are applied first to reduce Plan administrative expenses and, secondly, to reduce the contributions of the following year. Participant and safe harbor contributions are vested immediately.

(g) Subsequent Events

In preparing these financial statements, the Plan has evaluated subsequent events and transactions for potential recognition and disclosure through July 25, 2025, which is the date the financial statements were available to be issued.

(2) **Summary of Significant Policies**

(a) **Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting and present the net assets available for benefits and changes in those assets.

(b) **Valuation of Investments/Participant Notes Receivable**

Investments are stated at fair market value determined by quoted market prices or their equivalent at the Plan year end with the exception of certain stable value investment contracts which are stated at contract value, as applicable. Changes in the aggregate market or contract value of the investments are charged or credited to net investment income for the year.

Participant notes receivable are valued at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of investments and participant notes receivable which amount to approximately \$3,100,000. Investments and participant notes receivable are monitored monthly by both the trustee and management of the Plan and are not subject to collateralization.

(c) **Payment of Benefits**

Benefits are recorded when paid.

(d) **Tax Status**

The Plan has received a favorable IRS determination letter dated March 31, 2014. The Plan Administrator believes the Plan is operating in accordance with its provisions and is exempt from federal income tax.

(d) **Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(e) **Use of Estimates**

Management of the company has made certain estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities to prepare these financial statements in conformity with generally accepted accounting principles. Actual results could differ from those estimates.

(f) **Fair Value Measurement**

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
