Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 Description of plan

The following description of Nardone Brothers Baking Company, Inc. 401(K) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all employees of Nardone Brothers Baking Company, Inc. (the "Company") who have one year of service with at least 1,000 hours of service and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Each year, participants in the Plan may contribute up to 100% of pretax compensation, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also provides for a Qualified Automatic Contribution Arrangement ("QACA") for all employees hired by the Company whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The QACA contribution as defined provides for a 3% employee contribution in the initial employment period and increases automatically 1% annually until a maximum 6% is reached. The Company's QACA matching contributions is 100% of the first 1 percent plus 50 percent of the next 5 percent of compensation that a participant contributed to the Plan. The Company's matching contribution, including QACA, was \$445,614 for the year ended December 31, 2024. Participants direct the investment of their accounts into various investment options offered by the Plan. Contributions are subject to certain IRS limitation.

Participant accounts

A separate account is maintained for each participant. Each participant's account is credited or charged with the participant's contributions and the Company's matching contributions, including QACA, and allocations of Plan earnings or losses, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions, including QACA contributions, plus actual earnings thereon. Vesting for the Company's matching contributions and earnings is according to a cliffed vesting schedule of 0% vesting for less than 2 years of service and 100% vesting for more than 2 years of service.

Notes receivable from participants

Participants are not permitted to borrow from the Plan.

Payment of benefits

On termination of service, death, disability or retirement, participants or their beneficiaries are eligible to receive a distribution of their vested account balances. In-service distributions due to hardships and attainment of age 59 1/2, as defined, are also permitted. Distributions under the Plan are made in one lump-sum payment or installments.

Forfeited accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures will be used to reduce employer matching contributions to the Plan. Any excess forfeitures related to employer matching contributions will be used to pay administrative expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts balances, respectively. In 2024, forfeited nonvested accounts reduced employer contributions by \$2,675.

SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

NOTE 2 Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain expenses of maintaining the Plan are paid directly by the Company and are

excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – December 31, 2024 and 2023: The Plan's investments in registered companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the

SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – December 31, 2024 and 2023: Pooled separate accounts (“PSA”) invest in a single mutual fund. The fair value of the mutual fund is a publicly quoted pricing input used in determining the net asset value (NAV”) of the pooled separate account, which is not publicly quoted but is available to current investors via the custodian. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, this investment has a “Readily Determinable Fair Value”. The fair value of the underlying mutual fund is based on third-party pricing vendors and utilize observable market information. PSAs typically can be redeemed on a daily basis. Since these investments are valued similar to mutual funds, they are treated as Level 1 assets.

Common Collective Trusts – December 31, 2024 and 2023: The Plan invests in a stable value collective investment trust (“CIT”) for which the net asset value (“NAV”) is based on the contract value. Investments held by a CIT are required to be reported at fair value, however, contract value is the relevant measurement characteristic for that portion of the net assets of a CIT attributable to fully benefit-responsive investment contracts. This is because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined-contribution plans. The NAV of the CIT is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. This investment has a “Readily Determinable Fair Value”. This investment is valued similarly to mutual funds and therefore treated as level 1 assets.

The following tables set forth by level within the fair value hierarchy the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by FASB ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. NOTE 4 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

NOTE 5 Tax status

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself, however, the Plan administrator and the Plan's counsel believe that the Plan is designed and has been operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt and no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 Related-party transactions and party in interest transactions

Certain Plan investments are managed by the Principal Life Insurance Company and Principal Trust Company, the custodian for the Plan and, therefore these transactions qualify as party in interest transactions.

The custodian provide certain administrative services to the Plan pursuant to a Service Agreement between the Company and the custodian. The custodian receive revenue from mutual funds and other service providers for services the custodian provides to the funds. This revenue is used to offset certain amounts that would be owed to the custodian from the Plan for its administrative services to the Plan had the arrangements with mutual funds and other services providers not been in place.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE 7 Certifications

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (the custodian of the Plan).

NOTE 8 Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 9 Subsequent events

On January 7, 2025 Nardone Brothers Baking Company was sold to MBC Companies.

The Plan has evaluated subsequent events through July 7, 2025, which is the date these financial statements were available to be issued.
