### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the financial statements of Cancer Partners of Nebraska Cash Balance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Plan Description

---

The following, brief description of the Cancer Partners of Nebraska Cash Balance Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a cash balance defined benefit pension plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the eligible employees of Cancer Partners of Nebraska, P.C. (the Company). Excluded employees include non-owners in non-clinical roles, PRNs, Interns, Students and Temporary Employees who have not completed one year of service.

All eligible employees will be included in the Plan following their employment date and completion of six months of service and attaining the age of 20.5 on the earlier of (a) January 1 or (b) July 1. Employees are eligible for a hypothetical contribution upon completing 1,000 hours after entering the Plan.

#### ***Participant Accounts***

Under the Plan provisions, amounts are credited by the Company to the participants' hypothetical accounts. The accounts are allocated principal credits and investment credits at the end of every year. Participants who complete one year of service and are employed on the last day of the year are eligible to receive principal credits. The principal credits are allocated based on the grouping method as defined in the Plan document for that particular year. Participants' hypothetical accounts also receive investment credits at the end of every year. The amount of the investment credit is a fixed rate of 4.00%.

#### ***Pension Benefits***

Benefits are determined based on the participant's hypothetical account balance. Plan participants are eligible for their Plan benefit after terminating employment with vested rights. Participants become vested in the Plan upon completion of 3 or more years of service or attainment of normal retirement age of the later of 62 or the 5<sup>th</sup> anniversary of participation in the Plan, and no later than 65 for participants who entered the Plan prior to January 1, 2016. Participants who entered the Plan on or after April 21, 2022 will attain normal retirement age at 65. If employees terminate before rendering 3 years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions. An employee that terminates prior to normal retirement age will receive a distribution equal to the present value of vested accrued benefits as soon as administratively feasible. Participants may receive lump sum, joint and survivor annuities or regular annuities upon attaining retirement age and termination of employment. Participants with a balance greater than \$5,000 have the option of receiving the actuarial equivalent value of the accumulation account in the form of a one-time lump sum payment or a monthly annuity payable for their lifetime. Balances between \$1,000 and \$5,000 shall be transferred to an individual retirement account, unless the Participant elects otherwise. Participants whose balances do not

exceed \$1,000 will be paid out in a lump sum. Upon separation from service, participants have the right to defer receipt of benefits until age 70.5. Benefits are recorded when paid.

### ***Death and Disability Benefits***

A participant shall become fully vested upon death and total disability. The death and disability benefit shall equal the actuarial equivalent of the participant's vested accrued benefit at date of death or disability. Terminated participants vested accumulated benefit will be paid to the designated beneficiary upon death. Terminated participants vested accumulated benefit will be paid to the participant who suffers a total disability. If the termination is a result of the total disability the participant will be eligible for the immediate commencement of the actuarial equivalent of the vested accrued benefit. If the termination is a result of death, the death benefit shall be distributed in the form of a qualified preretirement survivor annuity to the stated beneficiary. Benefits are recorded when paid.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 7 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Funding Policy*

Contributions to provide benefits under the Plan are made solely by the Company. Their funding policy is to make cash contributions to the Plan in amounts determined by the Plan's independent actuary, if required. The minimum funding requirements of ERISA are met for the years ended December 31, 2024 and 2023.

### *Other*

Custodial fees, investment and record-keeping expenses of the Plan are paid by either the Plan or the Company at the discretion of management. Audit and legal fees are paid by the Company.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statements of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 22, 2025, noting no items requiring disclosure.

### **3. Actuarial Present Value of Accumulated Plan Benefits**

---

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The actuarial present value of accumulated Plan benefits is determined by an independent actuary, Ascensus (formerly Newport Trust Company), and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and expected date of payment. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024.

The most recent actuarial valuation performed by the Plan's actuary was as of January 1, 2025. The significant actuarial assumptions used in these valuations are (a) life expectancy of participants (the IRS 2025 Annuitant-District Mortality Table was used in 2024 and the IRS 2024 Annuitant-District Mortality Table was used in 2023), (b) compensation increases of 6.0%, (c) retirement age assumptions (the assumed average retirement age was 65), (d) pre-retirement discount rate of 4.00% and (e) post-retirement discount rate of 5.00%. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

#### 4. Funding Policy

---

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Company accrued contributions of \$1,337,961 and \$1,178,802, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA. Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### 7. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 8. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 9. Plan Termination

---

In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

Generally, the Pension Benefit Guaranty Corporation (PBGC) guarantees most vested normal retirement age benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically on the amount of an individual's monthly benefit that the PBGC guarantees.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial conditions of the Company and the level of benefits guaranteed by the PBGC.
