We have performed audits of the financial statements of **Jasper Products, LLC 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Super Savings Plan as of January 1, 2025. The **Jasper Products, LLC 401(k) Plan** started transferring its net assets into the Dairy Farmers of America, Inc. Super Savings Plan as of December 31, 2024, and will cease operations as of that date. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Description of plan**

The following description of the **Jasper Products, LLC 401(k) Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Jasper Products, LLC (the Company) age 19 or older and who have completed 30 days of service with the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) was enacted and was effective beginning on January 1, 2020. The SECURE Act provisions included, among other things, an increase in the age limit for required minimum distributions from age 70 ½ to 72. The Plan is in the process of operationally being amended to implement certain changes related to the SECURE Act. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was enacted. The CARES Act provides immediate and temporary relief for eligible retirement plans and their participants who were adversely impacted by the coronavirus. Effective October 5, 2020, the Plan made the election not to be amended to allow for the provisions of the CARES Act related to coronavirus distributions and loans. The Plan was amended to allow for the temporary waiver of required minimum distributions for the 2020 calendar year.

Effective January 1, 2022, the Plan was amended and restated. Effective with the restatement, the Plan increased the automatic contribution agreement in which all eligible employees are automatically enrolled in the Plan to a rate of 6 percent, unless the employee elects otherwise. In addition, the Plan increased the automatic deferral increase amount to a maximum of 10 percent, unless the employee elects otherwise.

Effective April 12, 2022, the Plan was restated again with no additional changes.

In November 2024, the Plan was amended, and the process for merging into the Dairy Farmers of America, Inc. Super Savings Plan was started in order to be effective January 1, 2025. The Plan underwent a blackout period starting December 19, 2024, in which all contributions ceased going into the Plan.

Contributions

Each year, participants may contribute up to 60 percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic contribution agreement in which all eligible employees are automatically enrolled in the Plan at a contribution rate of 6 percent unless the employee elects otherwise. Contributions

are invested in a qualified default investment alternative until the participant directs the investment of the automatic deferrals into another investment option offered by the Plan. In addition, the Plan has elected to automatically increase the deferral percentage by 1 percent up to a maximum of 10 percent at the beginning of each plan year, unless the employee elect otherwise. Each year, the Company may make a discretionary contribution equal to a percentage of the participant's contributions. The matching percentage in 2024 and 2023 was 50 percent of the employee's elective deferral amounts up to 6 percent with a maximum employer match of 3 percent. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Employee contributions are subject to certain limitations as limited by the IRS regulations.

Participant accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, plus actual earnings thereon. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested in the Company match and discretionary contribution after five full years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$25,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1 - 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Interest rates range from 4.25 to 9.50 percent during 2024 and 2023. Principal and interest are paid ratably through weekly payroll deductions.

Payments of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or an annuity option. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or in partial payments, if a participant's vested account is more than \$7,000. If a participant's vested account is \$7,000 or less, then their account will automatically be distributed from the Plan and rolled over into an IRA account if the participant is under the age of 65 and the vested balance is over \$1,000, if the participant does not elect another option available. If the participant's vested account is \$1,000 or less, then the account will automatically be paid out as a single lump sum.

The Plan allows participants to make financial hardship withdrawals for all or part of their vested account, including earnings on elective deferral contributions, for immediate and severe financial need. Effective January 1, 2019, elective deferral contributions will not be suspended for six months following the date of the withdrawal.

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$1,744, respectively. These accounts will be used to reduce or add to future employer contributions. In 2024 and 2023, employer contributions were reduced by \$191,017 and \$161,841, respectively, from forfeited non-vested accounts.

**2. Summary of significant accounting policies**

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participant

Notes receivable from plan participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent events

The Plan has evaluated subsequent events through July 7, 2025, the date the financial statements were available to be issued.

**3. Fair value measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Separate account assets comprise of actively traded mutual funds and other investments with publicly quoted pricing input reported at the net asset value as of the measurement date. These investments are ultimately valued similarly to mutual funds and can be redeemed daily.

*Collective trust fund:* Valued at the NAV of units as provided by the trustee based upon the fair value of the underlying investments held by the fund less its liabilities. NAV is a readily determinable fair value based upon the underlying investments being mutual funds that are publicly quoted pricing inputs. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Guaranteed investment contract:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer (See Note 7).

**4. Summary of certified information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Principal Life Insurance Company for the years ended December 31, 2024 and 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's trustee.

**5. Plan termination and transfer of assets**

On November 1, 2024, the Company adopted a merger amendment that the Plan would be merged into the Dairy Farmers of America, Inc. Super Savings Plan effective January 1, 2025, and that the Plan shall terminate. Within the Plan amendment there were provisions to allow for prior years of service from Jasper Products, LLC and the same credited vesting schedule held by the Plan. Assets totaling \$58,604,808 were transferred into the Dairy Farmers of America, Inc. Super Savings Plan on December 31, 2024. The remaining Plan assets will be transferred out over a period of time as the remaining insurance contracts mature.

**6. Tax status**

The Plan was designed under a volume submitter prototype non-standardized profit-sharing plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, and the Plan Administrator believes that the Plan is designed,

and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**7. Investment in insurance contract**

The Plan invests in non-benefit-responsive Guaranteed Interest Investment Contracts with Principal Life Insurance Company (Principal). Principal maintains the contributions in separate guaranteed interest accounts based on the maturity date and provides a guaranteed interest rate. The account is credited with earnings on the underlying investments and charged for participant withdrawals or transfers. The contracts are included in the financial statements at fair market value as reported to the Plan by Principal. The Guaranteed Interest Investment Contracts promise contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to their maturity.

**8. Related-party transactions and party-in-interest transactions**

Certain Plan investments are managed by Principal Life Insurance Company. Principal Life Insurance Company is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan pays administrative expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

**9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
