Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of New York State Public Employees Federation, AFL-CIO-Union Plan (the Plan or Union Plan) provides only general information. Participants should refer to the plan agreement or summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all union employees of the New York State Public Employees Federation (PEF). Unionized employees of PEF are eligible to participate in the Plan upon completion of certain service requirements, as set forth in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Contributions are subject to certain limitations. The Plan permits participants to contribute up to 60% of their salary up to the maximum limits on employee contributions set forth by the Internal Revenue Code (IRC). In addition, there are further limitations on contributions made by highly compensated employees. Rollover contributions from other plans and certain IRA's are permitted. Participants direct the investments of employer and employee contributions into various investment options offered by the Plan.

PEF provided a 3% safe harbor contribution in 2024 and 2023 to all Plan participants. The Plan does not allow for other matching contributions.

The employee salary reduction contributions for the years ended December 31, 2024 and 2023 amounted to \$601,737 and \$488,318, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) PEF's employer contribution and, (b) Plan earnings and losses, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

The Plan currently offers thirty-four (34) mutual funds, and one money market fund through a regulated investment company. Participants may change their investment options daily. Upon enrollment in the Plan, a participant may direct contributions in 1% increments in any of the investment options.

#### **Vesting**

Participants are immediately vested in their contributions and accumulated earnings thereon. Additionally, the plan sponsor makes a 3% safe harbor contribution in order to satisfy special nondiscrimination rules that apply to the Plan. Participants are also immediately vested in the plan sponsor contributions at the time they are made.

## 1. DESCRIPTION OF PLAN (Continued)

### **Notes Receivable from Participants**

Participants are allowed to borrow from their accounts provided they borrow a minimum amount of at least \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Only one note receivable may be outstanding at any given time and may be used for any purpose. Notes receivable are secured by the balance in the participant's account. Interest is charged at prevailing interest rates as determined by the plan administrator at the time the note is originated. Notes receivable are required to be repaid in level payments of principal and interest paid through payroll deductions.

### **Withdrawals and Payment of Benefits**

Participant contributions made from pre-tax compensation are subjected to certain withdrawal restrictions, as specified by the plan document and the Internal Revenue Code. Hardship withdrawals may be made due to immediate financial need, as defined in the plan document.

Upon termination of service, death, or disability, participants may receive the vested portion of their account in a lump-sum distribution subject to certain tax withholding considerations.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

### **Financial Instruments Measured at Fair Value**

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds and a money market fund.

### Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies into a three level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the net asset value of shares held by the Plan at year end based on quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Payment of Benefits**

Benefits to participants are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by PEF and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

## **5. PARTY-IN-INTEREST TRANSACTIONS**

The Plan is sponsored by the New York State Public Employees Federation, AFL-CIO. The Plan and the sponsor are considered parties-in-interest based upon shared management and certain shared Board of Trustee members. The following organizations are considered parties-in-interest based upon services provided to the Plan during the years ended December 31, 2024 and 2023:

New York State Public Employees Federation, AFL-CIO – Plan Sponsor  
PEF Membership Benefits – Related Organization  
PEF Retirees – Related Organization  
Fidelity Workplace Services, LLC – Third Party Administrator and Recordkeeper

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan also qualify as party-in-interest transactions.

## **6. TAX STATUS**

The Plan is designed from a prototype plan offered by FMR, LLC. The Internal Revenue Service has determined and informed FMR, LLC, by letter dated June 30, 2020, that the written form of the underlying prototype plan document is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for its own determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **7. TRANSFERS BETWEEN AFFILIATED PLANS**

PEF also maintains a separate 401(k) Plan, the New York State Public Employees Federation, AFL-CIO-M/C Plan (the M/C Plan), which covers substantially all non-union employees. If a PEF employee switches job classification from a union employee to a management confidential employee or vice-versa during the year, they are no longer eligible under the originating plan. Both the Union Plan and the M/C Plan allow new participants to transfer into the new plan, assets consisting of participant account balances and certain notes receivable from participants. During the years ended December 31, 2024 and 2023, employees originally covered by the Union Plan transferred assets of \$99,429 and \$271,163, respectively, to the M/C Plan. For the years ended December 31, 2024 and 2023, employees originally covered by the M/C Plan transferred assets of \$4,403 and \$1,228, respectively, to the Union Plan.

## **8. PLAN TERMINATION**

Although it has not expressed any intent to do so, PEF has the right under the plan document to terminate the Plan subject to the provisions of ERISA. In the event of termination, each participants' account shall become fully vested and non-forfeitable and be distributed in accordance with the plan document.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 21, 2025, which is the date that the financial statements were available to be issued.
