## INDEPENDENT AUDITOR'S REPORT

To the Participants, Plan Administrator, and the 401(k) Committee  
Oklahoma Surgical Hospital, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Oklahoma Surgical Hospital, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### Note 1 – Description of the Plan

Oklahoma Surgical Hospital, LLC (the Hospital or Employer) sponsors the Oklahoma Surgical Hospital, LLC 401(k) Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established for the benefit of the Hospital's employees, except for union or collective bargaining employees, nonresident aliens, and as-needed shift employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Plan trustee, and the 401(k) Committee is responsible for the oversight of the Plan. The Plan entered into a group variable funding agreement issued by Massachusetts Mutual Life Insurance Company (MassMutual). Effective January 4, 2021, Empower Retirement, LLC (Empower) acquired and became the sole administrator of MassMutual's retirement business. Empower Annuity Insurance Company of America (EAIC), an affiliate of Empower, holds the Plan assets. Empower processes and maintains the records of participant data. Employee Benefits Group, LLC, serves as the third-party administrator for the Plan.

#### Eligibility

Nonexcluded employees who have reached 21 years of age and have completed one month of service are eligible to participate in the Plan. Participants may enroll in the Plan on the first day of the quarter after satisfying eligibility requirements.

#### Contributions

Participants may contribute up to 100% of their compensation, as defined in the Plan document, as either pretax or Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan also provides for Employer safe harbor matching contributions of 100% of deferrals up to 4% of a participant's compensation. Employer safe harbor matching contributions are based on deferrals made each payroll period.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Internal Revenue Code (the Code).

#### Participant accounts

Each participant's account is credited with participant contributions, Employer safe harbor matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions and Employer safe harbor matching contributions plus actual earnings thereon.

### Notes receivable from participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance during the preceding 12-month period ending on the date of the loan over the current loan balance, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50%, which is based on commercially reasonable interest rates determined by the Plan administrator. Participants may only have one loan outstanding at any given time. Terms range from one to five years. Principal and interest is paid ratably through payroll deductions.

### Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Prior to April 1, 2024, upon termination, automatic distributions were required for balances of less than \$5,000. Effective April 1, 2024, upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by Empower. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

### Forfeitures

Forfeitures may be used to restore participant balances previously forfeited, to pay Plan administrative expenses, or to reduce Employer safe harbor matching contributions. The Plan had \$4 and \$20 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$16 were used to reduce Employer contributions.

### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participates in an agreement with Empower, where excess revenue may be returned and deposited into an unallocated suspense account. The amounts in the unallocated suspense account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. There were no unallocated funds in the suspense account as of December 31, 2024 and 2023. For the year ended December 31, 2024, no unallocated funds were used from the suspense account.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the valuation policies utilizing information provided by Empower. See Note 4 for discussion of fair value measurements and Note 5 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. An allowance for delinquent notes receivable from participants in the amount of \$45,393 and \$64,545 has been recorded as of December 31, 2024 and 2023, respectively. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

### Contributions

Participant contributions, and the related Employer safe harbor matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation.

### Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

### Subsequent events

The Plan administrator has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan entered into a group variable funding agreement issued by Transamerica Life Insurance Company (Transamerica), Transamerica Retirement Solutions, LLC, an affiliate of Transamerica, maintains the records of the participant data, and Transamerica holds the Plan assets.

## **Note 3 – Information Certified by EAIC**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, EAIC, under power of attorney granted to EAIC to certify on MassMutual's behalf, has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

#### Note 4 – Fair Value Measurements

Following is a description of the valuation methodology used for investments measured at fair value on a recurring basis:

*Variable annuity in pooled separate accounts* – Stated at fair value as determined by the issuer of the pooled separate accounts based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of units of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There has been no change in the methodology used as of December 31, 2024 and 2023. The following table summarizes investments for which fair value is measured using the NAV per share as a practical expedient as of December 31, 2024 and 2023:

#### Note 5 – Fully Benefit Responsive Investment Contract

The Plan holds a traditional guaranteed investment contract issued by MassMutual. This contract meets the fully benefit responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

MassMutual is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by MassMutual but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract is dependent on MassMutual's ability to meet its financial obligations. MassMutual's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with MassMutual. Examples of such events include, but are not limited to, the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Removal from the Plan of one or more groups or classifications of participants
- Partial or complete Plan termination
- Changes to the Plan's prohibition on competing investment options

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with MassMutual and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow MassMutual to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include:

- The investor provides effective communication to MassMutual that the agreement will be fully or partially terminated as of a date selected by the investor, which will be no earlier than 30 days after the investor provides effective communication to MassMutual
- The investor breaches a provision of the agreement
- The Internal Revenue Service determines that the Plan no longer meets the requirement of Code section 401(a), 403(a), 414(d), 414(e) or any other applicable Code provision
- There is a termination or partial termination of the Plan
- MassMutual provides effective communication to the investor that the agreement will be terminated as of a date at least 90 days after MassMutual provides effective communication to the investor

#### **Note 6 – Related Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers and employees of the Hospital. No officer or employee receives compensation from the Plan for these services. Certain administrative expenses, totaling approximately \$20,300, were paid by the Hospital on behalf of the Plan for the year ended December 31, 2024. The Hospital does not expect reimbursement from the Plan for these expenses.

The Plan's investments are issued by MassMutual and managed by Empower. Business written by MassMutual, including the fully benefit responsive investment contract, is administered by EAIC. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8 – Tax Status**

The Hospital adopted a preapproved defined contribution plan (the Preapproved Plan) sponsored by Employee Benefits Group LLC. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
