Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of the Big Four Companies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). (1) Description of the Plan

The following brief description of the Big Four Companies, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan covering all eligible employees of Big Four Companies, Inc. (“Plan Sponsor”), which wholly owns Windows USA, LLC. Employees hired prior to January 1, 2024 who have one year (1,000 hours) of service and have attained age 18 are eligible to participate in the Plan. Effective January 1, 2024, employees are eligible to participate after 60 days of service and reaching age 18 (“participants”). The Plan, which was originally adopted by action of the Plan Sponsor’s Board of Directors on July 1, 1996, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective December 29, 2020, the majority ownership of Windows USA, LLC was acquired by H.I.G. Capital and accordingly H.I.G. Windows USA, L.P. was formed. The Plan was not affected by the acquisition.

(b) Contributions

Each year, participants may defer a percentage of their pretax annual compensation as defined in the plan agreement, not to exceed the maximum annual amount as determined by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”) and make after-tax Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. In 2024 and 2023, the Plan Sponsor made a discretionary matching contribution equal to 50% of each participant’s salary deferral up to 6% of the participant’s eligible compensation. The Plan Sponsor may also make discretionary profit sharing contributions. No discretionary profit sharing contributions were made in 2024 or 2023.

(c) Participant accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor’s contributions, as well as allocations of plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

(d) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor contribution portion of their account plus actual earnings (losses) thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and vesting increases 20% each year until the participant is 100% vested after six years of credited service.

(1) Description of the Plan, continued

(e) Participants notes receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 7.25% to 12.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Generally, the term of the loan may not exceed 5 years, unless the loan is for the purchase of a primary residence, which allows for longer repayment terms. Principal and interest are collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, disability, retirement, or termination of service, a participant will receive a lump-sum distribution equal to the value of the participant's vested account. Any participant with a vested account balance less than \$1,000 will automatically receive an involuntary cash-out distribution in the form of a lump-sum payment.

(g) Forfeitures

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,003 and \$2,164, respectively. Forfeitures amounting to \$7,863 and \$6,347 were used to reduce Plan Sponsor contributions to the Plan in 2024 and 2023, respectively.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½, unless certain exceptions apply.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles ("GAAP") requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of significant accounting policies, continued

(c) Investment valuation and income recognition

The Plan's investments are stated at fair value as reported by the custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Contributions

Contributions from plan participants and any respective matching contributions from the Plan Sponsor, if applicable, are recorded in the year in which the employee contributions are withheld from compensation.

(e) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan agreement.

(f) Payment of benefits

Benefits are recorded when paid.

(g) Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. The Plan holds assets in an expense balance account ("EBA") which receives deposits as a result of a revenue sharing agreement with Empower. During 2024, deposits were netted with administrative expenses and used to pay qualified plan expenses. See Note 5 for further disclosure.

(h) Events occurring after the reporting date

The Plan has performed an analysis of the activities and transactions subsequent to December 31, 2024, to determine the need for any adjustments or disclosures for the year then ended. The Plan has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued.

(3) Summary of information certified by the custodian

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable as of the date of the financial statements under audit and covered by the certification, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (“Empower”), the custodian.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;**
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;**
- (c) Inputs other than quoted prices that are observable for the asset or liability; and**
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds* are valued at the daily closing price as reported by the fund and are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.**

***The guaranteed interest account* is valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note 7). Fair value approximates contract value. In determining the reasonableness of the methodology, the Plan Sponsor evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings.**

(4) Fair value measurements, continued

Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Related-party and party-in-interest transactions

Certain plan investments are managed by Empower. Empower is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Empower provides certain administrative services to the Plan pursuant to an agreement between the Plan Sponsor and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, Empower remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay the Plan's administrative expenses or allocated to the accounts of the participants. During the plan year, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing. Certain administrative functions are performed by officers or employees of the Plan Sponsor and no such officer or employee receives compensation from the Plan.

(5) Related-party and party-in-interest transactions, continued

Administrative expenses paid to the custodian and other parties-in-interest amounted to \$51,968 and \$47,740 for 2024 and 2023, respectively. The Plan Sponsor also pays for certain plan expenses for which it is not reimbursed by the Plan.

(6) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) Investment contract with insurance company

The Plan has entered into an investment contract with Empower Annuity Insurance Company of America, who maintains the Plan's contributions in a guaranteed interest account, which has been determined to be *non* fully benefit-responsive. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. In 2024, interest was \$1,136, net transfers amounted to \$15,481 out of the Plan, contributions and loan repayments made were \$22,957 and disbursements were \$39,097. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the guaranteed interest account was \$67,343 and \$97,828 as of December 31, 2024 and 2023, respectively. The average yield and crediting interest rate was 1.41% and 1.23% for 2024 and 2023, respectively. Such interest rates are reviewed on at least an annual basis for resetting.

(8) Risks and uncertainties

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

(9) Income tax status

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
