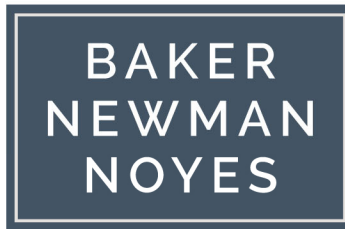

## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Adrenaline Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. Plan Description

The following description of the Adrenaline Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was established October 17, 2018. The plan is a defined contribution plan covering substantially all employees of Adrenaline, LLC (the Company) who are age 21 and over, except for union employees, nonresidential aliens, and part-time or leased employees. Fidelity Trust Management Company serves as the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

#### Eligibility

Employees become eligible to make pre-tax and/or after-tax (Roth) contributions, and to receive Company matching contributions, when they have reached the age of 21.

The SECURE Act 2.0 expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed between 500 and 999 hours of service in the three most recent consecutive years (2021-2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023-2024).

#### Contributions

Participants may contribute, on a pre-tax basis, up to the maximum percentage of compensation and dollar amount permissible under Section 402(g) of the Internal Revenue Code (the Code) not to exceed the limits of the Code Sections 401(k), 404, and 415. Participants are also allowed to make Roth contributions on an after tax basis. Participants may direct their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The initial automatic deferral amount will increase by 1% of the compensation up to the maximum of 10% of compensation per year on January 1 of each year, unless another deferral rate is affirmatively elected by the participant.

The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the Participant's elective deferrals. In 2024 and 2023, the Company's discretionary matching contribution to the Plan was equal to 50% of deferrals up to 6% of eligible compensation as contributed by the participant.

Participants may change their salary reduction contribution and investment options at any time during the Plan year.

### 1. Plan Description (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after five years of credited service, based on a graded vesting schedule.

#### Forfeitures

Forfeited balances of terminated participants' nonvested accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan. There were \$18,655 and \$25,824 worth of forfeitures used to offset employer contributions during the years ending December 31, 2024 and 2023, respectively. The balance of unallocated forfeitures as of December 31, 2024 and 2023 was \$50,155 and \$7,639, respectively.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balances in the participant's account and bear interest at 1% greater than the prime interest rate at the time the loan is originated. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 with various maturities through August 2029.

#### Payment of Benefits

Participants are eligible to receive their vested account balance upon termination of employment, age 59 ½, retirement, disability or death. Participants may receive their distributions in a lump-sum. The Plan also allows participants to make hardship withdrawals from participant balances attributable to employee elective deferrals and rollover contributions.

#### Administrative Expenses

Any administrative expenses of the Plan that are not paid by the Plan or offset by forfeitures are paid by the Company.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A discussion of fair value measurements is included in Note 4.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, if material.

#### Payment of Benefits

Benefits are recorded when paid.

#### Contributions

Participant contributions are recorded in the period in which payroll deductions are made; employer matching contributions are recorded in the same period as corresponding participant contributions.

#### Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

### 3. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company (Fidelity), the trustee, except for comparing such information with the related information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the trustee as of and for the years ended December 31, 2024 and 2023, stating that the information provided to the Plan Administrator by the trustee is complete and accurate. Such information includes investments, investment income, including interest and dividends and net appreciation in fair value of investments, investment transactions, notes receivable from participants, interest income on notes receivable from participants and related transactions.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques use need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. The Plan periodically reviews and updates the fair value hierarchy classifications. Changes related to the observability of inputs in fair value measurements may result in a reclassification between the fair value hierarchy levels.

*Mutual funds:* Valued at fair value based upon quoted active market prices which represent the net asset value of shares.

*Collective trusts:* The units of collective trusts are valued at fair value using the net asset value (NAV) practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund. Certain collective trusts have readily determinable fair values because the trusts' fair value are based on the end of day net asset value per unit which is published publicly daily on a national exchange and are therefore reflected within Level 2 in the fair value hierarchy tables below. There are no unfunded commitments and participant-directed withdrawals may be made at any time. If the Plan initiates a full-redemption of the GG Metlife Stable Value collective trust, the issuer requires 24 months' notice.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions or terminate the Plan at any time subject to the provisions of ERISA. In the event of any total or partial termination or discontinuance, all affected participants shall be fully vested in their accounts, and the assets shall be distributed to the participants in accordance with the terms set forth in the Plan.

### 6. Tax Status

The Plan Administrator received a favorable tax determination letter for a non-standard pre-approved profit sharing plan from the Internal Revenue Service dated June 30, 2020. The Plan has been amended subsequent to the receipt of the tax determination letter. In the opinion of the Administrator, the Plan has been operated within the applicable sections of the Code upon which the favorable determination was based and remains qualified under the Code and applicable regulations.

U.S. GAAP requires Plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Related Party Transactions

The Plan is responsible for administrative fees to the extent they are not paid by the Plan sponsor. Administrative fees consist of amounts paid to the third party administrator and Fidelity Trust Management Company for various administrative and investment services. These transactions qualify as party-in-interest transactions; however, it is exempt from the prohibited transactions rules under ERISA. In addition, notes receivable from participants qualify as party-in-interest transactions.
