### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Empire Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Empire Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established on January 1, 1985 and has been amended from time to time since that date. The Plan was last amended and restated effective August 1, 2023. The Plan was created for the exclusive benefit of employees of Empire Southwest, LLC (the Company, the Plan Sponsor, or the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee has oversight of the Plan.

**Eligibility**

To be eligible for voluntary salary deferral contributions and employer discretionary matching contributions, employees must (a) be at least age 18, (b) be employed at least one month, and (c) be a Plan-eligible employee. An employee can participate in the voluntary salary deferral contributions in the first pay period in which the eligibility period commences.

To be eligible for a portion of any employer discretionary profit sharing contribution, employees must (a) be at least age 18, (b) complete at least one year of service, (c) work at least 1,000 hours during an applicable Plan year, (d) be employed by the Company on the last day of the applicable Plan year and (e) be a Plan-eligible employee.

Effective August 1, 2023, the age requirement was removed from the Plan for the voluntary salary deferral contributions, employer discretionary matching contributions, and the employer discretionary profit sharing contributions.

**Contributions**

The Plan provides for four types of contributions:

- Participant pretax and Roth voluntary salary deferrals ranging from 1% to 100% of eligible compensation, as defined in the Plan document. The Plan has an automatic deferral feature of 5%, increasing each year by 1% up to a maximum of 10%, unless the participant opts out. Effective August 1, 2023, the maximum percentage contribution for participant pretax and Roth voluntary salary deferrals was changed from 100% to 75%.
- Employer discretionary matching contributions, to be determined, if any, either as a uniform percentage of deferrals or as a flat dollar amount for each participant.
- Employer discretionary profit sharing contributions, as determined by the Company's Board of Directors, are allocated to participants based on gross annual compensation. There were no profit sharing contributions made for the year ended December 31, 2024.
- Rollovers into the Plan from another qualified plan.

**Contributions (Continued)**

All contributions are subject to certain Internal Revenue Code (IRC) limitations.

The employer discretionary match was 50% of the first 6% of employee deferrals for the year ended December 31, 2024.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, allocations of Company discretionary profit sharing contributions, and Plan earnings; and charged with withdrawals and an allocation of Plan losses and Plan expenses. Allocations are based on participant earnings or account balances, or participant transactions as defined. The benefit to which a participant is entitled is the total benefit that can be provided from the combined vested amount of these participant accounts.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective funds as investment options for participants.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 35% of their vested account balance. Effective August 1, 2023, the maximum loan percentage was changed from 35% to 50%. The notes are secured by the balance in the participant's account and bear interest at Wall Street Journal's prime rate at the time the note is made, plus two percentage points. A participant may not have more than one note outstanding from the Plan at any time. Principal and interest is paid ratably through payroll deductions.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts is based on continuous years of service. Participants become 20% vested in their employer discretionary profit sharing contribution accounts and employer discretionary matching contribution accounts after two years of service. Vesting increases 20% each year for years three through six. A year of service is earned for any Plan year during which a participant works at least 1,000 hours. All accounts become 100% vested for a participant whose employment with the Company is ended due to death or total disability, or if a participant's employment is ended as part of a Plan termination.

Effective August 1, 2023, the vesting schedule was updated to 25% vesting in employer discretionary profit sharing and employer discretionary matching contributions after one year of service, with vesting increasing 25% each year thereafter and full vesting after four years of service.

**Forfeitures**

Forfeitures are the nonvested portion of accounts of participants who have separated from employment with the Company. At December 31, 2024, accumulated discretionary profit sharing contribution account forfeitures were \$-0- and matching contribution account forfeitures were \$496,908. At December 31, 2023, accumulated discretionary profit sharing contribution account forfeitures were \$-0- and matching contribution account forfeitures were \$264,645. The Employer, in its sole discretion, may elect to apply forfeitures arising during a Plan Year either to reduce Employer Contributions and/or Matching Contributions for the immediately succeeding Plan Year, or as an additional allocation to Participants' accounts prior to the application of such forfeitures toward the payment of Plan administrative expenses. During the year ended December 31, 2024, the value of nonvested accounts used to reduce employer contributions was \$435,127.

**Payment of Benefits**

Generally, participants become eligible for distribution of their accounts upon separation from employment with the Company. If a participant's vested account balance is greater than \$5,000 upon separation, then the account balance will remain in the Plan until the participant directs otherwise. If a participant's vested account balance under the Plan is between \$1,000 and \$5,000 at separation and they do not consent to a distribution of their vested account balance, the vested benefit automatically will be rolled over to an Individual Retirement Account selected by the Plan administrator. Effective April 5, 2024, the \$5,000 threshold was increased to \$7,000. If a participant's total vested benefit is \$1,000 or less upon separation, the entire vested benefit will be distributed to the participant in a lump sum, even if they do not consent to a distribution. Payment of benefits from the Plan will occur as soon as is administratively feasible following separation from employment.

**Plan Administration**

The Company administers the Plan through a Retirement Plan Committee composed of seven Company employees appointed by the Company's Board of Directors. Matrix Trust Company acts as the trustee and asset custodian. OneAmerica Retirement Services, LLC acts as the recordkeeper. WealthPlan Advisors acted as an investment advisor to the Plan until November 10, 2023, when they switched to Merrill Lynch Fiduciary Advisory Services.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Administrative Expenses**

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. In addition, OneAmerica Retirement Services provides the Plan certain accounting and administrative services for which fees are paid directly from the Plan. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Management fees and operating expenses charged to the Plan, for investments in the mutual funds, are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make a number of estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Matrix Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the net asset value (NAV) of shares based on the New York Stock Exchange at the close of each day.

*Collective Fund* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Matrix Trust Company is the trustee as defined by the Plan. Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participant's employer profit sharing contributions and matching contributions shall become 100% vested and nonforfeitable and participants and each beneficiary shall be entitled to receive any amounts then credited to his/her account, in the manner described in Note 1.

**NOTE 9 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
