### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Bellwether Community Credit Union 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from the qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

#### 1. Description of Plan

The following description of Bellwether Community Credit Union 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of Bellwether Community Credit Union (the Credit Union) who have one year of service and are age 18 or older. Under the provisions of the Plan, investment activity is directed by individual participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 1, 2023, the Plan was amended and restated to change from CMFG Life Insurance Company (CMFG) and Matrix Trust Company as trustee and custodian, respectively, to Principal Trust Company as trustee. All funds with CMFG and Matrix Trust Company were liquidated on March 3, 2023, with the proceeds invested in Principal Trust Company sponsored funds.

##### Contributions

Participants may contribute up to the maximum percentage allowable not to exceed the limits of the Internal Revenue Code (IRC) Sections 401(k), 404 and 415. The Credit Union matches 50% of participants' deferrals on a maximum of 10% of eligible compensation. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Credit Union may elect to make a discretionary contribution in any plan year. The Credit Union made a discretionary contribution of \$217,985 to the Plan in 2024 for eligible participants as of December 31, 2023. The Credit Union made a discretionary contribution of 5% of eligible compensation for eligible participants as of December 31, 2024, which is included in contributions receivable and will be funded to the Plan in 2025. Participants must complete one year of service to be eligible for the discretionary contribution.

Vesting of employer contributions is earned gradually based on a six-year schedule. Contributions are subject to certain limitations.

Plan forfeitures of \$17,749 were used to reduce employer contributions to the Plan in 2024.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and the Credit Union's matching and discretionary contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Withdrawals**

The Plan provides for participants to withdraw their funds at any time upon attainment of the normal retirement age (65 years old) as stated in the Plan document. Such withdrawals are based on the amount in the participant's accounts as of the valuation date coinciding with or immediately after the participant's retirement date. The Plan also provides for withdrawals in the event of death, disability, hardship, termination or early retirement. The Plan allows for withdrawals upon early retirement at age 55 and completion of ten years of service, and for in-service withdrawals once a participant reaches age 59<sup>1/2</sup>. The Plan provides for automatic distribution to terminated participants of their entire vested balance which does not exceed \$5,000.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

**Investments**

Investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan unless paid by the Credit Union.

#### **3. Group Annuity Contract**

The Plan has a benefit-responsive group annuity contract with Principal Life Insurance Company (Principal Life) through Principal Trust Company (Principal). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to 12 months. Such events include but may not be limited to the following: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; (4) removal from the Plan of one or more groups of classifications of participants; (5) partial or complete Plan termination; or (6) Plan disqualification.

#### **4. Fair Value Measurement**

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Pooled separate accounts:* Valued at NAV of the underlying asset in each separate account. The NAV is multiplied by the number of mutual fund shares owned. The number of shares owned in the underlying mutual funds reflects all contributions and disbursements traded through the end of the prior day to reach the value of the shares held by the separate account. The NAV is not a publicly quoted price in an active market, but it is available to current investors through Principal; therefore, pooled separate accounts are considered to have a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related-Party and Party-in-Interest Transactions**

The group annuity contract is also managed by Principal; therefore, these transactions qualify as party-in-interest transactions. The Plan had a revenue sharing account in 2024, whereby the Plan received \$277 from investment fund providers to offset fees for services provided to the Plan. The amounts received were recorded as a reduction to administrative expenses. Administrative expenses of \$44,969 were paid to service providers in 2024. These transactions also qualify as party-in-interest transactions.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**7. Tax Status**

The Plan is a pre-approved profit sharing plan sponsored by the recordkeeper. The pre-approved plan received a favorable opinion letter dated June 30, 2020. The Plan has been amended since the opinion letter was issued. The Plan administrator believes the Plan is currently being operated in compliance with the terms of the Plan and the Code and remains unqualified under the Code and applicable regulations and, as such, is exempt from taxes as of the financial statement date.

8. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
