INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of the plan

The following description of the Inverness Technologies, Inc. 401 (k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan qualified under sections 401 (a) and 401 (k) of the Internal Revenue Code (the Code), covering all employees of Inverness Technologies, Inc. (the Company). All employees are eligible to participate in the Plan on the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Trustee, Custodian and Administration of the Plan

The trustee and custodian of the Plan is John Hancock Life Insurance Company. The Company entered into a managed services agreement with Coastal Pension Services who provides record keeping and various administrative services.

Eligibility

The Plan is a defined contribution plan generally covering all employees of the Company.

Participant contributions

Participants may elect to contribute, on a tax-deferred basis, up to 100% of their annual compensation as defined by the Plan. Participant contributions may not exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code. Participants are permitted to make rollover contributions to the Plan.

Participant rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Additional amounts may be contributed as a profit sharing contribution at the discretion of the Company's Board of Directors. No discretionary profit sharing contributions were made by the Company for 2024. The Company's matching contributions totaled \$9,237 for the year ended December 31, 2024.

Participant accounts

Each participant's account is participant-directed and credited with participant and Company contributions, withdrawals and an allocation of Plan earnings and administrative expenses. Any earnings, losses, and administrative expenses are allocated to participant accounts based upon the balance in each account, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the portion of the participant's account.

Vesting

Participants are immediately 100% vested in their contributions, Company contributions, and earnings and losses thereon.

Forfeitures

There are no forfeitures as participants are immediately 100% vested in their accounts.

Participant loans

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Notes must be at least \$1,000 and a participant can hold no more than one note at any given time. Notes are collateralized by the participant's account balance. Notes bear interest at an interest rate equal to 1% above the prime rate. Interest and principal repayments are made ratably through semi-monthly payroll deductions. Notes become due immediately upon termination of the participant's employment.

Note 1. Description of the plan – continued

Payment of benefits

Upon termination of service, death, disability, retirement, or attainment of age 59 1/2, a participant or their beneficiary, in the event of death, is entitled to distribution of their account balance. Distributions may be made either in a lump sum or, in the case of required minimum distributions, on an investment basis. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distribution prior to age 59 1/2. As of December 31, 2024, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

Administrative expenses

All administrative expenses are paid with the assets of the Plan, unless paid by the Company, at its discretion. Administrative expenses totaling \$44,626 for 2024 were paid directly from the Plan during the year. All other administrative expenses were paid by the Company. Loan and distribution fees are paid by the Plan and its participants.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting. As described in ASC 962, *Plan Accounting – Defined Contribution Pension Plans*, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of the contingent assets and liabilities at the date of the financial statements and the reported amount of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 2. Summary of significant accounting policies – continued

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Note 3. Investments - Certified by the plan custodian

The Plan's investments are held by John Hancock Life Insurance Company, the Plan Custodian. A summary of the fair values of investments at December 31, 2024 and 2023 follow. Investments that represent 5% or more of the total Plan assets are separately identified. Fair value has been determined by quoted market prices, all investments are mutual funds.

Note 4. Fair value measurements

ASC 820, Fair Value Measurements and Disclosures (ASC 820), defines fair value and establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Investments in pooled separate accounts are valued at fair value based on the unit value of the fund. Unit values are determined by the institutions sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used during December 31, 2024 and 2023.

Note 5. Fully benefit – responsive investment contract

The Plan entered into a fully benefit-responsive investment contract with John Hancock Life Insurance Company (John Hancock). The contract invested in the John Hancock Stable Value Fund. John Hancock maintains the contribution in the general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6. Party-in-interest transactions

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan invests in certain investments managed by John Hancock Life Insurance Company, the Custodian of the Plan. The Plan allows participants to take out loans against their account balances. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Note 7. Plan termination

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions and to terminate the Plan at any time subject to the provision of ERISA. Upon termination of the Plan, the net assets of the Plan would be distributed to participants based upon individual interests in the Plan.

Note 8. Income tax status

The prototype plan, under which the Plan has adopted, has received a favorable opinion letter from the Internal Revenue Service dated November 30, 2020 stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, Income Taxes, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress. The Plan administrator believes it is no longer subject to examinations for Plan years prior to 2022.
