### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Sunshine Retirement Living LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in the "Information Certified by the Custodian" note to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## **DESCRIPTION OF THE PLAN**

The following description of the Sunshine Retirement Living, LLC's 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan which is qualified as a cash or deferred arrangement and profit-sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

### Eligibility

The Plan covers all employees of the group of employers, collectively Sunshine Retirement Living LLC (the "Company" or "Sponsor"), who have completed thirty days of employment and are age twenty-one or older. Employees may enter the Plan on the first day of the payroll period that follows the date on which they satisfy the eligibility requirements.

### Contributions

Plan participants are permitted to make elective deferrals of their total compensation up to the maximum amount which will not cause the Plan to violate the provisions of the Plan or cause the Plan to exceed the maximum amount allowable as a deduction to the employer under IRC Section 404. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover).

Company contributions are made solely at the discretion of the Board of Directors.

The Company may make a matching contribution equal to the lesser of 50% of the first 7% of a participant's pretax annual compensation or 50% of the contributions that a participant elects to contribute. An employee must have completed one year of service in order to be eligible to receive an employer matching contribution.

It is the policy of the Company to fund contributions to the Plan on a regular basis.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and their allocable share of Company matching contributions into a variety of investment choices as more fully described in the Plan's literature.

Participants may change their allocation daily. All investments of the Plan are participant directed.

### **DESCRIPTION OF THE PLAN (Continued)**

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years-of-service, at a rate of 20% each year after the first year, becoming 100% vested after six years of credited service. Additionally, a participant will be fully vested upon reaching age 65 prior to termination of employment, or upon death or disability prior to that date.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest is paid in level payments over a period not to exceed five years. Interest paid by participants on their loan balances is credited to their individual accounts. Each time a loan is taken, the related fee is charged to that participant's account.

#### Payment of Benefits

Upon termination of service or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or paid out in installments.

The Plan also provides a participant who demonstrates "financial need" with the option of withdrawing an amount against the participant's vested account balance.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$49,518 and \$24,222 respectively. These accounts will be used to reduce future plan expenses or company contributions. For the years ended December 31, 2024 and 2023, forfeitures were used to pay plan expenses totaling \$21,490 and \$30,486, respectively, and used to fund contributions totaling \$15,072 and \$51,259, respectively.

### **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See additional information in the "Fair Value Measurements" note to the financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, record keeping, short-term trading, and other costs are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.

## FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed Annuity:* Values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

### GROUP ANNUITY CONTRACT

The Plan has a group annuity contract with Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

### **GROUP ANNUITY CONTRACT (Continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or
- (d) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

Empower Trust Company, LLC, the custodian, holds all investments and executes all investment transactions on behalf of the Plan. Information regarding the value of all investments, investment interest and dividend income, and net appreciation/depreciation in the fair value of investments has been certified by the custodian as complete and accurate in accordance with 29 CFR Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Information regarding participant loan balances has not been certified.

### **RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in the summary of significant accounting policies note, the Plan made direct payments of \$47,819 for recordkeeping services, \$7,000 for audit services, \$24,682 for investment advisory services, and \$10,000 for contract administration. The Plan Sponsor pays directly any other fees related to Plan operations. Other parties-in-interest include the Plan's board of trustees, participants, and anyone performing services for the Plan.

### **TRUSTEES OF THE PLAN**

The Plan provides for Trustees to be appointed by the Board of Directors. These individuals are officers or employees of the Company.

## **PLAN TERMINATION**

Although it has not expressed any intent to do so, Sunshine Retirement Living LLC, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

## **TAX STATUS**

The company has adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service (IRC) dated June 30, 2020. The letter states that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **ERISA FIDELITY BOND NONCOMPLIANCE**

For the year ended December 31, 2024, the Plan was not in compliance with bonding requirements set forth in the Employee Retirement Income Security Act of 1974 (ERISA). The Company obtained an insurance policy through an insurance company that was not an approved surety which listed the Company as the insured party. ERISA mandates that each plan fiduciary be bonded through an approved surety with the Plan listed as the insured party to protect the Plan against losses due to fraud or dishonesty.

Upon discovery, the Plan immediately took corrective action and obtained an ERISA fidelity bond effective January 28, 2025, which satisfies the requirements set forth by ERISA for plan years after 2025.
