We have performed audits of the financial statements of Zober Industries Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. DESCRIPTION OF PLAN**

The following brief description of the Zober Industries, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Plan participants should refer to the Plan agreement for more complete information.

**Organization and Participation**

The Plan is a defined contribution profit sharing plan established for the purpose of providing employees of Zober Industries, Inc. (the Company) with certain retirement benefits. In May 1998, the Company amended the Plan for the implementation of a 401(k) provision and provided for all investments to be participant-directed.

Employees of the Company are eligible to become participants upon reaching age 18 and after completing a year of service. The Plan is structured under the provisions of Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may annually contribute up to 75% of pre-tax annual compensation, as defined in the Plan. Participants' contributions and Plan earnings thereon are fully vested at all times and may be withdrawn subject to the provisions of the Plan. Each year the Company can contribute a discretionary employer match. For the years ended December 31, 2024 and 2023, the Company matched 50% of the participants' contributions up to 4% of compensation. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants become fully vested in Company contribution amounts allocated to them on a graduated schedule. Complete vesting occurs upon completion of seven years of service. For the year ended December 31, 2024, the Company made an employer match contribution of \$80,166 and a \$75,000 discretionary profit sharing contribution.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's contribution and allocations of earnings for the participant's underlying selected investments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

On any termination of service where a participant's vested benefit in the Plan exceeds \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly, semi-annual, or annual installments over a period of not more than the participant's assumed life expectancy. For termination of service where a participant's vested benefit in the Plan does not exceed \$5,000, a participant must receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,612 and \$39,251, respectively. These accounts can be used to reduce plan expenses or future employer matching contributions. In 2024, plan expenses were reduced by \$21,716 and contributions reduced by \$565 from forfeited non-vested accounts.

**1. DESCRIPTION OF PLAN (continued)**

**Plan Amendment and Termination**

The Plan may be amended or terminated in whole or in part by the Company subject to the provisions of ERISA. In the event of termination of the Plan, the accounts of all participants shall become fully vested, and the Plan assets shall be distributed in accordance with the terms of the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments in all funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. The stable value fund is held in a common collective trust and the net asset values (NAV's) reported are generally obtained directly from the fund house or other investment provider.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain dividends are reported as dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Costs incident to the purchase and sale of securities, such as brokerage commissions and stock transfer taxes, are paid by the respective funds. All other administrative expenses incurred in the administration of the Plan are charged against the respective funds, unless the employer elects to pay such amounts. The Plan also allows the use of forfeitures to reduce plan administrative expenses.

**3. FAIR VALUE MEASUREMENTS**

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund:* The stable value fund is held in a common collective trust and is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INVESTMENT CONTRACTS**

During the 2024 and 2023 plan years, the Plan invested in a common/collective fixed income investment fund, the KeyBank EB Managed Guaranteed Investment Contract Fund (the "Fund"), which holds fully benefit-responsive investment contracts. The Fund maintains the contributions in a general account, which is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The contract is considered an indirect investment in a fully responsive benefit investment contract since it is held through a common collective trust. This investment is reported at fair value.

**5. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan's federal Form 5500, Annual Return/Report of Employee Benefit Plan, for the previous three years remains subject to examination by the Internal Revenue Service.

**6. CERTIFICATION BY PLAN TRUSTEE (unaudited)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Capital Bank and Trust Company, the custodian of the Plan and also a trustee of the Plan, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
