INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of
Boston Dynamics AI Institute 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Boston Dynamics AI Institute 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Boston Dynamics AI Institute 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan, which was established and effective January 1, 2023, is a profit-sharing plan covering all employees of Boston Dynamics AI Institute (the “Company” and the “Plan Sponsor”), as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility – Employees must be at least 21 years of age to participate in the Plan. Employees may enter the Plan immediately after fulfilling the eligibility requirement.

Contributions – Each year, participants may contribute the maximum pre-tax or Roth annual compensation allowed by the Internal Revenue Code (IRC), up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after thirty days unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at four percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Plan does not have an annual escalation for automatically enrolled participants.

Safe harbor matching contributions are made to satisfy IRS nondiscrimination requirements related to elective deferrals. The Company matches 100% of each participant’s elective deferrals up to 4% of eligible compensation on a per-pay-period basis. Safe harbor matching contributions totaled \$1,672,355 and \$676,405 for the years ended December 31, 2024 and 2023, respectively.

Discretionary matching contributions, if made, are determined annually at the Company’s discretion based on a percentage of participants’ pre-tax and Roth elective deferrals, including catch-up contributions. No discretionary matching contributions were made during the years ended December 31, 2024 and 2023.

The plan also permits the Company to make discretionary ACP safe harbor matching contributions to satisfy nondiscrimination testing on matching contributions (ACP test). These contributions, if made, are fully vested. No ACP safe harbor matching contributions were made during 2024 or 2023.

Discretionary profit sharing contributions may be made to eligible participants and are allocated pro rata based on each participant’s compensation as a percentage of total compensation for all eligible participants. These contributions are subject to a graded vesting schedule. No profit sharing contributions were made during 2024 or 2023.

Qualified matching contributions (QMACs) may be made on behalf of non-highly compensated employees to correct failed nondiscrimination testing. These contributions, if made, are fully vested. No QMACs were made during 2024 or 2023.

1. DESCRIPTION OF PLAN (CONTINUED)

Qualified nonelective contributions (QNECs), if made, are discretionary contributions allocated to non-highly compensated employees to support nondiscrimination testing compliance. Such contributions are fully vested. No QNECs were made during 2024 or 2023.

Participant accounts – Each participant’s account is credited with the participant’s contributions, the Company’s contribution, and allocations of Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Alternatively, the Plan Sponsor, in its discretion, may pay any or all such administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions, safe-harbor match and actual earnings thereon. Vesting in the Company’s discretionary matching contributions, profit-sharing contributions and ACP test safe-harbor matching contributions is based on years of service. A participant is 100 percent vested after three years of credited service. See vesting schedule below:

Forfeitures – A participant who leaves the Company forfeits any non-vested balance after the date the participant incurs five consecutive one-year breaks in service or it may be placed in a suspense account. If a terminated employee is rehired, forfeitures may be restored under certain circumstances. The Plan uses such forfeitures to reduce administrative expenses under the Plan. Any remaining amounts will be used to reduce future employer contributions. The forfeited non-vested account was \$0 at December 31, 2024 and 2023 .

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50 percent of their vested account balance for any purpose. Loans are secured by the balance in the participant’s account and bear interest at one percent over the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of benefits – Upon a participant’s retirement, termination of employment, death, or permanent or total disability, a participant may elect to receive a lump-sum amount equal to all or part of the value of the participant’s vested interest in his or her account. Hardship withdrawals are permitted from a participant’s total vested account without respect to earnings thereon. In addition, in-service withdrawals from the participant’s total vested account balance are permitted upon reaching age 59 ½. Upon termination, if a participant’s vested account is less than \$5,000, the Plan Administrator, after notification, will distribute the benefit to the participant in whatever manner the Plan Administrator deems best.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, and trustees. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefits are recorded when paid.

Subsequent Events – The Company has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

4. INVESTMENT INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and 2023, and net appreciation in fair value of investments and dividend income for the years ended December 31, 2024, and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an authorized representative of Ascensus Trust Company.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are maintained and administered by Ascensus, LLC, a related party to Ascensus Trust Company and the custodian and trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions, however, are exempt from prohibited transactions under ERISA. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

6. TAX STATUS

The IRS has determined and informed Ascensus LLC by a letter dated June 30, 2020 that the non-standardized pre-approved profit sharing plan adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax-exempt.

6. TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be not sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts – Assets held in self-directed brokerage accounts include cash equivalents, common stock, and exchange-traded funds. These assets are stated at fair value based on quoted market prices of the assets held in the accounts.
