Opinion

1. Plan Description

The following brief description of the Olsson, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2001 to enable eligible employees to benefit from common stock ownership interests in OEI, Inc. and its participating subsidiaries, Olsson, Inc. and OA Air, Inc. (the Company/Plan Sponsor). The Plan is intended to be an employee stock ownership plan (ESOP) within the meaning of Section 4975(e)(7) of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). The Plan was established to provide retirement benefits for the employees of the Company. See Note 3 for administration of the Plan.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such Plan year and have attained the age of 21. Participants who do not have at least 1,000 hours of service during such Plan year, are not employed on the last working day of the Plan year or have not attained the age of 21, are generally not eligible for an allocation of Company contributions for such year.

Employer Contributions

Company contributions are discretionary and determined annually by the Plan Sponsor.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with a) an allocation of shares of the Company's common stock, b) an allocation of forfeitures of terminated participants' non-vested accounts and c) Plan earnings or losses. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Employer contributions are allocated to each participant's account based upon the relation of the participants' eligible compensation to total eligible compensation for the Plan year. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year balance to all participants' beginning of year account balances. Effective January 1, 2024, accounts are maintained in individual member accounts managed by Blue Ridge ESOP Associates, Inc. (Blue Ridge). Prior to January 1, 2024, accounts were maintained in individual member accounts managed by Menke & Associates, Inc. (Menke).

On November 13, 2023, the Company executed a six-for-one common stock split. The financial statements and the related notes to the financial statements have been adjusted retroactively for the stock split.

Vesting

A participant's interest in allocated Company common stock is vested based on years of completed service. A participant is 20% vested after two years of completed service and vesting increases 20% per year until a participant is 100% vested after 6 years of completed service. Participants terminating due to normal retirement, death, or disability will be 100% vested.

Put Option

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase either in a single payment or with interest over a period of up to five years. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash for their Company common stock.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify shall be offered at least three investment options or receive a cash distribution. During 2024, diversifications included rollovers and cash distributions. During 2023, all diversifications were cash distributions.

Payment of Benefits

Distributions from the Plan will be made when a participant retires, dies (in which case, payment shall be made to the participant's beneficiary or, if none, his or her legal representative), or otherwise terminates employment with the Company. Distributions on account balances less than \$250,000 are made as soon as administratively possible. Distributions on account balances of \$250,000 or more will be made in annual installments over a period not to exceed three years, in substantially equal installment amounts of the value of such account balance. The period over which distributions occur is increased by one year, up to five additional years for each \$230,000 (or fraction thereof), as indexed by which the value of such accounts exceeds \$1,165,000. The amount to be distributed is based upon the immediately preceding valuation date from the participant's date of separation from service. Distributions are made in cash or, if the Company elects, in the form of Company common shares plus cash for any fractional share. Benefits are recorded when paid.

At December 31, 2024 and 2023, there are \$1,125,213 and \$1,304,345, respectively, of benefits payable for amounts allocated to accounts of participants who have elected to withdraw from the Plan but have not yet been paid.

Voting Rights

The Trustee receives instructions from the Plan Committee (a body appointed by the Company to manage operations and administration of the Plan), and all Company stock held by the Trust is voted by the Trustee in accordance with instructions from the Plan Committee. Notwithstanding the foregoing, the participant (or their beneficiary) shall be entitled to direct the voting of any voting shares of Company stock allocated to the participant's account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, liquidation, dissolution, or sale of substantially all of the assets relating to the trade or business of the Company. In accordance with instructions from the Plan Committee, the Trustee shall vote any unallocated shares (if any) held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction on behalf of the collective best of Plan participants and beneficiaries.

Forfeitures

Forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants during the years ended December 31, 2024 and 2023 totaled approximately 1,663 and 1,314 shares of common stock, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements. Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis.

Interest Bearing Operating Cash

Effective in 2024, the Plan maintains an interest-bearing cash account for operational purposes. The account generated \$35,868 in interest income during the year ended December 31, 2024. Interest income is recorded on the accrual basis.

Other

Investment management expenses, recordkeeping expenses, audit fees and administrative expenses are paid by the Company and are excluded from the Plan's financial statements.

Risk and Uncertainties

The Plan invests in Company common stock. Company common stock is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the Company's common stock, it is at least reasonably possible that changes in the values of the Company's common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 21, 2025, noting no items requiring disclosure.

3. Administration of Plan Assets

The Trust of the Plan holds the Plan's assets, which consist principally of Company common shares.

Company contributions are held by the Trust and managed by the Trustee, as instructed by the Plan Committee which is appointed by the Company's board of directors. Distributions to participants are made by the Trustee.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Plan are paid by the Company.

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold as well as held during the year) in the Company's common stock appreciated in fair value by \$17,017,230 and \$4,566,424, respectively.

5. Company Advances

During the years ended December 31, 2024 and 2023, the Company advanced \$600,244 and \$1,060,510, respectively, of cash to the Trust to cover the Plan's distribution obligations. This advance was an interest-free loan to the Plan. No collateral has been taken for this loan. The proceeds of the loan were used to fund cash distributions to participants. The advance was converted to a contribution as of the end of the Plan year.

6. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or Liabilities in active markets that the Plan has the ability to access.
- Leve 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

OEI, Inc. Common Stock: Valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income along with estimated fair value of Company assets and liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations prior to 2021.

8. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to the Plan provisions. Upon such termination of the Plan, accounts of all affected participants will become fully vested and the interest of each participant in the trust will be distributed to such participants or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Plan Committee shall direct the trustees to pay all liabilities and expenses of the trust. Should the Plan have debt collateralized by unallocated shares, the Plan Committee shall direct the trustee to sell shares of financed stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan.

9. Related Party Transactions

Certain Plan investments are common stock of the Company held under the Plan trust whereby the Trustee is directed by the Plan Committee (a body appointed by the Company to manage operations and administration of the Plan). These transactions with the Company qualify as related party transactions.
