Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Merchants Bancorp 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of the Plan

The following description of the Merchants Bancorp 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan was established on January 1, 2016 as a defined-contribution plan sponsored by Merchants Bancorp (Company). The Plan includes participation of the following related employers: Merchants Bancorp, Merchants Bank of Indiana, Merchants Capital Corp. ("MCC"), Merchants Capital Servicing, LLC ("MCS") and Merchants Capital Investments ("MCI"). Farmers-Merchants Bank of Illinois was sold in 2023. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company serves as the trustee of the Plan.

Eligibility

Employees of the Company and its affiliates are generally eligible to participate in the Plan after attaining age eighteen (18). Employees become eligible Participants if they have completed one day of service and will typically enter the Plan the first day of the next quarter.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions. Employee rollover and Roth contributions are also permitted by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes a Safe Harbor Company contribution of 3% of eligible compensation calculated annually. An additional discretionary profit-sharing contribution can also be made to the Plan as determined annually by the Company's Board of Directors. There were no profit-sharing contributions remitted to the Plan during 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are allowed as defined by the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 2: Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued using quoted market prices, if available.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a non-standardized profit sharing/401(k) plan adoption agreement sponsored by Principal Life Insurance Co. The prototype document received a favorable opinion letter from the Internal Revenue Service (IRS); therefore, the Plan has not been submitted to the IRS for an individual determination letter. The Plan has been amended since the prototype received the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

Note 3: Certification of Plan Trustee

Accordingly, Principal Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

During 2024 and 2023, the Plan paid \$101,478 and \$76,412, respectively, of fees to the Trustee. Fees incurred by the Plan for investment management services totaled \$70,079 and \$27,650 during 2024 and 2023, respectively, and are included in administrative expenses on the statements of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets of the Plan's sponsor. While the Sponsor remitted all employee contributions to the Plan, contributions of \$1,403 were not remitted within the required time period for the year ended December 31, 2023.

Note 8: Subsequent Events

On January 1, 2025, Plan amendments became effective that added an automatic enrollment feature for eligible employees who do not make an affirmative election to be enrolled with an employee contribution of 3% and also added an auto-escalation process that increases participants deferrals by 1% every January 1st until participant reaches 10%. Participants still have the option not to defer or to change deferrals at any time. This will be in place for all new hires and for any actively employed employee who does not have an enrollment election on file or who is deferring less than 3%.

Subsequent events have been evaluated through July 17, 2025, which is the date the financial statements were available to be issued.
