INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of L. B. J. & C. NOTE 1 - DESCRIPTION OF PLAN

L.B.J. & C. Development Corporation (the “Corporation”) established the L.B.J. & C. Development Corporation Tax Sheltered Annuity Plan (the “Plan”) on June 1, 1968. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan where employees are eligible to participate and make elective deferrals upon hire and are not required to meet any age or service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan and in accordance with applicable sections of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Because this is a 403(b) Defined Contribution Plan, participants are also allowed additional catch-up contributions upon completion of fifteen years of service. Effective February 1, 2018, the Plan was amended to provide an employer matching contribution of 100% of elective deferrals up to 5% of eligible compensation for participating employees with at least six months of service. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a guaranteed investment contract as investment options for participants. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Participant Loans

Loans to participants are not allowed in this Plan.

Rollovers

Rollovers are permitted into the plan as long as they are in accordance with the plan provisions and the Internal Revenue Code.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, severance, attaining the retirement age of 59 1/2 or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant could also take periodic payments over a period not exceeding the life expectancy of the participant or the joint life expectancy of the participant and his or her designated beneficiary. A participant may also receive a distribution for disability, hardship, or attaining the early retirement age of 55 with one year of service. For individual account balances of \$5,000 or less, the terminated employee is required to take a lump-sum distribution. Benefits are recorded when paid.

Forfeited Accounts

Forfeited accounts may be used to pay administrative expenses of the Plan or reallocated to existing participants' accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1 for the Plan, respectively. During the 2024 and 2023 Plan years, \$31 and \$861, respectively, were used to reduce employer matching contributions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to an annuity contract because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value for the annuity account held with Principal Life Insurance Company approximates fair value as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition (Continued)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

All Plan expenses until the date of retirement or withdrawal were paid by the Corporation via quarterly electronic funds transfers to Principal Life Insurance Company. Direct fees relating to the Plan totaling \$1,969 and \$2,477 were charged to participant accounts for the years ended December 31, 2024 and 2023, respectively. Effective March 21, 2025, an annual plan administrative expense of .26% will apply to each participant's account balance. The fee will be applied to the participant accounts in monthly increments of 1/12th.

Subsequent Events

The Corporation evaluated subsequent events through July 22, 2025, the date which the Plan's financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Such funds are normally calculated at the close of each business day as reported by each fund. Portfolio securities for which market quotations are readily available are generally valued at their market value, which typically is the last quoted sales price at the time of valuation. When there are no readily available market quotations for a security, the portfolio security is valued based on its fair value, which typically is the amount which the fund might reasonably expect to receive from the security upon a current sale.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of valuation methods or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Principal Fixed Income Non 401(a) investment option is a fully benefit-responsive single group annuity investment contract with a fixed rate of interest. This investment vehicle is valued equal to the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in, less any withdrawals and transfers out. This valuation methodology is considered to approximate fair value due to the volume of transactions initiated by the fund, the creditworthiness of the issuer, and a history of providing a contract value payout of not less than the participant's accumulation balance. The composite crediting rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate, which was an average of 2.85% and 1.88% in 2024 and 2023, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There is a surrender charge of 5% if the interest in the contract is terminated without 12 months advance notice.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Principal Trust Company, Massachusetts Financial Service Co., and Vaughan Nelson, and a guaranteed investment contract managed by Principal Life Insurance Company. These transactions qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - TAX STATUS

The IRS has determined and informed the Plan by a letter dated March 31, 2017, that the Plan is designed in accordance with Section 403(b) of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - CERTIFYING ENTITY CERTIFICATION

The following is a summary of the unaudited information, included in the Plan's financial statements and supplemental schedule that were prepared or derived from information prepared by Principal Trust Company, the certifying entity of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from Principal Trust Company that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts except for receivables.

Statements of Changes in Net Assets Available for Benefits – all items and amounts except for contributions, benefits paid to participants, and administrative expenses.

Supplemental Schedule – all items and amounts.

NOTE 10 – SETTING EVERY COMMUNITY UP FOR RETIREMENT ACT (SECURE 2.0)

In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective for plan years beginning after December 31, 2024 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
