We have performed an audit of the accompanying financial statements of AVNA INC. Profit Sharing/401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Year Ended December 31, 2024

1. Description of Plan

The following description of AVNA INC. Profit Sharing/401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with a safe harbor 401(k) component covering all eligible employees of AVNA INC. (the Company). Employees are eligible to participate in the Plan on the first of the month following 90 days of service. They are eligible for employer safe harbor non-elective contributions after six months of service and for profit sharing contributions after one year of service, with entry dates on January 1st and July 1st of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan, determining the appropriateness of the investment offerings and monitoring investment performance.

All assets of the Plan are held by the trustee, Empower Retirement. As of and for the years ended December 31, 2024 and 2023, all investments were participant-directed.

During 2024, the Plan adopted certain provisions of SECURE 2.0 Act, including eligibility effective January 1, 2024 for long-term part-time employees. The Plan also increased the balance at which participants receive an automatic distribution upon termination from \$5,000 to \$7,000 and amended to allow in-service withdrawals for individuals over age 65 who are still employed.

Contributions

Each year, participants may make salary deferral contributions to the Plan based on a percentage of their annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company has elected to make employer safe harbor nonelective contributions equal to 3% of each participant's eligible compensation, as defined by the Plan. For the year ended December 31, 2024, the employer safe harbor nonelective contribution totaled \$542,103. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds, collective trust funds, and a fixed annuity as investment options for participant salary deferral contributions and employer contributions.

1. Description of Plan (continued)

Contributions (continued)

The Company may also make a profit-sharing contribution equal to the lesser of 12½% of its operating profits (inclusive of the safe harbor contributions described above) or 12% of all employees' aggregate eligible compensation, as defined by the Plan. In order to receive an allocation of the profit-sharing contribution, participants must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. The Company's profit-sharing contributions are allocated to the same participant-directed investment options as the participant salary deferral contributions and employer safe harbor nonelective contributions. For the year ended December 31, 2024, there were no profit-sharing contributions made. In addition, the Company may make additional contributions to the Plan at the discretion of the Board of Directors. During 2024, no additional contributions were made. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan.

Administrative and investment advisory charges are paid directly by the Plan. Investment expenses charged by the investment options in which the Plan invests are paid directly from the underlying assets of the respective investment and are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Vesting

Participants are vested immediately in their salary deferral contributions and employer safe harbor nonelective contributions, plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement (defined by the Plan as age 62), participants shall become 100% vested in the Company profit sharing contribution portion of their account. For all other participants, vesting in the Company profit sharing contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Less than 3	0%
3 or more	100%

Payment of Benefits

Upon termination of service, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or a direct rollover to another retirement account. In the event the total value of a terminated participant's account is less than \$7,000, the Company may make an involuntary distribution of the participant's vested account balance.

Salary Deferral, Profit Sharing, and Employer Safe Harbor Nonelective Contributions

Payments of a participant's salary deferral, employer profit sharing, and employer safe harbor nonelective contributions (and earnings thereon) are generally available for distribution upon normal retirement or shortly after the participant terminates employment with the Company. Withdrawals from the salary deferral portion of a participant's vested account balance (including catch-up contributions and earnings) may also be made in the event of a financial hardship, in accordance with provisions specified in the Plan. Upon a hardship withdrawal, there is no suspension period placed on future employee deferrals.

Forfeited Accounts

Forfeited nonvested accounts of terminated participants will be reallocated to the accounts of other participants or used to offset Plan expenses. At December 31, 2024 and 2023 there was \$3,081 and \$6,066, respectively, of forfeited nonvested accounts which will be used to offset future expenses or reduce employer contributions. During 2024, there was \$0 forfeited from nonvested accounts and forfeitures of \$3,035 were used to reduce expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the basis of United States Generally Accepted Accounting Principles.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

The Plan's investments in collective trust funds are accounted for in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans* (ASC 962). The collective trust funds have been reported using the net asset value (NAV) as a practical expedient which is a representation of the fair value of the funds.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is net of applicable investment expenses.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to Plan administration and investment advisory services are charged directly to the participant's account and are included in administrative expenses.

3. Information Certified by the Trustee

The Plan's investments are administered by the trustee, Empower Retirement, as of December 31, 2024 and 2023 and for the years then ended. All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, and interest income, dividends and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained and certified as complete and accurate by the trustee, as previously defined.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the closing NAV reported on the active market on which the individual funds are traded.

Fixed Annuities

The reported values for the fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.

6. Tax Status

The IRS has determined and informed the Company by a letter dated June 29, 2017, that the Plan and related trust, as designed, are in accordance with applicable sections of the Internal Revenue Code (the IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the trustee and, therefore, are considered party-in-interest transactions. Expenses paid by the Plan for administrative and investment advisory expenses amounted to \$123,889 for the year ended December 31, 2024.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated events occurring between December 31, 2024 and July 23, 2025, the date the financial statements were available to be issued.
