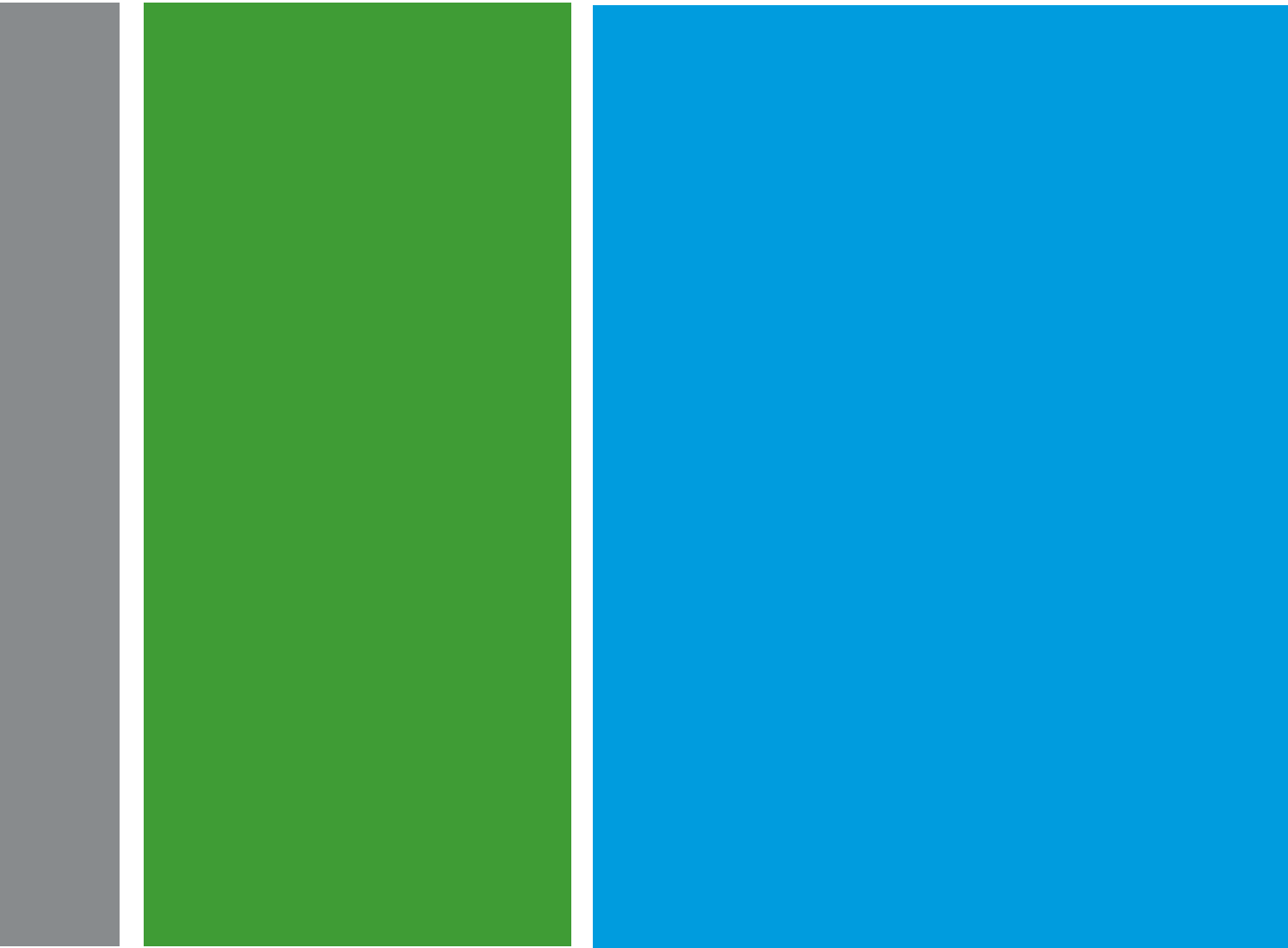

## INDEPENDENT AUDITORS' REPORT

To: The Plan Administrator of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Money Group Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

---

### 1) Plan description:

The following brief description of Money Group Retirement Plan (formerly known as Ad Practitioners Retirement Plan) (the Plan) is provided for general purposes only. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

- A) General – The Plan was established on January 1, 2020, as a profit-sharing plan with cash or deferred arrangement to provide benefits upon retirement, disability or death to participating employees or beneficiaries. The Plan covers all full-time employees of Money Group, LLC (formerly known as Ad Practitioners, LLC) (the Employer) provided they have worked at least six (6) months of service. Employees should be residents of Puerto Rico and no minimum age is required to become a participant. The Plan qualifies under Section 1081 of the Puerto Rico Internal Revenue Code (the Code), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Banco Popular de Puerto Rico is the trustee for the Plan.

On March 24, 2023, the Plan Document was amended to change the name of the Plan and the Plan Sponsor to Money Group Retirement Plan and Money Group, LLC, respectively. The effective date of this amendment was January 1, 2023.

- B) Contributions – Participants' pre-tax contributions are limited to \$15,000 as established by the Code. Total annual contributions made by the Employer and participants are limited to the lesser of \$69,000 or the total compensation paid by the Employer to the participant during the Plan year, as provided by the Code. Also, a participant who has attained age 50 by the end of a calendar year, may elect to make catch-up contributions up to a maximum of \$1,500. Participants may also make after-tax contributions to the Plan up to 10% of their compensation.

The Employer may make discretionary matching contributions which are determined annually. Discretionary matching contributions shall be contributed to the Plan with each payroll. Participants may also contribute amounts representing distributions from other Puerto Rico qualified retirement plans (rollovers).

- C) Participant accounts – Individual accounts are maintained for the Plan's participants to reflect the participants' and Employer's contributions, as well as the participants' share of the Plan's earnings and losses, appreciation and depreciation in the value of investments in the Master Trust, withdrawal or distribution and any related expenses.
- D) Vesting – Participants are immediately 100% vested in their contributions, matching contributions, rollover contributions plus actual earnings or losses thereon.
- E) Investments options – The Plan investments in the Master Trust are participant-directed. Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Contributions to a participant account that has not chosen an investment option are invested in a default fund. Participants may change their contributions at any time thereafter. The Plan also allows participants to change their investments options daily.
- F) Hardship withdrawals – Under certain circumstances, as defined by the Plan, and pursuant to applicable regulations, participants, while still employed by the Employer, are permitted to withdraw, in a single sum, a portion of employee contribution in their account balance. These conditions include: the purchase of principal residence, un-reimbursed medical expenses, payment of post-secondary tuition for the participant or a dependent, to prevent eviction or foreclosure on a principal residence, for funeral expenses for the participant's deceased parent, spouse, children or dependent, and/or for any other cause that, in the Plan's Administrator determination or through regulations, has produced an immediate and heavy financial need.

- G) Payment of benefits – On termination of service due to death, termination, or retirement, a participant may elect to receive either a lump-sum or annual installment over a fixed period of time. Normal retirement age is 65 years.

### 2) Summary of significant accounting policies:

- A) Basis of presentation – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.
- B) Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.
- C) Interest in Master Trust – Investment assets of the Plan are maintained in the Master Trust administered by Banco Popular de Puerto Rico, as Trustee. The Plan participates in one Master Trust.
- D) Investments valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The net appreciation (depreciation) in fair value of investments includes the Plan’s interest in Master Trust realized gains or losses on sales and net change in unrealized gains or losses on investments held. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

- E) Contributions – Participant contributions are recorded in the Plan year in which the Employer makes the payroll deductions.
- F) Benefits – Benefit payments to participants are recorded upon distribution.

### 3) Information certified by Banco Popular de Puerto Rico (the Trustee):

The following is a summary of the Plan’s assets information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to Plan’s assets is complete and accurate. Accordingly, as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets:

### 5) Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the assets at fair value of the Master Trust:

- A) Money market funds and interest-bearing deposits – The carrying amount of interest-bearing deposits approximates fair value due to their short-term maturities. These deposits are available on demand and are therefore classified as Level 1. The money market funds held by the Master Trust are registered mutual funds that invest primarily in U.S. government obligations. They are actively traded and valued at their net asset value (NAV), which represents fair value. Accordingly, they are also classified as Level 1.
- B) Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held as Plan's interest in the Master Trust are deemed to be actively traded and are classified as Level 1.
- C) Corporate bonds – Valued using pricing models maximizing the use of observable inputs for similar securities. They are classified as Level 2 within the fair value hierarchy.

### 6) Tax status:

The Plan is intended to be a tax qualified arrangement that complies with the provisions of ERISA and the Code, as amended. The Plan received a determination letter from the Puerto Rico Treasury Department dated December 15, 2020, which established that the Plan and the related trust are designed in accordance with the applicable provisions of the Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, the Plan had maintained its tax exempt status and had taken no uncertain tax positions that would require adjustment or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

The Plan is subject to routine audits by the Puerto Rico Treasury Department. As of December 31, 2024, the years 2020 and thereafter remained subject to examination; however, there are currently no audits for any tax period in progress.

### **7) Risks and uncertainties:**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in market values in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. Individual participant's accounts bear the risk of loss resulting from fluctuations in fund values.

### **8) Parties-in-interest transactions:**

Money Group, LLC and Banco Popular de Puerto Rico are parties-in-interest as defined by ERISA. There were no prohibited parties-in-interest investments or transactions as of December 31, 2024 and 2023, and during the year ended December 31, 2024.

### **9) Plan termination:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to reduce, suspend or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **10) Subsequent events:**

On March 26, 2025, the Plan Document was amended to specify that, for purposes of determining both employee and employer contributions, compensation is defined as base salary only. This definition excludes bonuses, overtime, commissions, and all other forms of compensation additional from base salary. The amendment is effective as of January 1, 2025.

The Plan Administrator is not aware of any additional subsequent events which would require recognition and/or disclosure in these financial statements. The Plan has evaluated subsequent events through July 18, 2025, the date on which the financial statements were available to be issued.
