### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Dewey Services, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Notes to Financial Statements**  
**Year Ended December 31, 2024**

**Note 1 – Description of Plan**

The following description of the Dewey Services, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Dewey Services, Inc. (the “Company”) is the plan sponsor. Principal Life Insurance Company and Principal Trust Company (collectively “Principal”) are the asset custodians and record keepers of the Plan. Principal holds the Plan’s investments and executes investment transactions through the trust established pursuant to the Plan. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan that covers substantially all full-time employees of the Company who have completed 1 year(s) with the company in which they worked at least 1,000 hours and are at least age 18 or older. The Plan was adopted effective August 1, 1984, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Administrative Committee oversees governance of the Plan.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan agreement, subject to a maximum annual limit by the Internal Revenue Service. In 2024, pre-tax contributions are subject to a limitation of \$23,000, plus a catch-up contribution of \$7,500 for participants age 50 or older. Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary contributions at the option of the Board of Directors. For the year ended December 31, 2024, the Company’s contributions totaled \$195,000.

**Participant accounts**

Individual accounts are maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, if any, as well as allocations of Plan earnings and allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

## **Investment options**

The Plan offers various investment options which are managed by Principal. Upon enrollment in the Plan, participants may direct their contributions in any of the investment options offered at the time. Participants may change their investment options daily. Participants should refer to the investment literature provided by the Company for a complete description of the investment options and for the detailed composition of each investment fund.

## **Notes receivable from participants**

Participants may borrow from their accounts a minimum of \$500 up to the lesser of (1) 50 percent of their account balance or (2) \$50,000 reduced by their highest unpaid loan balance outstanding (principal and interest) during the preceding twelve-month period. The loans are secured by the balance in the participant's account. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence and are repayable ratably through payroll deductions. The prime rate is determined based upon the prime rate of interest that is published in the Wall Street Journal on the 14th day of each month. At December 31, 2024 and 2023, interest on notes receivable from participants ranged from 5.25% to 10.50% per annum, with various maturities through June 2034.

## **Payment of benefits**

Upon termination of service due to death, disability, retirement, termination of employment, or financial hardship, participants may elect to receive the vested interest of their accounts in the form of a single sum of cash payment, or a direct rollover to an individual retirement account or another employer plan. Hardship withdrawals are also available.

## **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested Company contributions are used to reduce future Company contributions and to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,514 and \$17,118 and, respectively.

## **Note 2 – Summary of Accounting Policies**

### **Basis of accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

### **Use of estimates**

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include the fair value of certain investments. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. At December 31, 2024 and 2023, there was no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances. Based on the terms of the plan agreement, delinquent participant loans are recorded as distributions when a distributable event occurs.

### **Payment of benefits**

Benefits are recorded when paid in accordance with ERISA reporting requirements.

### **Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the

participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Note 3 – Fair Value Measurements**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are defined as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 – Quoted prices other than those included in Level 1 that are observable either directly or indirectly. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or that can be corroborated by observable market data for substantially the full term of the financial instrument.

Level 3 – Inputs are unobservable and significant to the fair value measurement. Unobservable inputs reflect the Plan's own judgements about assumptions that market participants would use in pricing the asset or liability.

The following are descriptions of the valuation methods and assumptions used for investments of the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported on the active market on which the individual funds are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds are held by the Plan are deemed to be actively traded.

*Guaranteed interest accounts:* The guaranteed interest accounts cannot be sold to a third party; thus, fair value is the amount the Plan's participants would receive currently if they were to withdraw or transfer funds from the Plan prior to their maturity for an event other than death, disability, termination, or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. This value represents contributions allocated to the guaranteed interest accounts, plus interest at the contractually guaranteed rate, less funds used to pay benefits and administrative expenses. The

investments in guaranteed interest accounts are deposited into the Principal general account and the fair value of the guaranteed interest accounts is reflected in Level 3.

*Pooled separate accounts:* Pooled separate accounts (“PSA”) are comprised primarily of shares of registered investment companies held through sub-accounts of Principal. The PSAs are valued using net asset value (“NAV”) as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through Principal. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments.

*Collective trust fund:* Collective trust funds represent investments held in commingled pooled funds. Investments in collective trust funds are valued using the net asset value (NAV) per share (or its equivalent) as a practical expedient, as provided by the fund manager. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets owned by the fund, less its liabilities. This investment category has no unfunded commitments and there are no redemption restrictions.

During the year ended December 31, 2024, there were no transfers of assets between Levels 1, 2 and 3. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023:

#### **Note 4 – Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, asset custodians and record keepers of the Plan.

At December 31, 2024 and 2023, \$456,519 and \$521,752, respectively, of notes receivable from participants and \$44,563 of interest income on notes receivable from participants for the year ended December 31, 2024, was not included in the information certified by Principal, as Principal is not the trustee or custodian for the notes receivable from participants.

#### **Note 5 – Related Party and Party-In-Interest Transaction**

At December 31, 2024 and 2023, certain plan investments are interests in separate accounts managed by Principal. Therefore, the transactions with Principal are party-in-interest transactions. Additionally, the Company provides certain accounting and administrative services to the Plan for which no fees are charged. As the Company is the Plan sponsor, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **Note 6 – Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions, if any.

#### **Note 7 – Tax status**

The Plan currently operates under a prototype plan offered by Principal, which received a favorable opinion letter from the Internal Revenue Service dated June 6, 2011. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable

requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. In addition, there continues to be concern regarding the ongoing impacts and disruptions caused by the COVID-19 pandemic on financial markets. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. At December 31, 2024, the Plan had three investments which exceeded 10% of total investments: AM Funds Mod Gr And In Port R6 – 17.6%, T. Rowe Price Rtmt I 2030 I Fd – 10.3%, and Alger Capital App Instl Y Fund – 10.0%. At December 31, 2023, the Plan had two investments which exceeded 10% of total investments: AM Funds Mod Gr And In Port R6 – 15.7% and T. Rowe Price Rtmt I 2030 I Fd – 10.1%.

#### **Note 9 – Subsequent events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued, noting no other items requiring disclosure.
