Notes to Financial Statements

1. Description of the Plan

The following description of the Axios Media, Inc. 401(k) Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 2019 by Axios Media, Inc. (Company or Plan Sponsor). The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

Empower Trust Company (Empower) is the trustee and recordkeeper of the Plan. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income, (2) employees covered by a collective-bargaining agreement that does not provide for participation in the Plan, (3) leased employees, and (4) independent contractors. Participants must be 21 years of age to participate in the Plan. Additionally, the participant must complete 30 days of service to participate in the Plan.

Contributions

Each year, participants may contribute up to 100% of eligible annual compensation (elective deferral contributions), as defined in the Plan, subject to the limits established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 5%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Effective January 1, 2024, the Plan was restated and the Plan sponsor elected to contribute a safe harbor match, which is 100% on the first 3% and 50% on the next 2%. Participants are immediately vested in the safe harbor match. During 2024, the Company made safe harbor matching contributions of \$2,437,592.

The Plan also provides for a discretionary matching contribution. In 2024, the Company did not make any discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe harbor and discretionary matching contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately vested in all participant contributions, safe harbor matching contributions, and rollover contributions, plus actual earnings thereon. Should the Company choose to provide a discretionary matching contribution, participants become fully vested in employer discretionary matching contributions upon completion of six years of service, with partial vesting of contributions occurring on an increasing annual scale beginning upon completion of two years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to (i) the lesser of \$50,000 or (ii) 50% of their vested account balance. Participant loans are reduced by the highest outstanding balance of any prior loans from the Plan during the prior one-year period. In general, loan repayment terms range from one to five years, or longer for the purchase of a principal residence, but not to exceed ten years. The interest rate on each note, determined quarterly, is set at 0% over the prime rate, as defined. The notes are secured by the balance in each participant's account and no more than one outstanding note is permitted at any time. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon retirement or termination of service, the Plan allows for distributions in accordance with the appropriate provisions of the IRC and applicable state laws. Benefits may be paid upon separation from service due to death, retirement, or termination of employment. If the participant's vested account balance is greater than \$5,000, the participant may choose from the following forms of payment: (1) single-sum payment or (2) installments subject to lifetime required minimum distributions, which may be payable in monthly, quarterly, or annual installments equal to or exceeding the annual required minimum distribution amount. Participants who attain age 59½ or older are eligible for in-service withdrawals.

A lump-sum distribution is automatic upon separation if the participant's vested account balance is \$1,000 or less, except for participants aged 62 and above, whose automatic lump-sum distribution is set at \$7,000. If the participant's vested account balance exceeds \$1,000 and the participant does not elect to receive the distribution directly or have the distribution rolled over to an eligible retirement plan, then the Plan will pay the distribution in a direct rollover to an individual retirement account (IRA) at a financial institution selected by the Plan Sponsor. A charge or restriction might apply for some investment options if all or any part of the account is taken in a single sum.

Distributions to participants on account of financial hardship may be made in certain circumstances, subject to approval by the Plan Sponsor and are limited under the terms of the Plan.

Administrative Expenses

The Plan Sponsor has elected to pay most administrative expenses associated with the Plan, which are excluded from these financial statements. Participants are charged directly for certain fees related to individual participant loans and distributions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

Subsequent Events

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by JP Morgan Investment Holdings (JP Morgan), a service provider to the Plan. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related to Plan operations and investment activity to JP Morgan during 2024. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Tax Status

The Plan Sponsor adopted a non-standardized defined contribution pre-approved plan document sponsored by Empower Retirement, LLC. The Internal Revenue Service (IRS) has determined and informed Empower Retirement, LLC by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.
