**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Savings Plan for Employees of Douglas County Incorporated (the "Plan") is provided for general information purposes only. The Plan is sponsored by Douglas County Incorporated (the "Company") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a self-directed, defined contribution profit sharing plan with an elective section 401(k) salary reduction option. All eligible employees are able to participate in the Plan after completing one year and 1,000 hours of service with the Company. The Plan maintains monthly entry dates of the first day of each month. The profit sharing plan was established in 1993, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent qualified retirement plan legislation.

Employee Contributions

Employee contributions consist of the amount of salary deferral elected by each participant and may be up to 100% of the participant's pre-tax earnings up to the maximum amounts allowed by law. Participants are limited in their Section 401(k) contributions by nondiscrimination testing of Section 401(k) of the Internal Revenue Code. The maximum Section 401(k) contribution amount, per participant, was \$23,000 for 2024 and \$22,500 for 2023. However, for participants age 50 and above, additional "catch-up" contributions were allowed, up to \$7,500 and \$7,500 for 2024 and 2023 respectively, for a total annual amount of \$30,500 for 2024 and \$30,000 for 2023.

The Plan offers a variety of investment options and allows for participant-directed investment. Participant contributions are maintained in separate accounts.

Employees, even those not yet eligible to participate in the Plan, may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans as well as individual retirement accounts (IRAs). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

Employer Contributions

The Plan provides for the Company to make a fixed matching contribution which is fixed at 50% of the first 4% of base compensation that a participant contributes to the Plan. Profit sharing contributions from the Company are also made at the discretion of the Company's Board of Directors.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching contribution, the Employer's profit sharing contribution (if applicable), and allocations of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Vesting interest in the Company's matching and profit sharing contributions are calculated at 20% per year of service, beginning with the participant's first full year of service and reaching 100% at the end of five years of credited service of at least 1,000 hours per year. Participants will become fully vested if termination of employment occurs due to death or disability, regardless of years of continuous service.

Investment Options

Upon enrollment in the Plan, each participant elects to self-direct the investment of their entire account balance in 1% increments, which are limited to any of the investment funds offered by and entrusted to John Hancock Life Insurance Company, as custodians. Participants may change their investment options daily.

Loans to Participants

No loans to participants are permitted.

Payment of Benefits

The Plan provides for retirement and disability benefits. The custodian of the Plan shall commence distribution of a participant's non-forfeitable accrued benefits as soon as administratively feasible after the participant terminates employment with the Company.

Distributions to participants of §401(k) plan funds are restricted by certain federal regulations to the following events: (i) participant's retirement, (ii) death or disability, or (iii) separation from service, as defined by the regulations. In-service distributions may be made for participants over the age of 59 ½ from their vested account balance. Hardship distributions are also allowed from participants vested balances upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeited Accounts

Forfeitures of unvested employer match and profit sharing contributions are used to reduce future employer contributions. No Forfeitures were used to reduce the Company's matching contributions in 2024, and forfeitures of \$4,491 were used to reduce Company's matching contributions in 2023. At December 31, 2024 there was \$1,816 in unallocated forfeitures to reduce employer match contributions in 2025.

Corrective Distributions

Contributions provided under a qualified plan must be nondiscriminatory. If the Plan fails the Actual Deferral Percentage (ADP) Nondiscrimination test, since the Plan is not a safe harbor plan, all excess contributions of Highly Compensated Employees (HCEs) are required to be distributed back to the applicable HCE participants as a corrective refund of excess contributions.

Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to Participant accounts will become 100% vested. At that time, amounts would be paid out as a lump-sum distribution directly to the participant or to another qualified plan or account of their choosing.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income are recorded on the accrual basis of accounting. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, all participants who had elected to withdraw from the Plan had been paid.

Administrative Expenses

The Plan's accounting, legal and some third-party administrator expenses are paid directly by the Company. All other administrative and investment fees are allocated to individual participant accounts as asset management charges. See Note 5 for administrative expenses paid by the Company.

Risks and Uncertainties

The Plan provides for various investment options that have different strategies. These investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled Separate Accounts:* Number of shares owned in the underlying separate account multiplied by the closing net asset value per unit as quoted by the contract issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – TAX STATUS**

The Plan has obtained an IRS approval determination letter, dated June 30, 2020, for the volume submitter plan document adopted by the Plan, which may constitute reliance on the approved plan. The Plan has been amended since receiving the determination letter; however, the Plan's Advisory Committee and legal and tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan continues to qualify under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of pooled separate accounts held and managed by John Hancock Life Insurance Company USA (John Hancock USA). John Hancock USA was a custodian of the plan assets and, therefore, these transactions qualify as party-in-interest transactions. John Hancock USA received only indirect compensation in 2024.

Fees of \$31,025 and \$23,139 were paid directly by the Company for 2024 and 2023, respectively. These covered the cost for the Plan's third-party administration and audit services, which are considered party-in-interest.

**NOTE 6 – INFORMATION CERTIFIED BY PLAN CUSTODIAN**

The plan administrator has elected the method of compliance as permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA of 1974. Accordingly, as permitted under such election, the Plan’s independent auditors need not perform any auditing procedures with respect to the following information certified by John Hancock Life Insurance Company USA, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedules.

**NOTE 7 – GUARANTEED INTEREST ACCOUNTS**

The John Hancock Guaranteed Interest Account is an investment option offered under the John Hancock group annuity contract. Contributions are held in the John Hancock general account. Guaranteed interest accounts guarantee the return of principal, plus compound interest earned over a defined 3, 5, or 10 year term, less any applicable contract or participant-level recordkeeping changes. Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed interest accounts in that month. For other types of contributions, interest rates may change during the month. At the end of each reporting year, a composite rate of interest is determined for each participant account, depending on the amounts contributed and the rate in effect on the day it is allocated under the participant account. Contributions continue to earn that calculated composite interest rate for the duration of the guarantee term.

The John Hancock Guaranteed Interest Account is reported at contract value.
