### ***Opinion***

We have audited the financial statements of Fishback Financial Corporation Employee Stock Ownership Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### ***Basis for Opinion***



**Note 1: Description of the Plan**

***General***

The following description of the Fishback Financial Corporation Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

Fishback Financial Corporation (Company) established the Plan effective as of January 1, 2010. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan is administered by an Employee Benefits Administration Committee (Plan Committee) appointed by the Company's Board of Directors. The trust department of a subsidiary of the Company is the Plan's custodian and trustee.

The Plan purchased Company common shares and holds the stock in a trust established under the Plan. All Company stock held by the Plan is allocated to eligible Company employees.

***Eligibility***

Employees of the Company and participating subsidiaries are generally eligible to participate in the Plan on the first day of each month after which the employee has worked at least one hour and has attained the age of eighteen.

***Employer Contributions***

The Company will allocate 100% of matching contributions (on elective deferrals in Fishback Financial Corporation 401(k) Profit Sharing Plan (the 401(k) Plan), up to 7% of employee's compensation, to the employee stock ownership plan. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. There were no profit-sharing contributions made during 2024 and 2023. Employee contributions are not permitted.

***Vesting***

Participants vest in the Company's contributions and earnings thereon based on years of service. Employees are 20% vested after two years of service and become an additional 20% vested each of the next four years, becoming fully vested upon completing six years of service. Participants terminating due to normal retirement, death, or disability will be 100% vested.

***Payment of Benefits***

Upon completion of five years of participation in the Plan, a participant may elect to diversify a portion of their company stock account by a transfer of cash of up to 100% of their vested company stock to the 401(k) Plan. Any amount transferred to the 401(k) Plan shall be subject to the terms of the 401(k) Plan after the transfer. In addition, distributions are available to current employed participants upon reaching six years of service and 59 ½ years of age.

No other distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to the participant's beneficiary or, if none, his or her legal representatives), becomes permanently disabled, or otherwise terminates employment with the Company and its participating subsidiaries.

Distribution of a participant's account will be made in shares of Company stock, cash or a combination of Company stock and cash at the discretion of the Plan Administrator in a lump sum amount; provided however, that the Plan Administrator shall provide written notification to the participant of his or her right to demand that the value of the Company stock portion of his or her account be distributed solely in Company stock.

***Put Option***

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock.

The put option shall be exercisable only with respect to such shares held by the participant by written notice to the Company during the first 60 days after the Company stock is distributed by the Plan and for a 60-day period commencing one year after the Company stock is distributed by the Plan and annually thereafter. If exercised, the Trustees may, in their sole discretion, assume the Company's rights and obligations with respect to purchasing the Company stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Voting Rights***

The Trustee receives instructions from the Plan Committee, and all Company stock held by the Trust is voted by the Trustee in accordance with instructions from the Plan Committee. Notwithstanding the foregoing, the participant (or their beneficiary) shall be entitled to direct the voting of any voting shares of Company stock allocated to their Company stock account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, liquidation, dissolution, or sale of substantially all of the assets relating to the trade or business of the Company.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of active participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify shall be offered at least three investment options.

***Participant Accounts and Forfeitures***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited semi-annually with an allocation of shares of the Company's common stock purchased with proceeds from employer contributions. Only those participants who are eligible employees of the Company will receive an allocation. Employer contributions are allocated to each participant's account based on a percentage of participant's eligible compensation relative to total eligible compensation. Plan earnings are allocated semi-annually to each participant's account based on the ratio of the participant's beginning of the period account balance to all participants' beginning of the period account balances.

Forfeitures of terminated nonvested account balances shall first be used to restore forfeited amounts to qualifying participants and then to pay administrative expenses or to reduce future Company matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$159,387, respectively. In 2024 and 2023, Plan administrative expenses paid from forfeited nonvested accounts totaled \$33,826 and \$36,164, respectively. In addition, in 2024 and 2023, Company contributions were reduced by \$381,919 and \$57,983, respectively, from forfeited nonvested accounts.

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, change in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The common shares of the Company are valued at estimated fair value on December 31, 2024 and 2023. Fair value is determined by semi-annual independent appraisals.

Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date.

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from employer matching contributions are recorded in the year in which participant compensation is earned.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

***Plan Tax Status***

The Plan received a determination letter dated September 26, 2013, in which the Internal Revenue Service stated the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore they believe that the Plan was qualified, and

the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 3: Administration of Plan Assets**

The Trustee of the Plan holds the Plan's assets, which consist principally of Fishback Financial Corporation common shares.

Company contributions are held and managed by the Trustee, which invests cash received, interest and dividends income and makes distributions to participants, as instructed by the Plan Committee. Distributions to participants are made by the Trustee.

**Note 4: Dividends**

During the Plan years ended December 31, 2024 and 2023, the Company paid \$396,472 and \$419,334, respectively, in cash dividends on Company common stock shares held by the Plan. Dividends were paid directly by the Company to the participants. The dividends and distributions reported on the Plan's financial statements include these amounts.

**Note 5: Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The valuation process involves plan management’s selection of an independent appraiser under an annual contract. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP trustee, reviews in detail, discusses and approves. The results of this process are documented in minutes of the plan fiduciary or Company minutes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7: Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons. The Plan paid \$33,826 and \$36,164 of administrative expenses to parties-in-interest for the years ended December 31, 2024 and 2023, respectively.

The Plan invests in certain funds of the Plan Trustee, including Fishback Financial Corporation common stock and an interest-bearing money market bank account with the Company's bank subsidiary. The Company provides certain administrative services at no cost to the Plan.

**Note 8: Transfer of Plan Assets**

Eligible employees have the option to transfer 100% of their account in the Plan to the Company's 401(k) Plan once every five years after they have completed five years of participation in the Plan.

For the years ended December 31, 2024 and 2023, a total of \$175,378 and \$247,049 was transferred from the Plan to the Company's 401(k) as elected by the participants to diversify a portion of their company stock. This transfer to the 401(k) is included as a transfer on the statements of changes in net assets available for benefit.

**Note 9: Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, participants will become 100% vested in their accounts and the interest of each participant in the trust fund will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund and sell shares of financed stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan (if any).

**Note 10: Risks and Uncertainties**

The Plan primarily invests in Company common stock, which is exposed to various risks, such as interest rate, market and credit risks as well as valuation assumptions based on earnings, price/book values and/or other such techniques. Due to the level of risk associated with such investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Note 11: Subsequent Events**

Subsequent events have been evaluated through July 23, 2025, which is the date the financial statements were available to be issued.
