Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Chileda Institute, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accounting records of the Plan are maintained on the accrual basis and presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan’s valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Interest and Dividend Income - Interest and dividend income are recorded when earned during the fiscal year.

Purchases and Sales of Securities - Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of securities is based on cost. Cost is the fair value at the beginning of the Plan year or historical cost if the security was purchased during the Plan year.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

NOTE 2 - PLAN DESCRIPTION

The brief Plan description is provided for general information purposes only; for more complete information, the participants should refer to the Plan agreement.

The Plan is a defined contribution employee benefit plan, with employee elective contributions and employer matching and employer discretionary contributions, covering substantially all full-time employees of Chileda Institute, Inc. The Plan was adopted on April 1, 2012 and restated effective January 1, 2015. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Chileda Institute, Inc. employees who have completed one year of service, worked one thousand hours, and have obtained the age of 21 are eligible to participate in the Plan.

Vesting - Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in Chileda Institute, Inc.'s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service based on the schedule below.

The vesting percentage times the employee's account balance is his or her benefit if they terminate employment.

Contributions - Each year, participants may contribute up to the maximum percentage allowable by Internal Revenue Code Sections 401(k), 402(g), 404 and 415. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The sponsor may make matching contributions equal to a discretionary percentage to be determined by the sponsor. The sponsor contributed 100% of the first 4% of base compensation that a participant contributed to the Plan as matching contributions for the years ended December 31, 2024 and 2023. Additional amounts may be contributed at the option of the Chileda Institute, Inc.'s Board of Directors. Chileda Institute, Inc. made a 3.0% discretionary contribution for the year ended December 31, 2024 and a 2.0% discretionary contribution for the year ended December 31, 2023. All employee and employer contributions are participant directed.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Chileda Institute, Inc.'s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits - On termination of service, a participant may elect to receive the value of his or her account in a lump-sum distribution, a series of substantially equal periodic installments not to exceed the participant's life expectancy, or partial withdrawals as described in the Plan's provisions.

Forfeited Accounts - Forfeitures are used to pay Plan expenses and/or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,965 and \$28,733, respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs rather than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of certain pooled separate accounts is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

The fair value of these investments are determined by pricing data provided by outside valuation service providers who generally use the mean bid/ask prices but may also use alternative observable pricing inputs including discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

Level 3 Fair Value Measurements

The fair value of these investments are determined by inputs to the valuation methodology that are not observable and are significant to the fair value measurement.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2, or 3.

Pooled Separate Accounts - Pooled separate accounts are valued at NAV of the units of the pooled account. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell its investments for an amount different than the reported NAV. Participant transactions may occur daily. Redemption frequency and notice period is daily.

Certain investments that were measured at NAV have not been classified in the fair value hierarchy table presented below. The fair value amounts presented in the table are intended to permit the reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for plan benefits.

NOTE 4 – INVESTMENTS

All investments bear full market risk. All gains and losses (realized and unrealized) are attributed to pooled separate accounts for the year ended December 31, 2024 and 2023 and are included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with Standard Life Insurance Company. Standard Stable Asset D investment choices are invested in a general account. The Stable Asset D has no stated maturity. Interest rates are reset quarterly as of the beginning of the quarter, during which a new interest rate is applied daily to the total outstanding balance of the investment. As described in Note 1, this type of investment is considered fairly valued at contract value.

The Standard Stable Asset D investment choice is a non-tradable obligation of Standard. The investment’s contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Standard.

The repayment of principle and interest credited to participants holding the investment is a financial obligation of Standard. However, if an event should occur such that realization of full contract value for a particular investment contract is no longer probable, the Stable Asset D investment choice may no longer be considered fully benefit-responsive.

The terms of Standard Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no condition, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to other investment choices within the plan.

Since the Stable Asset D investment choice is an obligation of Standard, the occurrence of an event that limits the ability of the investment to transact at contract value between Standard and a participant holding the investment is not probable.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY, continued

The Stable Asset D investment choice allows a participant reasonable access to their assets.

Assets held in Stable Asset D investment choices are commingled with assets in the general account. There is no specific portfolio of assets in which the Stable Asset D investment choices invest, so no financial statements are available.

The credited interest rate is backed by the income received from assets held in the general account.

NOTE 6 - ADMINISTRATIVE EXPENSES

Chileda Institute, Inc. pays certain administrative expenses and participant fees that are not absorbed by participant accounts.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Chileda Institute, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 8 - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter dated June 30, 2020 from the Internal Revenue Service. The Plan has been subsequently amended, and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
