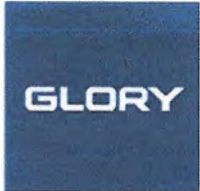

### Note 1: Description of Plan

The following description of the Glory Global Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Glory Global Solutions Inc. (the Company). Fidelity Management Trust Company (Fidelity) is the Plan's trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility and Participation

Eligible employees are immediately able to participate in the Plan upon hire. All employees are eligible except for employees covered by a collective bargaining agreement, residents of Puerto Rico, leased employees, expatriate employees, or nonresident aliens with no income from a United States source.

Employees are immediately eligible to receive employer base contributions. Also, employees are immediately eligible for matching contributions if they have made elective contributions during the Plan year.

#### Contributions

Each year participants may contribute up to 40% of their pre-tax annual compensation, as defined in the Plan, but no more than allowable under the Internal Revenue Service (IRS). Participants are automatically enrolled at 6% contribution rate unless specified otherwise. Participants who were automatically enrolled in the Plan also receive an automatic increase of 1%, unless specified otherwise, occurring annually at the beginning of the Plan year until a 10% contribution rate is attained. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants may elect to make Roth contributions to the Plan.

The Company may make discretionary matching contributions. During 2024, the Company made discretionary matching contributions equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The Company also contributes a base contribution which equals 2.5% of eligible compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions. Plan earnings (losses) and administrative expenses are allocated based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting schedules and service hours eligible toward vesting for contributions made under other plans and merged into the Plan vary. Participants should refer to the Plan document for a more complete description of the Plan's vesting provisions. The vesting for Company discretionary matching and base contributions are as follows:

#### Notes Receivable from Participants

Notes receivable from participants are loans made to participants from their account balance. Participants may borrow from their account balance a minimum of \$1,000, up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by commercial lending institutions. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits under the Plan are paid to a participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan document. The participant may elect to receive a single lump sum payment or payments in an annuity for certain eligible participants. In-service distributions may be made to participants who have not terminated employment and have attained age 59 ½. However, if the value of vested benefit is less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment and account values of \$1,000 to \$7,000 will be automatically rolled into an IRA unless the participant directs otherwise.

Under certain circumstances, participants may qualify to receive a hardship distribution, as defined, from their account balance.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be used to reduce Company contributions or used to pay administrative expenses in accordance with the Plan document. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$9,114 and \$18,422, respectively. During 2024, the Company contributions were reduced by \$370,916 from forfeited nonvested accounts.

#### Secure 2.0

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### **Administrative Expenses and Revenue Credits**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments. Revenue credits are calculated quarterly by Fidelity and used to reimburse the Plan for administrative expenses. Revenue credits of \$50,000 were used to offset \$24,715 of administrative expenses for the year ended December 31, 2024.

#### **Subsequent Events**

Subsequent events have been evaluated through July 21, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4: Information Certified by Plan Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivables from participants, administrative expenses and revenue credits, and interest and dividends for the year ended December 31, 2024 was obtained or derived from information certified as complete and accurate by Fidelity.

#### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

#### Note 6: Tax Status

The Plan adopted the Fidelity Prototype Plan (Prototype Plan) with an IRS determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the prototype document has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan Administrator believes the Plan is exempt from federal and state income taxes. Plan management evaluates uncertain income tax positions taken by the Plan.

### **Note 7: Party-in-Interest Transactions**

Certain investments are in mutual funds managed by Fidelity. These transactions, notes receivable from participants, and administrative expenses qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29CFR 408(b) of the ERISA regulations.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

### Note 1: Description of Plan

The following description of the Glory Global Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Glory Global Solutions Inc. (the Company). Fidelity Management Trust Company (Fidelity) is the Plan's trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility and Participation

Eligible employees are immediately able to participate in the Plan upon hire. All employees are eligible except for employees covered by a collective bargaining agreement, residents of Puerto Rico, leased employees, expatriate employees, or nonresident aliens with no income from a United States source.

Employees are immediately eligible to receive employer base contributions. Also, employees are immediately eligible for matching contributions if they have made elective contributions during the Plan year.

#### Contributions

Each year participants may contribute up to 40% of their pre-tax annual compensation, as defined in the Plan, but no more than allowable under the Internal Revenue Service (IRS). Participants are automatically enrolled at 6% contribution rate unless specified otherwise. Participants who were automatically enrolled in the Plan also receive an automatic increase of 1%, unless specified otherwise, occurring annually at the beginning of the Plan year until a 10% contribution rate is attained. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants may elect to make Roth contributions to the Plan.

The Company may make discretionary matching contributions. During 2024, the Company made discretionary matching contributions equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The Company also contributes a base contribution which equals 2.5% of eligible compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions. Plan earnings (losses) and administrative expenses are allocated based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting schedules and service hours eligible toward vesting for contributions made under other plans and merged into the Plan vary. Participants should refer to the Plan document for a more complete description of the Plan's vesting provisions. The vesting for Company discretionary matching and base contributions are as follows:

#### Notes Receivable from Participants

Notes receivable from participants are loans made to participants from their account balance. Participants may borrow from their account balance a minimum of \$1,000, up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by commercial lending institutions. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits under the Plan are paid to a participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan document. The participant may elect to receive a single lump sum payment or payments in an annuity for certain eligible participants. In-service distributions may be made to participants who have not terminated employment and have attained age 59 ½. However, if the value of vested benefit is less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment and account values of \$1,000 to \$7,000 will be automatically rolled into an IRA unless the participant directs otherwise.

Under certain circumstances, participants may qualify to receive a hardship distribution, as defined, from their account balance.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be used to reduce Company contributions or used to pay administrative expenses in accordance with the Plan document. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$9,114 and \$18,422, respectively. During 2024, the Company contributions were reduced by \$370,916 from forfeited nonvested accounts.

#### Secure 2.0

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### **Administrative Expenses and Revenue Credits**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments. Revenue credits are calculated quarterly by Fidelity and used to reimburse the Plan for administrative expenses. Revenue credits of \$50,000 were used to offset \$24,715 of administrative expenses for the year ended December 31, 2024.

#### **Subsequent Events**

Subsequent events have been evaluated through July 21, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Information Certified by Plan Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivables from participants, administrative expenses and revenue credits, and interest and dividends for the year ended December 31, 2024 was obtained or derived from information certified as complete and accurate by Fidelity.

### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

### Note 6: Tax Status

The Plan adopted the Fidelity Prototype Plan (Prototype Plan) with an IRS determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the prototype document has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan Administrator believes the Plan is exempt from federal and state income taxes. Plan management evaluates uncertain income tax positions taken by the Plan.

### **Note 7: Party-in-Interest Transactions**

Certain investments are in mutual funds managed by Fidelity. These transactions, notes receivable from participants, and administrative expenses qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29CFR 408(b) of the ERISA regulations.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
