Report on Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Burwood Group, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Burwood Group, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of the Plan

The following description of Burwood Group, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective January 1, 2021, the Plan was restated. Pursuant to the restatement, participants may contribute up to 100% of their pretax annual eligible compensation (elective contribution). Effective September 1, 2021, the Plan was amended. Pursuant to the amendment, all active and new participants shall vest under a 3-year cliff vesting schedule for the employer-matching and employer non elective contributions. The previous vesting provisions under the 2-6 year graded schedule will continue to apply to all employees who terminated prior to September 1, 2021.

General

The Plan is a defined contribution plan sponsored by Burwood Group, Inc. (Company) for the benefit of its employees who are not covered by a collective bargaining agreement. Employees become eligible upon attaining the age of 21. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as subsequently amended.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation, up to the Internal Revenue Service limit. Employee rollover contributions are also permitted. Participants may change their deferral rate monthly taking effect as of the first day of the following month. Salary deferred contributions are also subject to a separate limitation that must be met in order to satisfy certain nondiscrimination tests as required under tax law and regulations. Employee rollover contributions are also permitted. Effective September 1, 2023 the Plan allows after-tax employee contributions.

The Company made a qualified non-elective contribution in the amount of \$40,130 for the year ended December 31, 2024. The Company may also make a discretionary employer matching contribution, as determined by the Company's Board of Directors. The Company made matching contributions of \$513,626 for the plan year ended December 31, 2024 equal to 100% of the employee elective contribution limited to the first 3% of eligible compensation as defined by the Plan.

Participant Investment Account Options

Participant investment account options available include various mutual funds, common collective trusts, and a guaranteed interest fund. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and in the Company's qualified non elective contribution, plus earnings thereon. Vesting in the Company's employer matching contributions and employer non elective contributions portion of their accounts plus earnings thereon, is based on years of continuous service. Participants that were terminated subsequent to September 1, 2021, are fully vested after three years of service. Participants that were terminated prior to September 1, 2021, vest under the 2-6 year graded schedule.

Payment of Benefits

Upon retirement, death or termination, the participant or beneficiary will receive the vested balance in the participant's account in the form of a lump-sum distribution, installment payments or transfer to another plan at the participant's discretion. If the participant's vested account balance is greater than \$5,000, the participant may elect to keep that balance in the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$5, respectively. Forfeited accounts are applied to reduce employer match or toward administrative expenses. No amount was used to reduce administrative expenses during the year ended December 31, 2024. For the year ended December 31, 2024, \$72,256 was utilized to reduce employer contributions.

Notes Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings unless the participant is paying the loan in full. Interest on the loans ranging from 4.25% to 9.50% at December 31, 2024, is based on local prevailing rates as determined by the plan administrator.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services. Administrative expenses paid by the Plan were \$73,712 for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participants notes receivable are reclassified as distributions based upon the terms of the plan document.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of shares of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The fair values of participation units held in common collective trusts are based on the net asset value per unit (NAV) as reported by the fund managers.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contracts with Insurance Company

The Plan invests in a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a rate of 2.35% - 2.45% during 2024, that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The interest earned is compounded daily to the effective annual interest rate. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of this investment was \$241,059 and \$185,750 at December 31, 2024 and 2023, respectively

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contracted obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at

contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The contract may be terminated either by the Company or by Empower upon written notice. The termination of the contract will have no impact on the value of the contract. Empower reserves the right to defer the payment of a total withdrawal from the contract upon termination for up to six months.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Plan Terminations

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account.

Note 8. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Burwood Group, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain funds of the plan trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Net appreciation (depreciation) also includes certain investment management fees.

Note 10. Subsequent Events

Subsequent events have been evaluated through July 22, 2025, which is the date the financial statements were available to be issued.
