## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of  
Momentum Midstream Management LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Momentum Midstream Management LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

**Note 1 - Description of Plan**

The following description of the Momentum Midstream Management LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the *Plan Document* for more information, which is available from the Plan Administrator.

General

The Plan, effective as of November 23, 2005, was most recently amended and restated on May 1, 2023. The Plan is a defined contribution plan covering substantially all employees of Momentum Midstream Management LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan trustees and recordkeeper

JPMorgan Invest Holdings LLC serves as the recordkeeper and retains FASCore, LLC to provide recordkeeping services for the Plan, as an agent for Reliance Trust Company ("Reliance"), trustee of the Plan. Effective April 1, 2023, Reliance designated Empower Trust Company, LLC (collectively with Reliance, the "Trustees") to be the trustee of the Plan.

Eligibility

Full-time and part-time employees are eligible to participate in the Plan after reaching age 18 and completing one month of service. Part-time employees are required to complete 1,000 hours of service to be eligible to participate in the Plan. New employees who are eligible to participate in the Plan are automatically enrolled at a pretax deferral rate of 3%. This occurs as soon as administratively feasible after thirty days of employment unless otherwise specified.

Participant contributions

The Plan provides for voluntary employee contributions expressed as a percentage of the participant's eligible compensation, as defined, up to 100% of a participant's compensation. The contributions are not to exceed the limits set by the Internal Revenue Code ("IRC"), which limits the annual amount of salary deferrals that may be made by any participant. Eligible participants may also make catch-up contributions upon attaining 50 years of age, as defined by the IRC. Participants may also rollover amounts representing distributions from other qualified plans.

Employer contributions

The Company adopted the Safe Harbor provisions of the IRC. The employer will make a mandatory matching contribution on behalf of each participant's contribution in the amount equal to 100% of the employee's elective deferrals not to exceed 6% of the employee's eligible compensation for the Plan year.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's Safe Harbor contribution, and Plan earnings/losses. Each participant's account is charged with an allocation of administrative expenses, if any.

**Note 1 - Description of Plan (Continued)**Participant accounts (continued)

Participants direct the investment of their account balances in any of several investment funds. Participants can change their investment options among the various investment funds either through direct transfers from one fund to another or by changing the percentage of future contributions allocated among the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Company Safe Harbor contributions and actual earnings (losses) thereon.

Plan expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid by the Company at its discretion. Expenses that are paid by the Company are excluded from these financial statements. Transaction-related fees are paid by participants. Investment related expenses are included in net appreciation in the fair value of investments.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note receivable balance in the participant's account during the prior 12-month period or 50% of the participant's vested account balances. Additionally, a participant may not have more than one note receivable outstanding at any time. Each note receivable under the Plan must mature within five years from the date on which it was made unless the note receivable is used to acquire a principal residence, in which case the note receivable may permit a longer repayment term. The notes receivable is secured by the balance in the participant's account and bear interest at 2% over the Prime Rate published in the *Wall Street Journal* on the first business day of the month before the loan is originated.

Participant withdrawals

Upon termination of services due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount. If the value of the participant's account is less than \$7,000, the Company can distribute the entire vested account balance. If the participant's account balance is between \$1,000 and \$7,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. If the participant's account balance is less than \$1,000, the payment will be made in cash in a single lump sum.

Additionally, participants may make early withdrawals of all or a portion of their vested account balance under the hardship provisions of the Plan. Participants may make unrestricted early withdrawals of amounts representing distributions from other qualified retirement defined benefit or contribution plans. Participants may make unrestricted withdrawals of their vested account balance on or after age 59 1/2. Withdrawals from the Plan may be subject to federal income tax on contributions and income earned.

**Note 1 - Description of Plan (Continued)**Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets would be allocated among participants of the Plan in accordance with the provisions of the Plan.

**Note 2 - Summary of Significant Accounting Policies**Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Participant withdrawals are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make use of estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Unrealized appreciation or depreciation and realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Financial instruments and credit risk

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions, upon liquidation of their account balance.

Subsequent events

Management has evaluated subsequent events through July 18, 2025, which was the date that the financial statements were available to be issued and has determined that there were no events to be reported.

**Note 3 - Fair Value Measurements**

The Plan uses a three-level hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

- Level 1 – quoted prices in active markets for identical assets or liabilities;
- Level 2 – inputs other than level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or
- Level 3 – unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds – these investments are valued daily based on the quoted market value of the fund assets.
- Collective trust – this investment is measured at net asset value (“NAV”). This NAV represents the Plan’s fair value since this is the amount at which the Plan transacts with the trust. The investment can be redeemed daily, has a daily redemption notice period, and has no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the valuation methods are considered appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 - Income Tax Status**

The Plan has adopted a prototype plan document, which obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and is being operated within the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan recognizes in the financial statements the impact of uncertain tax positions taken only if it is more likely than not of being sustained upon examination by the taxing authority based on the technical merits of the position. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
