NOTE 1 – DESCRIPTION OF PLAN

Flight Services International, LLC 401(k) & Profit Sharing Plan (the Plan) is a qualified retirement plan adopted by Flight Services International, LLC (the Company) to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally established by the Company effective May 15, 2012, and was most recently restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the plan's provisions.

Eligibility: Employees (except union employees and certain nonresident aliens) are eligible to participate in the Plan on their date of hire. Employees may enter the Plan on the first day of the month coinciding with or next following the date requirements are satisfied.

Contributions: The Plan has the following contribution options:

- *Participant Contributions* – Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There are two types of elective deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed 90% of a participant's compensation or a dollar limit which is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may defer additional amounts as catch-up contributions. Participants may modify or revoke their salary deferral election at any time.
- *Employer Contributions* – The Company may make a discretionary matching contribution equal to a uniform percentage of a participant's salary deferrals. For 2024, the Company determined the amount of the discretionary percentage to be 50% up to 10% of a participant's salary deferrals.
- *Rollover Contributions* – Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer match contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their deferral contributions, including catch-up contributions and rollover contributions, plus any earnings thereon. Vesting in employer contributions is based on years of service. A participant is 100% vested after three years of credited service.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of the accounts in the Plan if they request one due to their disability, retirement, or termination of employment from the Company. If a participant's vested account balance does not exceed \$1,000, the participant's account balance will be distributed in a lump sum. If a participant's vested account balance exceeds \$1,000, but is less than \$7,000, participants may either elect to receive the distribution in cash or to roll over the distribution to an IRA or other qualified plan of a new employer. If a participant's vested account balance exceeds \$7,000, the participant must consent to any distribution.

Participants who have attained age 59½ may receive an in-service distribution from their vested accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay any administrative expenses or to reduce any employer contributions. At December 31, 2024 and 2023, there were \$-0-, of forfeitures that had not yet been applied. During 2024, forfeitures of \$33,674 were used to reduce employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 21, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Participant Contributions Payable: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Benefits Paid to Participants: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company (AUL), a OneAmerica company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Pooled Separate Accounts: The fair values of participation units held in pooled separate account sub accounts are based on net asset values reported by the fund managers as of the financial statements dates and recent transaction prices. The sub-accounts of the pooled separate accounts hold passive investments in a single mutual fund with investment strategies identified with the name of the pooled separate account. The underlying investment composition of the pooled separate accounts as of December 31, 2024 and 2023, was approximately 83% target date mutual funds, 15% US equity index funds and 2% fixed income securities funds, respectively. Each pooled separate account sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INVESTMENT CONTRACT

The Plan holds a fully-benefit responsive guaranteed investment contract with AUL totaling \$80,807 for 2024 and \$20,522 for 2023. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is reset annually by AUL and is based on a formula defined in the contract, which considers factors such as current interest rates, investment performance, and market conditions. For the years ended December 31, 2024 and 2023, the interest rates credited to participant accounts were 1.25% and 1.75%, respectively.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

NOTE 5 – INVESTMENT CONTRACT (Continued)

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on AUL's ability to meet its financial obligations. AUL's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with AUL. Such events include a full or partial Plan termination, the insolvency of the Company, or aggregate terminations in any contract year exceeding 20% of the full contract value as determined on the first day of that contract year. Under those unlikely events, a surrender charge may apply. The Company believes there are no events that are probable of occurring that might limit the ability of the Plan to transact at contract value with AUL and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow AUL to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of AUL. This is a contingent event, and the Company believes that any events allowing AUL to terminate the contract and settle at a different amount are probable of not occurring.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. AUL serves as the recordkeeper and custodian for the Plan. As such, it manages certain Plan investments, including the fully benefit-responsive investment contract disclosed in Note 5. Therefore, the Plan's payment of fees to AUL for these services qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
