<b>Erisa Plan Year</b>	A plan year is set forth in the plan documents and is 12 months long. Short Plan Years are allowed for valid business reasons, like transitioning to a new plan year. ** The plan year cannot be longer than 12 months.
<b>Report Due Date</b>	All 5500 Reports are <u>always due 7 months after the end of the plan year.</u>
<b>Participant Count</b>	The number of enrolled employees in any ERISA benefit on the specified dates. Employer-paid benefit or the benefit with the highest enrollment. <u>No dependents included.</u> <ul style="list-style-type: none"> <li>● We cannot accept Employee Census Reports or Benefit Invoices in lieu of a hard count.</li> </ul>
<b>COBRA Count</b>	The number of former employees enrolled in COBRA on specified dates. <u>No dependents included.</u> <ul style="list-style-type: none"> <li>● If Higginbotham handles the plan's COBRA Administration, enter Higg for these counts and we will request the count from the COBRA Department.</li> </ul>
<b>ERISA Wrap Document</b>	Employers who offer employee benefit plans are required by ERISA to have a written plan document. Wrap Documents contain specific language to meet ERISA guidelines. Wrap Documents are the instructions on <i>how</i> the plan's 5500 is required to file. <ul style="list-style-type: none"> <li>● Wrap Documents should be updated to reflect a change in renewal dates, addition/removal of benefits, a change in participating employers, or change in how the plan is funded.</li> </ul>
<b>Policy Contract Year</b>	Typically mirrors the ERISA Plan Year, but can be different - with certain contingencies. The end of the contract year must fall during the ERISA Plan Year.
<b>MEWA</b>	Multiple Employer Welfare Arrangement (MEWA) is a group of employers who pool their resources to provide health insurance coverage to their employees. Employers participating in a MEWA are not under common ownership.
<b>MEWA Form M-1</b>	MEWAs are required to complete and submit Form M-1 detailing their benefits operation of and compliance with federal law. Form M-1 is due by March 1st each year (regardless of ERISA plan year) and is usually submitted by the plan sponsor.
<b>MEWA Confirmation Receipt Number</b>	Upon submission of Form M-1, the EBSA will provide a Confirmation Number (located in the upper left corner of the submitted form) and must be included in the 5500 filing.
<b>MEWA Participating Employer List</b>	MEWAs are also required to submit a list of Participating Employers and Participating Employer EINs with their 5500 filing. This information is required.
<b>Authorized Signer</b>	The name and email address of the authorized signer is required for submission of 5500 reports.
<b>Change of Renewal Date</b>	When a plan changes renewal dates it creates a gap between old and new plan years that still requires 5500 reporting. These gaps are addressed with Short Plan Year reports. If not filed SPY reports will carry delinquent penalties. By providing this information, we can make sure there are no missed reports - and no delinquent filings.
<b>Schedules</b>	We must have a Schedule A for each benefit listed in the Wrap Document.
