- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**1. DESCRIPTION OF PLAN**

The following description of The Republic of Tea, Inc. / Rubin Wines, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) plan covering all full-time employees sponsored by The Republic of Tea, Inc. (the "Company") who are at least 21 years of age and completed six consecutive months of service and are not members of a collective bargaining unit. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants are permitted to contribute either pre-tax or after-tax (Roth) deferrals through payroll deductions subject to certain maximum limitations imposed by the Internal Revenue Code (IRC) (\$22,500 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to the maximum limit imposed by the IRC (\$7,500 for 2024). All employee contributions are immediately 100% vested plus actual earnings thereon. The plan provides for rollover contributions to the Plan, which is always 100% vested and non-forfeitable.

The Plan provides for the Company to make profit sharing contributions at the discretion of the Board of Directors. If the Company decides to make a profit-sharing contribution all full-time employees that have at least one year of service, have attained age 21, and are still employed at the end of the year will receive a portion of this contribution. The contribution is allocated to the participant accounts based on the employee's compensation as a percentage of all participant's compensation. All employer profit sharing contributions are 100% vested.

The Company elects on an annual basis whether it will make a 3% nonelective safe harbor contribution. Participants are eligible to receive safe harbor nonelective contributions if they are at least 21 years of age and completed six consecutive months of service. All safe harbor nonelective contributions are 100% vested. For the years ended December 31, 2024 and 2023, the Company has elected to make safe harbor contributions.

All participant's accounts are 100% vested.

**Participants Accounts**

Individual accounts are maintained for each Plan Participant. Each participant's account is credited with the participant's contribution, applicable safe harbor nonelective contributions, allocations of applicable profit-sharing contributions and Plan investment earnings and charged with withdrawals and an allocation of Plan investment losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan through Newport Trust Company, LLC, (Plan Trustee). Participants may change their investment options at any time throughout the year via internet or direct phone access via the recordkeeping system.

**Payment of Benefits**

Distributions are made to participants upon retirement, termination of employment, or total and permanent disability. In the case of death, distributions are made to the participant's beneficiary. Employees are 100% vested in all accounts if the distribution results from disability or death.

**Plan Termination**

Although it has not expressed any interest to do so, the Company has the right under the Plan to terminate the Plan at any time. In the event of termination, the account of each participant shall be fully vested and non-forfeitable as of the effective date of complete termination of the Plan and each participant's contribution account shall be distributed to the participant.

**Plan Amendments**

2024

There were no Plan amendments in the year ending December 31, 2024.

2023

The Plan was amended effective January 1, 2023, to allow that future elective deferrals for participants who are taking a hardship withdrawal will no longer be suspended. With the same amendment, the Plan elected to allow Hardship withdrawals can now include qualified non-elective contributions (QNECs) and qualified matching contributions (QMACs) to the pool of available funds to be withdrawn from.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than generally accepted accounting principles. This basis of accounting differs from GAAP in that, records contributions when they are received and expenses when they are paid instead of when they are receivable or payable. This creates a timing difference in the valuation of benefits payable to participants between the time the contributions are withheld from the employee's paychecks until the time they are deposited into the Plan.

**Investment Valuation and Income Recognition**

Assets of the Plan at December 31, 2024 and 2023 are maintained in Registered Investment Companies (mutual funds) with Newport Trust Company, LLC. The Plan's investments are carried at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices that represent the net asset of shares held by the plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses incurred in the administration of the Plan as well as all fees related to the audit are paid directly by the Company. Refer to Note 6 for further information.

**Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles and the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expense during the reporting period. Accordingly, actual results may differ from those estimates.

**3. FAIR VALUE MEASUREMENTS**

Included in the financial statements are certain financial instruments which are carried at fair value. The fair value of an asset is the amount at which the asset could be bought or sold in a current transaction between willing parties, that is, other than in a forced liquidation sale. The fair value of a liability is the amount at which that liability could be incurred or settled in a current transaction between willing parties, that is, other than in a forced or liquidation sale. FASB ASC 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds Valued at the daily closing price as reported by the fund to reflect the current market price of the fund's securities. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

**5. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, is exempt from Federal income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Newport Trust Company, LLC, maintains the investments and executes investment transactions and allocations. A separate investment manager, RBC Wealth Management, reviews and recommends assets for Plans. Fees are paid for these investment management services. These transactions qualify as exempt party-in-interest transactions. The fees paid by the Company for these services were \$17,276 and \$16,673 for the years ending December 31, 2024 and 2023, respectively.

Ascensus, LLC the parent company of Newport Trust Company, LLC, handles all administrative and record-keeping duties of the plan. They receive fees for these administrative services. There are no transactions within this process that qualify as party-in-interest transactions.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment funds, it is reasonably possible that changes in the value of the investment funds will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**8. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events for potential recognition and disclosure through July 22, 2025, the date the financial statements were issued. No subsequent events necessitating financial statement accrual or disclosure were identified.
