## Independent Auditor's Report

To the Board of Trustees  
Century Arms, Inc. 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Century Arms, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audits). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedule Required by ERISA**

The information included in the supplemental schedule, other than that agreed to, or derived from, the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to, or derived from, the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following brief description of the Century Arms, Inc. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General:** The Plan is a profit sharing plan formed on July 1, 1985, covering all employees of Century International Arms, Inc. and Century Arms, Inc. (the Company) who have completed at least three consecutive months of service, as defined, and reached 21 years of age as of the date the other requirement has been satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute up to 100% of their pretax annual compensation. Participants who have reached age 50 before the end of the Plan year are eligible to make an additional catch-up contribution. In addition, the Plan allows rollover contributions from other qualified plans.

The Company provides a discretionary match that is currently 25% of each participant's first 6% of contributions. Profit sharing contributions may also be contributed at the option of the Company's Board of Trustees. Participants who have not completed 1,000 hours of service and are not employed on the last working day of a Plan year are not eligible for an allocation of profit sharing contributions for such year, except upon retirement, death or disability. There were no profit sharing contributions made in 2024.

Contributions and eligible compensation are subject to certain limitations.

**Participant accounts:** Each participant's account includes the participant's contributions, the Company's discretionary matching contributions, and an allocation of the Company's profit sharing contributions, Plan expenses and Plan earnings. Allocations of the Company's profit sharing contributions, Plan expenses and Plan earnings are based on participant earnings or account balances, as defined by the Plan. Participants direct the investments of their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service, increasing 20% per year until the participant is 100% vested after six years of credited service. Participants automatically become fully vested upon disability or death while under the employment of the Company.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Interest rates range from 3.25% to 8.5% as of December 31, 2024. All loans must be repaid within five years or within 30 years for the purchase of a primary residence. Principal and interest are generally paid ratably through payroll deductions.

#### Note 1. Description of Plan (continued)

**Payment of benefits:** Benefits are distributed under the Plan based on the normal retirement age (65), in-service distributions upon reaching ages 53 (discretionary matching contributions and profit sharing contributions only) and 59½, death, disability, qualified reservist status, or the termination of service. A participant may elect to receive a lump-sum payment or installment payments equal to the vested portion of his or her account. Participants may also request hardship withdrawals upon meeting certain requirements, as defined in the Plan document. Participants may withdraw from their rollover account at any time.

**Forfeitures:** As of December 31, 2024 and 2023, there were no forfeited nonvested accounts available. Any forfeited nonvested amounts are used to reduce employer contributions or pay administrative fees. During 2024, forfeitures of approximately \$7,500 were used to pay administrative fees.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Contributions from Plan participants and the related matching contributions from the employer are recorded in the year the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses of the Plan:** Substantially all expenses of maintaining the Plan are paid by the Company. Certain administrative fees are paid by the Plan. Certain transaction fees are paid by Plan participants.

**Use of estimates:** The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Note 2. Summary of Significant Accounting Policies (continued)

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** Plan management has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by Ascensus, LLC, as Authorized Representative of Ascensus Trust Company

The following is a summary of the Plan's information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus LLC, as authorized representative of Ascensus Trust Company, a qualified institution:

- All investments and notes receivable from participants;
- All investment income and interest income on notes receivable from participants;
- Information regarding investments in Note 4; and
- Information included on Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year).

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

**Level 1:** Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2:** Observable market-based inputs or observable inputs that are corroborated by market data.

**Level 3:** Unobservable inputs for assets or liabilities that are not corroborated by market data.

#### **Note 4. Fair Value Measurements (continued)**

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in the current or prior year.

**Common stocks:** Valued at the closing price reported on the New York Stock Exchange or similar active market and, therefore, are considered Level 1 investments.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, are considered Level 1 investments.

#### **Note 5. Tax Status**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

#### **Note 7. Related-Party Transactions**

ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the qualified institution or an affiliate are considered party-in-interest transactions. Additionally, the Company pays certain administrative fees for the Plan, as described in Note 2.
