INDEPENDENT AUDITOR'S REPORT

To the Participants of the Hull Associates 401(k) Savings Plan
Grand Prairie, Texas

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Hull Associates 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hull Associates 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hull Associates 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 **DESCRIPTION OF PLAN**

The following description of the Hull Associates 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan qualifies as a profit-sharing plan under the Internal Revenue Code (Code) Section 401(a) and as a cash-or-deferred arrangement under Code Section 401(k).

The Plan is a participant-directed defined-contribution plan covering all employees of Hull Associates, LLC, Ameritech Millworks LP, Keystone Distribution LLC., Keystone Lumber LLC, and Hull Associates – North LP, (collectively the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The original effective date of the Plan was January 1, 2002; and the Plan was restated January 1, 2021.

The Plan is a defined contribution plan that covers all employees of the Company who have three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate after three months of service.

Employee contributions

Participants are permitted to contribute up to 90% of their annual compensation to the Plan on a tax-deferred basis. Participants may elect to set up automatic annual increases in deferral rates of 1% per year. Catch-up contributions are permitted. Transfers (rollovers) from qualified plans are allowed under the provisions of the Plan.

Employer contributions

The Company makes safe harbor matching contributions based on 100% of eligible employee contributions up to 3%, plus 50% of eligible employee contributions that exceed 3% but do not exceed 5%.

The Company may also make other employer matching contributions and profit-sharing contributions. These were not made in 2024.

Administrative expenses

Certain expenses, such as participant loan fees and withdrawal charges, are charged to the applicable participant account. The Plan also pays for recordkeeping fees. These are allocated to participants ratably, based on account balances. The Company absorbs the cost of substantially all other administrative expenses.

Note 1 **DESCRIPTION OF PLAN – (continued)**

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of Plan earnings and expenses. Allocations of Plan investment earnings or losses and expenses are based on participants' account balances invested in each fund.

Investments

All investments are participant directed.

Vesting

Participants are fully vested in their employee contributions, safe harbor contributions, rollover accounts, and earnings on those contributions.

The employee's portion of their account balance derived from employer nonelective profit sharing and employer matching contributions not listed above are 20% vested after one year of service with the Company. That increases 20% per year, until they are fully vested after five years of service. In addition, the employer nonelective profit sharing and employer matching balances become fully vested in employer contributions upon the participant's death, reaching retirement age, or upon disability while employed by the Company.

Notes receivable from participants

Participants may receive a loan from their participant accounts. The minimum amount of a loan is \$1,000; the maximum amount is the lesser of: (1) \$50,000 or (2) 50% of their vested account balance. The loan repayment period is a maximum of five years, except for loans made for the purchase of a residence, for which the repayment period must not exceed 20 years.

Participant loans are secured by the participants' vested balance in the plan and bear interest at prime rate plus 2%.

At December 31, 2024, these loans bore interest at rates from 5.25% to 10.5%, were payable in payments to be made at least quarterly, and matured at various dates through December 2029. At December 31, 2023, these loans bore interest at rates from 5.25% to 10.5%, were payable in payments to be made at least quarterly, and matured at various dates through August 2028.

Forfeitures

Forfeitures, which were not material at December 31, 2024 and 2023, may be used to pay administrative expenses or to reduce future employer contributions.

Payment of benefits

Upon termination of service, participants with vested balances of \$5,000 or less receive a distribution of their vested balances, net of tax withholding, in a lump sum. If the amount to be distributed is between \$60 and \$5,000 and the participant does not affirmatively elect to have the distribution rolled into a qualified plan or paid to them (net of tax withholding), the balance is transferred into an individual retirement account set up for their benefit. Otherwise, terminated participants receive a lump-sum amount equal to the value of their vested interest in their account when they elect a distribution of their account balance.

In-service withdrawals of certain vested balances are available to participants in cases of hardship, upon attaining age 59 ½, or upon other allowable circumstances. Also, contributions that were transferred into the Plan from another qualified plan may be transferred out of the Plan to an individual retirement account or another qualified plan.

Other plan provisions

Other Plan provisions including investment options are described in the Plan Document.

Note 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting. This method differs from accounting principles generally accepted in the United States of America since revenues are recorded when received rather than when earned, and expenses are recorded when paid rather than when incurred.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with the modified cash basis requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through July 9, 2025, the date which the financial statements were available to be issued.

Note 3 **TAX STATUS**

The Plan adopted the Nova 401(k) Associates, Inc. Defined Contribution Pre-Approved Plan, Basic Plan Document (the Pre-Approved Plan) effective January 1, 2021. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Pre-Approved Plan, as designed, was in compliance with the applicable requirements of the Code. Therefore, no provisions for income taxes are included in the accompanying financial statements.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by the U.S. Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 4 **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan's sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, affected participants will become fully vested in their employer contributions.

Note 5 **INFORMATION CERTIFIED**

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$12,963,747 and \$10,396,073 at December 31, 2024 and 2023, respectively, notes receivable from participants of \$328,663 and \$250,950, at December 31, 2024 and 2023, respectively, and related investment income of \$1,345,261 for the year ended December 31, 2024.

These accounts are maintained by John Hancock Life Insurance Company (U.S.A.), d/b/a John Hancock, a party-in-interest.

Note 6 **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets or liabilities. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1, Level 2, or Level 3 inputs for the periods presented.

Fair value of investments that calculate NAV

Pooled separate accounts (PSAs) are measured at NAV per share as of December 31, 2024 and 2023. Their fair value is shown in the table above. The PSAs have no unfunded commitments or redemption notice requirements. In exceptional circumstances, PSAs may place trading restrictions on incoming transfers; however, transfers out of a PSA are allowed at any time at the PSA's NAV. PSAs are normally heavily invested in a mutual fund. For example, the JH Multimanager 2030 Lifetime Separate Account is heavily invested in the JH Multimanager 2030 Lifetime Fund (the underlying mutual fund). The PSAs' objectives are to remain heavily invested in the underlying mutual funds, and to mirror their performance as closely as possible.

Note 7 **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 **REPORTABLE TRANSACTIONS**

There were no reportable transactions in 2024.

Note 9 **PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are managed by John Hancock. John Hancock is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.
