Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Uhlig LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Description of Plan

The following description of the Uhlig LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a 401(k) defined contribution plan established January 1, 1997, covering all eligible employees of Uhlig LLC (the “Company”). An employee is eligible to participate in the Plan after completing one year of service, 1,000 hours, and is age 21 or older. Employees may enter the Plan January 1, April 1, July 1, or October 1, following the date that the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has implemented and made effective changes as allowed by the CARES Act including related rules on in-service distributions and participant loans.

On July 22, 2022, the Plan implemented and made effective changes as allowed by the SECURE Act including amending eligibility requirements for long term part-time employees and allowing distributions for qualifying birth or adoptions.

b. Contributions

Employees participating in the Plan may enter into an elective deferral agreement authorizing the employer to withhold a portion of such participant’s compensation to deposit into the Plan. The Company contributes 25% of elective contributions up to 8% of compensation. Contributions are subject to certain IRS limitations.

The Plan includes an auto-enrollment provision, whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation. Each participant directs their own investments among various options made available by the Plan.

c. Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the matching contribution, and allocations of discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan gains and losses and administrative expenses.

1. Description of Plan (Continued)

c. Participant Accounts (Continued)

Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their voluntary salary deferral plus the earnings thereon. Employees are considered fully vested in the case of normal retirement age 65, early retirement age of 55 and 6 years of service, death, or disability. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate published in the Wall Street Journal. Participants may only have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

f. Payment of Benefits

Upon termination of service due to death, normal retirement, disability, and termination of employment, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A distribution from the Plan prior to termination is allowed once a participant is 59 ½ years old. Benefits are recorded when paid.

g. Unallocated Accounts

Under the provisions of the Plan, when certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be utilized to reduce the Company's matching contributions for the Plan year or may be used to pay administrative expenses. Forfeitures totaling \$2,452 were used to reduce employer contributions during the year ended December 31, 2024. No forfeiture balance remained at December 31, 2024 and 2023.

g. Unallocated Accounts (Continued)

In addition, the Plan maintains an ERISA spending account where excess revenue sharing is deposited to be allocated as earnings to participant accounts or used to pay Plan expenses in a future period.

Unallocated accounts totaled \$35 at December 31, 2024 and 2023.

h. Administrative Expenses

The Plan sponsor bears some administrative costs for the Plan, including the costs of officers and employees who perform certain administrative functions.

2. Summary of Significant Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transition between market participants at the measurement date. See Note 3 for discussion of fair value investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

e. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

f. Income Taxes

The Plan's income tax filings are subject to examination by various taxing authorities. The Plan's open examination periods are 2021 and forward.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1), and the lowest priority to unobservable inputs, (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commissions. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed interest account: Valued at contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Common collective trusts: Valued at the net asset value (NAV) of units of the collective investment trust. The NAV is based on the fair value of the underlying investments and is used as a practical expedient to estimate fair value.

4. Investment Contract with Insurance Company

The Plan participates in a collective investment fund for collective investments in contracts issued by insurance companies with Empower Annuity Insurance Company, which maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses.

The Guaranteed Interest Account promises contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. As such, the Guaranteed Interest Account is considered non-benefit responsive and is reported at its fair market value in the Statement of Net Assets Available for Benefits. Significant unobservable inputs include the composite guaranteed rates and the current rates as of December 31, 2024 and 2023.

6. Tax Status

The Plan has adopted a prototype plan document, which obtained its latest opinion letter on November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRS. Although the Plan has been amended since receiving the determination letter, the Company and the plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Risk and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements.

9. Exempt Party-In-Interest Transactions

The Plan's custodian and trustee, Empower Annuity Insurance Company of America, a related party, and Empower Trust Company, LLC, hold the investment assets and executed investment transactions and, therefore, qualify as parties-in-interest to the Plan.

10. Subsequent Events

Subsequent events have been evaluated up to July 23, 2025, the date these financial statements were available to be issued.
