## Independent Auditor's Report

### Opinion

We have audited the accompanying financial statements of California Winery Workers Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net deficit available for benefits as of December 31, 2024 and 2023, the related statements of changes in net (deficit) assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net deficit available for benefits of California Winery Workers Pension Plan as of December 31, 2024 and 2023, and the changes in its net (deficit) assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of California Winery Workers Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about California Winery Workers Pension Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **Note 1 - Description of the Plan**

The following brief description of California Winery Workers Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for more complete description of the Plan's provisions.

**General**

The Plan, a multiemployer defined benefit plan, was established on July 1, 1960, for the purpose of providing pension benefits to eligible participants covered by a collective bargaining agreement between Local Unions Nos. 45 and 186 of the Distillery, Rectifying, Wine and Allied Workers International Union of America and the Winery Employers Association. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board of consisting of equal representation from the participating employers and the Local Union.

**Contributions**

On December 31, 2008 the Plan legally terminated by mass withdrawal of all employers. Withdrawn employers are no longer required under their collective bargaining agreements to contribute to the Plan on behalf of their employees.

Withdrawn employers have been assessed withdrawal liability amounts, as are necessary on an actuarial basis, to provide the Plan with assets to cover the Plan's funding shortfall to the extent permitted by ERISA provisions. Scheduled withdrawal liability payments are expected to continue into the future until all benefit obligations have been met.

The future withdrawal liability payments will not be sufficient to meet all benefit obligations. Starting during the year ended December 31, 2021, the Plan receives funding from the Pension Benefit Guaranty Corporation (PBGC) to continue operations. See Note 7.

**Vesting**

On December 31, 2008, the Plan legally terminated. Upon Plan termination, benefits of the non-vested participants in the Plan were required to vest on that date, to the extent that funds were available to fund those benefits.

## Pension Benefits

Eligibility conditions and benefit amounts payable for the various types of pensions provided by this Plan are based on the accumulation and retention of years of vesting credit and provisions specific to the date the Pension becomes effective. All types of retirement require termination of all employment in the winemaking industry, and in the employer's industry if not winemaking. Benefits are payable under the following conditions: normal retirement at the age of 65 and vested or an early retirement at the age of 55 and vested. To be vested, the participant must have ten years of vesting credit, have five years of vesting credit and attainment of age 55, or for the participants active in 1999 or thereafter, five years of vesting credit. Benefit accruals ceased for each participant under this Plan effective with the date of the withdrawal of the participant's employer during the 2007 or 2008 plan year.

Under the defined benefit plan, effective April 1, 2009, qualified participants are entitled to either normal or early reduced retirement benefits. Additionally, the Plan includes pre-retirement death benefits to the surviving spouse of the deceased participant if the participant dies with a vested interest in the Plan. The pre-retirement death benefits are for the life of surviving spouse and commence any time after the deceased participant would have reached early retirement age.

Effective January 1, 2021, monthly pension benefits to certain participants were reduced, as required in accordance with the PBGC guaranty level. The maximum benefit that the PBGC guarantees is set by law. Under the multiemployer program, the PBGC guarantee equals a participant's years of service multiplied by (1) 100% of the first \$11 of the monthly benefit accrual rate and (2) 75% of the next \$33. The PBGC's maximum guarantee is \$35.75 per month times a participant's years of service.

## Note 2 - Summary of Significant Accounting Policies

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosures of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results may differ from those estimates.

### Assessed Withdrawal Liability Receivable and Allowance for Credit Losses

The Plan's policy is to recognize a receivable at its present value, net of any allowance for credit losses, once a withdrawal liability has been actuarially determined and formally assessed by the Plan. Management of the Plan evaluates employers' withdrawal liability receivable periodically for potential credit losses based on historical experience as well as current and reasonable and supportable forecasted economic conditions. As of December 31, 2024 and 2023, there was no allowance taken.

### **Withdrawal Liability Contributions**

Contributions are recognized when actuarially determined and formally assessed by the Plan.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Expenses**

The Plan's expenses are paid by the Plan as provided in the Plan Document. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net (deficit) assets available for benefits.

### **Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service participants have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries. Benefits under the Plan are accumulated based on participants' wages and hours worked. The accumulated plan benefits for active participants will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to participant service rendered to the valuation date.

### **Subsequent Events**

The Plan has evaluated subsequent events through June 26, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Funding Policy**

#### **Contributions**

On December 31, 2008, the Plan legally terminated by mass withdrawal of all employers. Withdrawn employers have been assessed withdrawal liability amounts on an actuarial basis. Withdrawn employers are no longer required to contribute to the Plan on behalf of their employees.

#### **Pension Protection Act Funding Status**

The Plan has been terminated due to mass withdrawal therefore the Plan is no longer subject to the minimum funding standards required under Section 412 of the Internal Revenue Code (IRC). Accordingly, the funding standards, certification, and notification requirements of IRC Section 432 are also inapplicable to the Plan.

### **Note 4 - Plan Termination**

On December 31, 2008, the Plan legally terminated by mass withdrawal of all employers. It is expected that the Plan will continue to exist to pay current and future pensioners. It will operate on withdrawal liability payments from former contributing employers and funding from the PBGC. Participants no longer accrue any benefits.

The Plan issued a notice of insolvency to PBGC. In connection with this notice, the Plan submitted an application for financial assistance requesting that the PBGC provide supplemental funding for payment of benefits and reasonable administrative expenses incurred by the Plan after the depletion of existing plan assets. The Plan became insolvent effective January 1, 2021.

In July 2021, the Plan and the PBGC executed a promissory note under which the PBGC will provide financial assistance to the Plan on a quarterly basis in the form of a loan. This process is expected to continue on a quarterly basis as the Plan needs financial assistance. The PBGC has the right to demand repayment of the loan or any portion thereof. See Note 7 for details of the note.

Certain benefits under the Plan are insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. The PBGC does not guarantee all types of benefits and the amount of any individual participant's benefit protection is subject to certain limitations. Some benefits may be fully or partially provided for while other benefits may not be provided at all. See Note 1 for the calculation of pension benefits under PBGC guarantees.

**Note 5 - Actuarial Present Value of Accumulated Plan Benefits**

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of December 31, 2023 were (a) life expectancy of participants (the 1994 Group Annuity Mortality Basic Table for Males and Females Projected to 2033 with Projection Scale AA), (b) retirement age assumptions (the earliest retirement-eligible age), (c) investment return (assumed at 0% , net of investment expense), and (d) PBGC discount rates (5.06% for the first 20 years, and 4.37% thereafter).

\* In accordance with ERISA Section 4281, the PBGC discount rates, healthy life mortality table, and disabled life mortality table changed as well as the interest rate increasing from 3.90% to 5.06%.

**Note 6 - Assessed Withdrawal Liability**

The Plan complies with the provisions of the Multiemployer Pension Plan Amendment Act of 1980 (MPPAA), which requires imposition of a withdrawal liability on a participating employer that partially or totally withdraws from the Plan. Under the provisions of MPPAA, a portion of the Plan's unfunded vested liability would be allocated to a withdrawing employer. A withdrawal liability is usually paid in monthly or quarterly installments as determined by a statutory formula over a maximum of 20 years. Had the valuation been performed as of December 31 there would be no material differences. The Plan entered into various settlement agreements with participating employers who withdrew from the Plan and were subject to withdrawal liability assessments. Assessments are due until all obligations of the plan have been funded. The Trustees, at times, approve settlements and payment plan arrangements for assessment amounts owed to the Plan.

During the years ended December 31, 2024 and 2023, the Plan recognized a net decrease in the withdrawal liability estimate receivable of \$1,719,782 and \$18,251,870, respectively, as detailed below.

As of December 31, 2024 and 2023, there were 7 and 8 employers making withdrawal liability payments, respectively. Payments can be made quarterly or annually, and employers are now required to contribute to the Plan until all benefit obligations have been met. The present value for the future stream of payments from those employers as of December 31, 2024 and 2023, is \$8,966,436 and \$10,686,218, respectively, with changes in net present value of payments recorded in the statements of changes in net (deficit) assets. Payments received from withdrawn employers for the year ending December 31, 2024 and 2023, totaled \$495,577 and \$13,392,458, respectively.

**Note 7 - Note Payable – PBGC**

Through December 31, 2024 and 2023, the Plan received loans totaling \$46,868,253 and \$38,533,355, respectively, from the PBGC representing financial assistance to help cover benefit payments and administrative expenses. The loans are evidenced by demand promissory notes for repayment of the principal together with interest at the federal underpayment rate in effect under Section 6621(a)(2) of the IRC. Interest of \$7,169,458 and \$3,295,241 has been accrued through December 31, 2024 and 2023, respectively. The interest is accumulating throughout the receipts of the loan, however, is not being paid by the Plan due to the financial condition. Repayment of the principal amount, plus interest, would be required to commence should the Plan's financial condition improve to such a degree that it has assets beyond those necessary to pay basic benefits. The loans are secured by a security agreement on certain collateral of the Plan.

**Note 8 - Tax Status**

The Plan obtained its latest determination letter on April 22, 2015, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

**Note 9 - Related Party and Party-in-Interest Transactions**

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 10 - Risks and Uncertainties**

The actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
