Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of F.H.C. Employees' Retirement and Security Plan (the "Plan"), an employee benefit plan subject to the Employer Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the F.H.C. Employees' Retirement and Security Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of McLennan County Medical Education and Research Foundation, dba Waco Family Medicine – Institute; Heart of Texas Community Health Center, Inc., dba Waco Family Medicine – Center; and Waco Family Practice Foundation, dba Waco Family Medicine – Foundation (collectively, the "Company" or the "Plan Sponsor").

(b) Contributions

Each year, the Company contributes amounts to the Plan at the discretion of the Company's board of directors. Participants are eligible for Company contributions if they are employed on the last day of the Plan year and they have worked greater than 1,000 hours during the Plan year. The Company makes contributions to the Plan throughout the Plan year, which are allocated during the subsequent Plan year to eligible participants based on participant earnings, as defined by the Plan. Unallocated Company contributions were \$558,861 and \$892,275 at December 31, 2024 and 2023, respectively.

(c) Participant Accounts

Each participant's account is credited with an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Contributions are vested to the participant based on years of continuous service. Effective January 1, 2015, a year of credited service for vesting purposes is 500 hours. Prior to December 31, 2014, a year of credited service was 1,000 hours. For participants employed on or after January 1, 2007, participants are vested 20% after two full years of service, and 20% each year thereafter, until full vesting occurs with six years of credited service.

F.H.C. Employees' Retirement and Security Plan

Notes to Financial Statements (Continued)

(1) Description of the Plan (continued)

(d) Vesting (continued)

For participants employed prior to January 1, 2007 and for employer contributions made on or after January 1, 2007, participants are 20% vested after two full years of service, 40% after three years, 60% after four years, and become fully vested after five years of credited service. For employer contributions made prior to January 1, 2007, participants become fully vested after 5 years of credited service. Full vesting also occurs upon death, total disability, or attainment of retirement age.

(e) Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or various installment options over extended periods of time.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of the valuation of the investment contract with an insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

Notes to Financial Statements (Continued)

(2) Summary of Significant Accounting Policies (continued)

(d) Administrative Expenses

The Plan document allows for the expenses of maintaining the Plan to be satisfied directly out of the Plan's assets. A portion of the administrative expenses of the Plan is paid by the Company. Also, certain transaction charges are paid by the participants involved.

(e) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(f) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Investment Contract with an Insurance Company

The Plan maintains a group annuity investment contract with Standard Insurance Company ("Standard"). Standard maintains all assets of the group annuity investment contract in pooled separate accounts and an unallocated investment contract.

The following methods and assumptions were used to report the values of the investment contract with an insurance company:

The pooled separate accounts are valued using the net asset value ("NAV") of the units as determined by Standard. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that Standard would sell the underlying investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the group annuity contract with Standard, Standard reserves the right to require 60 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

The unallocated investment contract under the group annuity contract with Standard (the Guaranteed Interest Fund) meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Guaranteed Interest Fund guarantees a credited rate of return that is adjusted quarterly based on current market conditions and performance of the fund's investments, but may not be less than 3%.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is set quarterly by the issuer and is effective on the first day of the quarter. The Plan must provide a 30-day advance notice of its intent to withdraw from the investment. If the Plan ends its participation in the Guaranteed Interest Fund, it will receive contract value as surrender value. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs) that cause a significant withdrawal from the plan, or (c) the failure of the insurance contract to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

F.H.C. Employees' Retirement and Security PlanNotes to Financial Statements
(Continued)(4) Information Certified by the Custodian

For 2024 and 2023, the financial information included in the Plan's financial statements, except for amounts payable to the Plan Sponsor, employer's contributions, benefits paid to participants and administrative expenses, has been derived from information certified as complete and accurate by Standard Insurance Company, the custodian of the Plan, in accordance with Section 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

(5) Amounts Due to Plan Sponsor

During 2024, the Plan Sponsor provided Standard with pre-funding of the potential plan contribution, which was to be held in a company account until the annual discretionary employer contribution was finalized and approved. The Plan Sponsor never authorized nor understood that these amounts were being deposited into a plan account, which resulted in a "mistake in fact" as outlined under the Plan Document. Under the terms of the Plan Document, amounts may be returned to the Plan Sponsor if there was a "mistake in fact"; thus, excess amounts pre-funded (including appropriate earnings during 2024) of \$628,249 are reported as a liability of the Plan at December 31, 2024.

(6) Components of Net Assets Available for Benefits

Net assets available for benefits include certain forfeited nonvested amounts of former participants. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$172,805 and \$130,867, respectively. These amounts will be reallocated to participants in the same manner as employer contributions. Forfeitures were not reallocated during 2024. Forfeitures of terminated nonvested account balances reallocated to remaining participants during the year ended December 31, 2023 totaled \$43,692.

(7) Tax Status

The Plan is using a volume submitter profit-sharing plan document. In a letter dated June 30, 2020, the Internal Revenue Service ("IRS") indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code section 401(a). Although the Plan has been amended since receiving the acceptability letter, the plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Notes to Financial Statements (Continued)

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

(9) Party-In-Interest Transactions

As more fully described in Note 3, the Plan invests in a group annuity investment contract with Standard. Standard is the custodian, as defined by the Plan, and qualifies as a party-in-interest. Fees paid by the Plan for the investment management services to Standard amounted to \$13,105 and \$13,630 for 2024 and 2023, respectively.

The Plan has not considered Company contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions.

The Plan invests in a group annuity investment contract with various investments underlying the contract. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(12) Subsequent Events

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits through July 23, 2025, the date at which the financial statements were available to be issued, and determined there are no items to disclose.
