### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Family Health Center 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employer Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the Family Health Center 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering substantially all employees of McLennan County Medical Education and Research Foundation dba Waco Family Medicine – Institute; Heart of Texas Community Health Center, Inc., dba Waco Family Medicine – Center; and Waco Family Practice Foundation, dba Waco Family Medicine – Foundation (collectively, the “Company” or the “Plan Sponsor”).

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”) was signed into law, which included provisions related to retirement plans. The Plan adopted the optional provisions under the CARES Act related to distributions as further discussed below.

#### (b) Contributions

Each year, participants may contribute up to the maximum amount allowable as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may direct contributions in percentage increments to any one of thirty investment options. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### (c) Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(Continued)(1) Description of the Plan (continued)(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

(e) Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or various installment options over extended periods of time.

The Plan adopted the provision under the CARES Act to allow certain eligible participants to take coronavirus-related distributions up to \$100,000 from their vested account balance without penalty. Further, these participants may repay the amount withdrawn to an eligible retirement plan within three years from the date of distribution and such repayments are not subject to retirement plan contribution limits and are not taxable. For coronavirus-related distributions not repaid, taxes on these withdrawals may be paid over a three-year period beginning with tax year 2020.

(2) Summary of Significant Accounting Policies(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of investments held by the Plan and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Administrative Expenses

The plan document allows for the expenses of maintaining the Plan to be satisfied directly out of the Plan's assets. A portion of the administrative expenses of the Plan is paid by the Company. Also, certain transaction charges are paid by the participants involved.

(e) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(f) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(g) Reclassifications

Certain reclassifications have been made to the accompanying 2023 financial statements to make them comparable to the current year.

#### (3) Investments and Fair Value Measurements

The Plan invests in mutual funds and an unallocated investment contract with Standard Insurance Company (“Standard”). The following table presents the reported values of the underlying investments, all of which are participant-directed:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The following methods and assumptions were used to estimate the fair value of the mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U. S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following methods and assumptions were used to report the values of the investment contract with an insurance company:

The unallocated investment contract with Standard (the Standard Stable Asset Fund or "SAF") meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The SAF guarantees a credited rate of return that is adjusted quarterly based on current market conditions and performance of the fund's investments, but may not be less than 1%.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is set quarterly by the issuer and is effective on the first day of the quarter. The Plan must provide a 30-day advance notice of its intent to withdraw from the investment. If the Plan ends its participation in the SAF, it will receive the Plan's fair value as surrender value. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs) that cause a significant withdrawal from the plan, or (c) the failure of the SAF to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(Continued)(4) Information Certified by the Custodian

For 2024 and 2023, the financial information included in the Plan's financial statements, except for contributions, benefits paid to participants and administrative expenses, has been derived from information certified as complete and accurate by Reliance Trust Company, the custodian of the Plan, in accordance with Section 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(5) Tax Status

The Plan is using a volume submitter 403(b) plan document. In a letter dated March 31, 2017, the Internal Revenue Service ("IRS") indicated the standardized form of the Plan is acceptable under section 403(b) of the Internal Revenue Code ("IRC"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or a determination as to whether the Plan qualifies under Code section 403(b). Although the Plan has been amended since receiving the acceptability letter, the plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(7) Party-In-Interest Transactions

As more fully described in Note 3, the Plan invests in an unallocated investment contract with Standard Insurance Company ("Standard"). Standard is the third-party administrator, as defined by the Plan, and qualifies as a party-in-interest. Fees paid by the Plan for investment management services to Standard amounted to \$107,669 and \$98,711 for 2024 and 2023, respectively.

The Plan has not considered contributions to the Plan or benefits paid by the Plan to participants as party-in-interest transactions.

(Continued)(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits through July 23, 2025, the date at which the financial statements were available to be issued, and determined that there are no items to disclose.
