We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. The Plan and Its Significant Accounting Policies

The following description of the Bechtel Trust & Thrift Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Bechtel Global Corporation, its respective subsidiaries, or affiliated companies (the “Company,” “Companies,” or “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants are eligible to enroll in the Plan upon commencement of employment with the Company.

Administration and Master Trust

Per the Bechtel Trust & Thrift Plan Document, the Bechtel Trust & Thrift Plan Committee (the “Committee”) manages the operation and administration of the Plan. The Committee contracted with The Northern Trust Company (“Trustee”) as trustee for the years ended December 31, 2024 and 2023. The Committee has contracted with Empower Plan Services, LLC (“Record Keeper”) to process and maintain the records of participant data during the years ended December 31, 2024 and 2023.

The Plan’s investments are held in the Master Trust for Certain Tax-Qualified Bechtel Retirement Plans (the “Master Trust”). The assets of the Master Trust are held by the Trustee. Net investment income and administrative expenses of the Master Trust were allocated 100 percent to the Plan as the Plan is the only participating plan in the Master Trust throughout 2024.

Use of Estimates

The preparation of the Plan’s financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the Plan’s interest in the Master Trust is based on the specific interest the Plan has in the fair value of the underlying participant-directed investment options.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

Net investment income or loss, as earned, together with realized and unrealized gains and losses, are allocated daily to participants based on their account balances and their investment fund options.

1. The Plan and Its Significant Accounting Policies, continued

Investment Valuation and Income Recognition, continued

The net appreciation in the value of the investments of the Master Trust, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments, is included in the Plan interest in investment gain of the Master Trust presented in the Statement of Changes in Net Assets Available for Benefits.

Notes Receivable from Participants

Notes receivable from participants (“notes receivable”) are measured at their unpaid principal balance plus any accrued but unpaid interest with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances.

Payment of Benefits

Benefits are recorded when paid by the Record Keeper.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of the Plan are included in administrative expenses. Investment advisory and certain participant transaction fees are charged directly to the participant’s account and are included in administrative expenses. Investment related and certain other expenses are paid out of the Master Trust and are included in the Master Trust’s net investment gain or loss.

Income Taxes

The Internal Revenue Service has determined and informed the Sponsor by a letter dated May 10, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

In accordance with guidance on accounting for uncertainty in income taxes (Accounting Standards Codification (“ASC”) 740-10), management evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to federal and Virginia income tax examinations for years prior to 2021 and to California income tax examinations for years prior to 2020.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rates, market, and credit risks. The Plan also faced the risk of increased market volatility due to global events. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the values of such investments, participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

2. Participation and Benefits

Participant Contributions

Participants may contribute between 1 and 85 percent of their eligible pre-tax or after-tax compensation, as defined in the Plan. Participants who contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participants' direction.

Participants may also contribute rollover distributions from other qualified retirement plans at any time prior to full distribution of the Plan account. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer Contributions

Participants are eligible for contributions from the Company in the first full payroll period following their completion of one year of service. In 2024, the Companies contributed, in the form of a matching contribution, an amount equal to 100 percent of each participant's eligible contribution, up to the first 6 percent of eligible compensation for participants defined as non-Project Hires. Additional amounts may be contributed at the option of the Board of Directors ("the Board") of the Company, including profit sharing contributions. For 2024, the Board approved a profit-sharing contribution to the Plan equal to 3 percent of eligible compensation for participants defined as non-Project Hires, subject to annual contribution limitations. Employer contributions are made by the appropriate participating Companies.

2. Participation and Benefits, continued

Vesting

Participants are 100 percent vested in their account, including employer contributions.

Participants Accounts

Each participant account is credited with the participant's contributions and the participant's share of the Companies' matching and discretionary contributions and Plan earnings. Allocation of the Companies' contribution is based on participant contributions or eligible employee compensation, as defined in the Plan. Upon enrollment in the Plan, participants may direct their contributions into one or more of the investment fund options available to Plan participants. Participants who fail to make an investment election will be defaulted to the Professional Management Program, the Plan's Qualified Default Investment Alternative (QDIA).

Distributions to Participants

The Plan allows for withdrawals while working for the Companies. Eligible withdrawals include pre-age 59 1/2 withdrawals from after-tax sources, post-age 59 1/2 withdrawals from all sources, qualified birth and adoption distributions, and hardship withdrawals on account of heavy and immediate financial need as defined in the IRC. Upon termination, retirement, death, or disability, the participant or beneficiary may elect to leave their account balance in the Plan, receive a single-lump sum amount equal to the value of funds allocated to the participant's account, receive partial withdrawals or installment payments of the participant's account, or roll over the account balance to an Individual Retirement Account or another qualified retirement plan. The Plan allows for the automatic lump sum distribution of participant vested account balances that do not exceed \$1,000.

Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the participant's vested balance. Such notes receivable bear interest in the available market financing rates and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable is established by the Committee.

3. Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted market prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets held by the Master Trust and the Plan measured at fair value. There have been no changes in the methodologies used during 2024 or 2023.

- Cash and cash equivalents include cash positions and foreign currency positions. Fair value is estimated to approximate the cost basis of the balance, based upon the liquidity of the account.
- Commercial paper and certificates of deposit are valued using a market-based approach and are carried at amortized cost, which approximates fair value.
- Corporate securities and repurchase agreements are valued using a market-based approach and are carried at amortized cost, which approximates fair value.
- Common stocks listed on an exchange are valued at the closing prices on the last business day of the year.

3. Fair Value Measurements, continued

- Real estate investment trusts are valued at the closing prices on the last business day of the year.
- Bonds, notes, convertible debt securities, and U.S. government and agency securities are valued using a market-based approach, making use of dealer quotes and considers yield and market risk.
- Collective trust funds are valued at net asset value, which is a practical expedient used to estimate fair value and is based on the fair value of the underlying investments held by such funds. There are no redemption restrictions on any of the collective trust funds. The objective of the short-term investment fund is to provide safety of principal, daily liquidity, and a competitive yield over the long term.
- Mutual funds are valued at the closing prices on the last business day of the year.
- Loans secured by mortgages are valued using available primary/secondary market information and consider interest-rate movements, new issue information, spread, volatility, and other pertinent data.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in the Master Trust are set forth by level within the fair value hierarchy and are presented in separate tables (see Note 5) at fair value as of December 31, 2024 and 2023.

4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including interest in Master Trust and notes receivable from participants held at December 31, 2024 and 2023, and Plan interest in investment gain of Master Trust and interest from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Northern Trust Company (the trustee of the Plan).

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan provides that each participant's account will be distributed in a single sum.

7. Party-in-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain investments of the Master Trust were managed by an affiliate of The Northern Trust Company in 2024 and 2023. These transactions qualify as exempt party-in-interest transactions. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Participant loans are also considered party-in-interest transactions.

For the year ended December 31, 2024, administrative fees attributable to the Plan were paid by the Master Trust to the following related parties:

The Master Trust and the Plan also pay administrative fees to various other parties-in-interest such as the Trustee, investment managers, the recordkeeper, auditor, and attorneys.
