**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the PANTHERx Specialty, LLC 401(k) Plan (the “Plan”) provides only general information. More complete information regarding the Plan provisions may be found in the Plan document.

***General***

The Plan was formed effective September 1, 2022 and is a single-employer, defined contribution plan established by PANTHERx Specialty, LLC (the “Company” or “Plan Sponsor”) covering substantially all employees of the Company. The Board of Directors of the Company (the “Plan Administrator”) controls and monitors the operation and administration of the Plan. Empower Trust Company, LLC serves as the trustee of the Plan. The Plan provides for participant-directed investments and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***Eligibility***

Employees become eligible to participate in the Plan after completing one month of service and attaining age 21. The Plan excludes leased employees, employees who are represented by a collective bargaining agreement, employees who are compensated on a commission-only basis, employees who became employees as a result of a Code Section 410(b)(6)(C) transaction, and part-time, temporary, or seasonal employees.

***Contributions***

Each year, participants may contribute up to 85% of their pre-tax annual compensation, as defined. Participants are allowed to make Roth contributions to the Plan. Contributions are limited to the maximum amount allowable under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for an auto-enrollment feature whereas newly eligible participants are automatically enrolled into the Plan with a pre-tax deferral rate of 3% unless they formally opt out.

The Company contributes a matching contribution equal to 100% of a participant’s contributions that are not in excess of 3% of the participant’s eligible compensation, plus 50% of the amount of the participant’s contributions that exceed 3% but not in excess of 5% of the participant’s eligible compensation. Additionally, the Company may, at its discretion, make profit sharing contributions in an amount as the Board of Directors may determine. No profit sharing contributions have been made since inception.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s and Company’s matching contributions, and an allocation of Plan earnings and is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their account balance into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles.

***Vesting Provisions***

Participants are immediately vested in all contributions and earnings thereon.

***Notes Receivable from Participants***

Subject to approval of the Plan administrator, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Loans must be repaid with interest within five years from the date of the loan. If the loan is for the purpose of acquiring the participant's principal residence, the loan must be repaid with interest within 10 years.

***Payment of Benefits***

On termination of service due to death, disability or retirement of a participant, the participant (or participant's beneficiary) is entitled to the participant's vested account balance. A participant or a participant's beneficiary may elect to receive a lump-sum cash payment or rollover funds to an individual retirement account or another qualified plan. If a participant's vested account balance is not greater than \$5,000, the participant will receive a distribution of the value of the entire vested portion of such account balance as soon as administratively practicable. If the participant's vested account balance is greater than \$5,000, the participant may elect to leave their account in the Plan but will be required to begin distributions when the participant attains age 73 per IRC guidelines. The Plan does not allow for distributions on account of hardship.

Effective March 15, 2023, the Plan was amended to allow for in-service distributions upon the participant's attainment of age 59½. The participant may direct the Company to distribute the lesser of \$5,000 or the participant's entire account.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of plan assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

***Deferred Participant and Employer Contributions***

Deferred contributions includes participant contributions totaling \$111,689 and related employer matching contributions totaling \$67,558 related to a January 2025 pay period that was remitted in advance during 2024.

***Investments Valuation and Income Recognition***

The Plan's investments are reported at fair value except for investments that are considered fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement date basis. Interest and dividend income is recorded upon receipt. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis from those mutual funds and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - CERTIFIED INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL)'s Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the certifying entities of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, investments at contract value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) No. 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to unobservable inputs (Level III measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level I - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund* - The collective trust fund is valued at NAV per share or its equivalent of the fund, which is based on the fair value of the fund’s underlying assets. There are no redemption restrictions or unfunded commitments on this investment. The collective trust has a daily redemption frequency.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan invests in the Empower Investments Fixed Account Series Class I and Class III funds which is a fully benefit-responsive investment contract and, therefore, is measured at contract value. Contract value is the relevant measure for fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Certain events can limit the ability of the Plan to transact at contract value with the contract issuer. Such events include, but are not limited to, complete or partial termination of the Plan or merger with another plan, divestitures of a subsidiary that cause a significant withdrawal from the Plan, or failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Investment contracts generally impose conditions on the Plan. If an event of default occurs and is not cured, the issuer may terminate the contract. These events may include a breach of material obligation under the contract or a material amendment to the Plan agreement that is not approved and accepted by the issuer. These events may limit the ability of the plan to transact at contract value. Plan management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable.

**NOTE 6 - TAX STATUS**

The Plan has adopted a pre-approved plan that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. The Plan has been amended subsequent to the version of the pre-approved plan that received the opinion letter. The Company believes that the Plan is operating in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan Sponsor has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan's fixed annuity investment option is managed by the Trustee. Payments for services provided by the Trustee qualify as party-in-interest-transactions. Notes receivable from participants are also considered party-in-interest transactions.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 24, 2025 the date the financial statements were available to be issued and has determined that there were no subsequent events that have occurred through the date of the report to recognize or disclose in these financial statements.
