## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of Screen-It Graphics

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Screen-It Graphics of Lawrence 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**1. DESCRIPTION OF THE PLAN**

The following description of the Screen-It Graphics of Lawrence 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan that covers substantially all employees of Screen-It Graphics of Lawrence, Inc. d/b/a Grandstand (the “Company”). The Plan was established on January 1, 2014. Effective January 1, 2022, the Plan was amended and restated to adopt the Third Cycle Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

Reliance Trust Company serves as the Plan’s trustee and custodian. The Participant recordkeeper is ADP Retirement Plan Services.

**Eligibility** – Participants are eligible to participate in the Plan after completing 2 months of service. Upon meeting eligibility requirements, employees will be automatically enrolled in the Plan at a pre-tax deferral rate of 3%, unless an alternative election is made by the participant. An employee enters the Plan on the first day of the month coinciding with or the next month following the date the eligibility requirements are satisfied. Participants that have been automatically enrolled in the Plan will have their pre-tax deferral rate increased 1% each year, up to a maximum of 6%, unless an alternative election is made by the participant. The automatic escalation is effective on the first day of the second Plan year following eligibility. The Plan excludes part-time, temporary and seasonal employees, defined as those employees regularly scheduled less than 1,000 hours, and interns.

**Contributions** – Participants may contribute up to 90% of annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Employees who are over 50 years old may elect to make catch up contributions. Participants may designate a portion or all of their contributions as Roth contributions.

The Company makes QACA matching contributions each payroll. For 2024, the Company matched 100% of a participant’s deferral amount, up to a maximum of 3% of compensation and 50% on the next 2% deferred to the Plan.

The Company may also make discretionary non-elective contributions to the plan. To be eligible to receive the non-elective contribution, a participant must be employed on the last day of the Plan year and have 500 hours of service. During 2024, no discretionary non-elective contribution was declared.

**Participant Accounts** – Each participant’s account is credited with the participant’s and the Company’s contributions, an allocation of the investments’ earnings or losses, and is charged with the participant’s withdrawals and distributions, and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments** – Upon enrollment in the Plan, participants direct contributions to the available investment options, which consist of various mutual funds and common/collective trust funds.

**Vesting** – Participant contributions and traditional safe harbor matching contributions (made prior to 2019), and earnings thereon, are at all times fully vested and nonforfeitable. Vesting in employer

QACA matching contributions and non-elective contributions is based on years of continuous service. A participant becomes 100% vested in QACA matching contributions after 2 years of service. A participant becomes 100% vested in non-elective contributions after 3 years of service.

**Forfeitures** – Forfeitures of terminated participant's nonvested accounts are used to reduce employer contributions. In 2024, forfeitures of \$11,507 were used to reduce the QACA match contribution. As of December 31, 2024 and 2023, there was \$0 and \$2,816 of forfeitures available, respectively.

**CARES Act** – In March 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was enacted to provide expanded access to retirement plan accounts during the COVID-19 pandemic. The CARES Act contained several provisions that temporarily impacted 401(k) plans, such as, the waiver of required minimum distributions, a new COVID-19-related hardship withdrawal option, increased loan limits, and a loan repayment deferral option. The Company incorporated these provisions into the Plan. These temporary CARES Act provisions expired at the end of 2020. The Plan has been amended to reflect these changes.

**Payment of Benefits** – Upon termination of service, a participant may elect to receive a lump-sum amount equal to vested account balances. For distributions greater than \$1,000 but not exceeding \$5,000, the account balance will be rolled over into an individual retirement account, unless otherwise directed by the participant.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

**Notes Receivable from Participants** – Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and, effective January 1, 2022, bear interest at the *Wall Street Journal* prime rate plus 1%. Loans issued prior to January 1, 2022, were issued at prime plus 2%. Loans may be repaid over a term of no more than 5 years, unless the loan is for the purchase of a primary residence in which case the loan term can be up to 30 years. Loans are repaid ratably through payroll deductions. Participants may have only one loan outstanding at a time. Participants are charged a \$125 setup fee when initiating a loan.

**Administrative Expenses** – Administrative expenses of the Plan may be paid by either the Company or the Plan. Administrative fees are generally paid indirectly and are deducted from investment earnings. Certain participant related fees such as distribution and loan fees are deducted directly from participant accounts.

**Termination of the Plan** – Although it has not expressed any interest in terminating the Plan, the Company may terminate the Plan at any time, whereupon Plan assets, net of expenses and liabilities, will be distributed based on each participant's assets in the Plan. In the event of Plan termination, the accounts of all participants will become fully vested.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

**Contributions** – Contributions are recognized in the year service is rendered by the Participant.

**Payment of Benefits** – Benefit payments are recognized upon distribution.

**Date of Management’s Review** – Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

## 3. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the closing price (NAV) reported on the active market on which the individual securities are traded.

Common/collective trust funds – Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided to the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of its underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. RISKS AND UNCERTAINTIES**

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **5. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest and dividend income
- Notes receivable from participants and related interest
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **6. TAX STATUS**

The Company adopted a Prototype Non-Standardized Profit-Sharing Plan with a deferral arrangement which received a favorable opinion letter from the IRS on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid certain fees to ADP, Inc., a related party to ADP Retirement Plan Services, to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

**8. SUBSEQUENT EVENTS**

Effective January 1, 2025, an amendment to the Plan increased the mandatory force out amount from \$5,000 to \$7,000. This amendment brings the Plan into compliance with the Secure 2.0 Act.
