### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of QA1 Precision Products Inc 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



**NOTE 1 DESCRIPTION OF PLAN**

The following description of QA1 Precision Products Inc 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established August 1, 1997 and has been amended throughout the years to comply with tax legislation. The Plan was restated effective January 1, 2023 in conjunction with a change in service providers. The plan was most recently amended subsequent to year-end on April 1, 2025. Plan covers employees of QA1 Precision Products, Inc. (Employer) and Detroit Speed and Engineering (effective January 1, 2025). The Plan excludes union employees and nonresident aliens with no U.S. source income. The Plan is subject to ERISA. The 401(k) Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**

Employees are eligible to participate in the salary reduction arrangement in the Plan and receive Employer contributions upon completing six months of service and attaining age 21. Entry dates are quarterly.

Starting April 1, 2025, employees are eligible to participate in the salary reduction arrangement in the Plan and receive Employer contributions upon completing three months of service and attaining age 21. Entry dates are quarterly.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. To be eligible for profit sharing components the employee must be employed by the Company on the last day of the Plan year.

The Employer will make a safe harbor matching contribution to the Plan. For the year ended December 31, 2024, the Employer safe harbor matching contribution was 100% of the first 3% of compensation deferred, plus 50% of deferrals that exceed 3% but do not exceed 5% of compensation deferred. The Employer may make a discretionary profit sharing contribution. In order for a participant to receive an allocation of profit sharing contributions, they must be employed on the last day of the Plan year. There were no profit sharing contributions authorized for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions, the Employer's safe harbor matching contributions, the Employer's discretionary profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their deferral and safe harbor matching contributions plus actual earnings thereon. Vesting in the Employer's profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service using a graded vesting schedule. A participant is 100% vested after the completion of six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Principal and interest is paid ratably through payroll deductions. The notes must be repaid within five years unless the loan is for purchase of a primary residence.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, a participant may receive the value of the vested interest in their account in the form of a lump sum distribution, installments, partial payments, or an annuity. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance was never greater than \$5,000, the Plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name without the participant's consent.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to reduce administrative expenses or used to reduce future Employer contributions. There was no forfeited nonvested accounts as of December 31, 2024 and 2023. Forfeitures used to reduce Employer matching contributions was \$18,468 for the year ended December 31, 2024. There were no forfeitures used to pay administrative expenses for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account. Certain expenses incurred in connection with the general administration of the Plan are offset with revenue sharing credits and are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Subsequent Events**

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Reliance Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with certification as to the completeness and accuracy of the notes receivable from participants and related interest income, and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at year-end) as of December 31, 2024.

Mid Atlantic Trust, the qualified institution of the Plan, has supplied the Plan administrator with certification as to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statement of net assets available for benefits through April 2023.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their Employer accounts.

**NOTE 7 PLAN TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Paychex, Inc. was the recordkeeper of the Plan and Mid Atlantic Trust Company was the trustee and custodian of the Plan, as defined by the Plan, through January 1, 2023. Effective January 1, 2023, recordkeeping and Plan investments were managed by Automatic Data Processing (ADP). Residual assets were transferred to ADP in April 2023. Therefore, these investment transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempted from the prohibited transaction rules of ERISA.
