Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Matrix Adhesives Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Matrix Adhesives Group 401(k) Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. DECEMBER 31, 2024 AND 2023

NOTE 1 PLAN DESCRIPTION

The following description of Matrix Adhesives Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all U.S. employees of Matrix Adhesives Group, LLC and its subsidiaries (the Company) who are not covered under a collective bargaining agreement. The Company is the plan sponsor and administrator that controls and manages the operation and administration of the Plan. The Plan's investments are held by Ascensus Trust Company, the Plan trustee.

An employee becomes eligible to participate in the plan if they are at least (21) years of age and have completed at least 3 months of service (defined as 250 hours).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants can elect pre-tax or Roth deferrals of their compensation subject to certain Internal Revenue Code (IRC) limitations. The Plan also permits rollover contributions of retirement benefits received from other qualified plans. In addition, those participants who are age 50 or older may make catch-up contributions.

The Company has elected to make Safe Harbor Matching Contributions to the plan. The Company matches 100% of participant contributions, up to 3% of the participant's eligible compensation and 50% of a participant's contribution up to 5% of the participant's eligible compensation, including catchup contributions.

The Company may make discretionary profit sharing contributions. No discretionary profit sharing contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's Safe Harbor matching contributions and allocations of plan earnings, and is charged with withdrawals and an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions, actual earnings thereon, and any contributions made on their behalf into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant vests 20% per year and is 100% vested after six years of credited service.

Notes Receivable from Participants

Loans are not permitted under the Plan.

Payment of Benefits

Distributions from the Plan may be made in cash upon termination of employment or may be deferred until the participant's normal retirement age. Retiring participants may elect benefit distribution in a lump-sum payment amount equal to the value of his or her vested account. Required minimum distributions may also elect cash installments over the life of the participant and a designated beneficiary. If an account balance is below \$1,000 at the time of termination, the employee will automatically receive a lump-sum payment. If an account balance is greater than \$1,000 but less than \$5,000 at the time of termination, the Plan has the option of rolling the vested balance over to another qualified retirement account or receiving a lump-sum payment. A participant may also request a withdrawal from their account based upon financial hardship or at age 59½, as defined by IRC regulations.

Forfeitures

Forfeited amounts may be used to reduce future contributions made by the employer or to reduce administrative expenses. Forfeitures of approximately \$40,159 were used to reduce employer contributions during 2024. Forfeited non-vested account balances totaled approximately \$2,011 and \$39,009 at December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan, as provided by the plan document. Fees related to the administration of benefit payments from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are public investment vehicles valued using the net asset value provided by the administrator of the fund on the last day of the Plan's

year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Money Market Funds: Money market funds are valued at cost, which approximates fair value, and classified within Level 1 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 CERTIFIED FINANCIAL INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their account balances.

NOTE 6 TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Ascensus LLC which had received an opinion letter dated June 30, 2020, from the IRS which stated the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated to Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments in cash and certain mutual funds are sponsored and advised by Ascensus Trust. Ascensus provides investment advisory and management services of such funds. Ascensus is the recordkeeper and trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for custodian and recordkeeping services as well as investment management services amounted to \$2,145 for the year ended December 31, 2024. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

NOTE 9 DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2023, the plan failed to timely remit contributions to the plan. The contributions and lost earnings were remitted to the plan in March 2024 in the amount of \$2,519.

During the year ended December 31, 2024, the plan failed to timely remit contributions to the plan. The contributions and lost earnings relating to the plan year ended December 31, 2024 amounted to \$18,418. In March 2024, \$2,439 of contributions and lost earnings related to the plan year ended December 31, 2024 were remitted to the plan. In April 2025, \$15,979 of contributions and lost earnings related to the plan year ended December 31, 2024 were remitted to the plan.

NOTE 10 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 18, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
