INDEPENDENT AUDITOR'S REPORT

To the 401(k) Committee of
Howard Energy Partners 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Howard Energy Partners 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical

requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Plan Description

The following description of the Howard Energy Partners 401(k) Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, refer to the Plan document.

General

HEP Services LLC (the “Company”) is the Plan sponsor. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan has adopted a prototype plan from an entity related to Fidelity Management Trust Company (“Fidelity”). Fidelity is the trustee of the Plan with affiliates of Fidelity being the recordkeeper and third-party administrator.

The Plan covers all employees of the Company except those who are covered by a collective bargaining agreement, participants of the Company’s internship program or non-resident aliens with no U.S. source income. Eligible employees who have attained the age of 18 and have completed three months of continuous service may enter the Plan on the first day of the following month. The Plan is participant directed and participants may change their contribution rates or revoke their deferral election at the beginning of each payroll period or prior to the end of the payroll period. Participants may change investment options at any time.

On December 29, 2022, the SECURE 2.0 Act was signed into law to enhance the retirement savings system. Principle areas of the act addressed automatic enrollment, required minimum distributions (RMD), and catch-up contributions. There are provisions which are currently part of the Plan design, including the provisions for automatic enrollment and the RMD provisions required for 2024, which have been adopted by the Plan. All provisions of SECURE 2.0 Act with effective dates after December 31, 2024, and beyond will be evaluated and implemented in accordance with future regulations and guidance.

Contributions

Participants may elect to make deferral contributions, on either a tax-deferred or Roth after-tax basis, to the Plan up to 100% of eligible compensation subject to the maximum amount allowed by law. Effective February 16, 2024, the Plan allows participants to make additional after-tax contributions beyond the standard deferral limits, subject to applicable Internal Revenue Service (“IRS”) rules. Participants who have or will attain the age of 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for participants in a former employer’s qualified plan to contribute direct rollovers to the Plan. The Company automatically enrolls employees who meet the eligibility requirements in the Plan, unless the employee declines participation in writing. Participants who are automatically enrolled will have an initial deferral contribution of 6% with an annual increase of 1% on January 2nd of each subsequent plan year to a maximum deferral contribution of 9% unless changed by the participant.

The Company may make discretionary matching contributions. During 2024, the Company elected to make a discretionary matching contribution equal to 100% of a participant’s elective contribution, up to 5% of the participant’s eligible compensation, for the Plan year.

The Company may also make discretionary profit sharing contributions, which are allocated to each eligible employee in proportion to their eligible compensation as a percentage of the eligible compensation of all those eligible employees within an employee classification group. To be eligible for the profit sharing contribution, an employee must be employed on the last day of the plan year, except for employees that retire or become disabled or deceased during the Plan year. The Company made no such contributions during 2024.

Participant Accounts

Individual accounts are maintained for each participant. Each participant’s account is adjusted to reflect participant contributions, employer contributions, withdrawals, income, expenses, gains and losses attributable to the participant’s account.

Vesting

Participants are fully vested in their participant and rollover contribution accounts and the appreciation or depreciation thereon at all times. Vesting in employer contributions, and earnings thereon, is based on years of service. Participants vest 25% per year after one year of service and are 100% vested after four years of service. Service with Marathon Petroleum Logistics Services, LLC for employees hired between February 1, 2021 and March 15, 2021, Southwestern Energy Company, GT Logistics, LLC, Air Products and Chemicals, Inc. for employees hired between September 25, 2024 and October 10, 2024, and Howard Midstream Energy Partners, LLC are included to determine years of service for vesting purposes. A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability. Retirement age under the Plan is 65.

Forfeitures

Forfeitures of nonvested employer contributions can be used to reduce employer contributions or pay allowable administrative expenses of the Plan. During 2024, forfeitures of \$184,022 and \$42 were used to reduce employer contributions and pay allowable administrative expenses, respectively. The forfeiture balance was \$111 and \$653 as of December 31, 2024 and 2023, respectively.

Benefit Payments

Upon a participant's termination or retirement, the funds in the participant's account are available to be distributed in a lump-sum payment. Hardship distributions are allowed subject to the provisions of the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balances reduced by the highest outstanding note balance during the prior twelve month period. Notes are paid in installments through biweekly payroll deductions for periods ranging up to five years, or up to ten years for the purchase of a primary residence. The notes bear interest at reasonable rates determined at the date of the note and are secured by the participant's vested account balance. If a participant defaults on the loan, it is treated as a taxable deemed distribution from the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Contributions

Participant and employer contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Investments

Investments are reported at fair value. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis, dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, no allowance was considered necessary by management. If a participant ceases to make note repayments and the Plan Administrator deems the note to be in default, the default will be a deemed distribution to the participant. The note receivable from the participant's balance is reduced once a distributable event occurs under the terms of the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative expenses are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

- Level 1 inputs are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 inputs include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
- Level 3 inputs are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Mutual funds and money market funds are measured at fair value using quoted prices in an active market which represent the net asset value of shares held by the Plan at year end and are categorized in Level 1 of the fair value hierarchy. The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in methodologies used at December 31, 2024 and 2023.

4. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Party in Interest

Affiliates of Fidelity, the Plan's trustee, manage certain Plan investments. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year). Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

6. Income Taxes

The Plan has adopted a volume submitter prototype plan, which obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

GAAP requires plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any plan year in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan Administrator has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued. Except as discussed above, the Plan Administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
