NOTE 1 – DESCRIPTION OF PLAN

The Refined Technologies 401(k) Plan (the Plan) is a defined contribution plan covering eligible employees of Refined Technologies, Inc. (the Plan Sponsor) and participating employers: Refined Shopworks, LLC, Renu Technologies, LLC, Biochem Systems, Inc. (effective 12/15/24), Refined Technologies Upstream, LLC, and Rizon Technologies, LLC (effective 12/15/24) (collectively, the Company). The Plan was originally effective January 1, 2013, and was amended and restated effective January 1, 2024. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and to provide additional security for their retirement and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following provides only general information. Participants should refer to the terms of the legal plan document for a more complete description of the Plan's provisions.

Administration: The Company serves as the plan administrator and is responsible for oversight of the operation and administration of the Plan, determines the diversification and appropriateness of the Plan's investment offerings, and monitors investment performance. Empower Trust Company, LLC (Empower) acts as custodian and recordkeeper for the Plan.

Eligibility: The Plan is provided for all employees of the Company who are not union employees, non-resident aliens, or part-time employees. Participation is available to all eligible employees who are at least 18 years of age and have completed 60 consecutive days of service from the date of employment. Participants may enter the Plan on the first day of the month coinciding with or next following their satisfaction of eligibility conditions.

Contributions: Participants may elect to defer up to 90% of their compensation, as designed, on a pretax or after-tax (Roth) basis subject to the amounts allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to limitations of the IRC. The Plan also accepts participant rollover contributions and direct rollovers from other qualified plans or IRAs, as defined.

If a participant does not submit a salary deferral agreement or does not specifically decline to make salary deferrals, the Company will automatically withhold 6% from their pay and contribute it to the Plan on the participant's behalf in the form of an automatic elective deferral. The election will remain in effect until the participant modifies or terminates the election. Participants may revoke or make modifications to their salary deferral election at any time.

The Company will make a safe harbor matching contribution equal to 100% of a participant's salary deferrals, up to 6% of eligible compensation. The Company may make a discretionary profit sharing to the plan equal to a percentage of a participant's compensation or a discretionary dollar amount determined by the Company. During 2024, the Company did not make a discretionary profit-sharing contribution to the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a guaranteed investment contract as investment options for participants. Participants may modify elections, transfer existing balances, and obtain information regarding investments on a daily basis.

Retirement, Death, or Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their salary deferrals and rollovers, plus actual Plan earnings thereon. A participant's vested percentage in their accounts attributable to employer contributions, plus actual Plan earnings, thereon is based on years of vesting service. A participant is 100% vested in employer safe harbor contributions after two years of service and 100% vested in discretionary profit-sharing contributions after three years of vesting service.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by an outstanding loan balance, if any, during the previous 12 months. The loans are secured by the vested balance in the participants' accounts. Interest rates are determined by the Company and are based on the prime rate plus 2% at the date of issuance. Principal and interest are repaid ratably through payroll deductions. Loan terms are limited to five years unless for the purchase of a principal residence, which could then be extended to 20 years. A participant may only have two loans outstanding at any given time.

Payment of Benefits: Upon termination of service before normal retirement age, a participant may elect to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, or to rollover the distribution directly to another qualified plan under Section 401 of the IRC. If a participant's vested account balance does not exceed \$5,000 upon termination of employment, it will be automatically distributed regardless of whether a participant consents to receive it. Upon normal retirement, disability, or death, the participant or beneficiary is entitled to receive the full amount credited to their account. Benefits may be paid to the participant in a single lump-sum payment in cash or a direct rollover to another qualified plan. If the participant or their beneficiary is required to take minimum distributions, benefits may be paid in a series of payments as required by the IRC.

Participants may receive an in-service distribution upon attaining age 59½, incurring a financial hardship, or incurring a disability. Hardship withdrawals are allowed only to satisfy certain immediate and heavy financial needs.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay any administrative expenses or to reduce any employer contributions. At December 31, 2024 and 2023, there were \$15,145 and \$19,906, respectively, of forfeitures that had not yet been applied. During 2024, forfeitures of \$39,314 were used to reduce employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested in their employer contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 16, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the trustee. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowances for credit losses, as repayments of principal and interest are received through payroll deductions and the notes collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit risks and the risks related to global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair value of investment will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 5 – KEY GUARANTEED PORTFOLIO FUND

The Plan holds a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (formerly, Great-West Life & Annuity Insurance Company) (EAICA), which is called the Key Guaranteed Portfolio Fund (the Fund). EAICA maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA guarantees the repayment of principal and a minimum interest rate, which cannot be less than 0.00% annually, regardless of investment performance. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting rate is reviewed on a quarterly basis for resetting. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the Fund over the year. The average yield earned by the Plan was 1.41% for 2024 and 1.23% for 2023.

Since the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain investments limit the Plan's ability to transact at contract value with EAICA. Such events include the following: (1) premature termination of the contract by the Plan, (2) facility closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The plan utilizes Empower for recordkeeping services, Nova 401(k) Associates for third party administration services, and Gallagher Benefit Services, Inc. and Empower Advisory Group, LLC for investment advisory and management services. The Plan's payment of fees to these service providers qualifies as party-in-interest transactions. The Key Guaranteed Portfolio Fund issued by EAICA and notes receivable from participants also reflect party-in-interest transactions.
