We have performed audits of the financial statements of Ascot Enterprises, Inc. 401(k) Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Plan Description

The Ascot Enterprises, Inc. 401(k) Savings Plan and Trust (the "Plan") is a defined contribution plan covering eligible employees of Ascot Enterprises, Inc. (the "Company") who are 21 years of age and have completed at least one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Participant Contributions

Participants may make voluntary pre-tax contributions of compensation in any amount, up to the dollar limits set by the Internal Revenue Code. Employee rollover contributions are also permitted. Participants may enter the Plan each January 1, April 1, July 1 and October 1, and may change the amount of their contribution quarterly or stop deferring at any time.

Company Contributions

The Company may make a discretionary match contribution equal to a percentage of each participants' elective deferrals; the exact percentage is determined each year by the Company. The Company may also make a discretionary profit sharing contribution; determined annually. To be eligible for the Company contributions, participants must be employed on the last day of the Plan year and must have completed 1,000 hours of service during the Plan year. The Company made a discretionary matching contribution of \$30,000 for the year ended December 31, 2024. The Company did not make a discretionary profit sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, Plan earnings, and is charged with an allocation of administrative expenses. Allocations of the earnings and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option of investing in a variety of investment funds offered through Lincoln National Life Insurance Company. All amounts in participant accounts are participant-directed and allocations can be changed daily.

Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Company's contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after one year of credited service.

Note 1. Plan Description (Continued)

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Company contribution amount. These forfeitures may be used to pay Plan expenses and also to reduce future Company contributions.

As of December 31, 2024 and 2023, there was \$74 and \$72, respectively, available to offset Plan expenses or reduce future Company contributions. There were no forfeitures used to offset Plan expenses or reduce Company contributions during the year ended December 31, 2024.

Benefit Payments

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, installment payments, or rollover into another qualified plan. Participants may also remain in the Plan as an inactive participant. Hardship withdrawals are also allowed from the fully vested portion of a participant's account balance with certain restrictions, as outlined in the Plan document.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Lake City Bank, as Trustee, and Lincoln National Life Insurance Company. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date plus one-day basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through July 16, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Lincoln National Life Insurance Company

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Lincoln National Life Insurance Company, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment earnings as shown in the accompanying statement of changes in net assets available for benefits, including net realized and unrealized appreciation or depreciation in fair value of pooled separate accounts and interest income from investment contracts.
- c. The supplemental schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"): Valued at the net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contracts with Insurance Company

The Plan holds a traditional investment contract, the Guaranteed Investment Contract, with Lincoln National Life Insurance Company ("LNL"). The contract meets the fully benefit-responsive investment contract criteria, and is, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The investment contract is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on the ability of LNL to meet its financial obligations from the general assets of the company. Interest is credited daily at an interest rate that will not be less than the guaranteed minimum interest rate stated in the contract. The credited interest rates can be changed quarterly. Restrictions apply to the aggregate movement of funds to other investment options. Surrender charges could limit the ability of the Plan to initiate/complete a transaction at contract value. Certain circumstances would allow LNL to terminate the contract and settle at amounts different from the contract value; however, Plan management does not believe that any of the specified circumstances are probable.

Note 6. Income Tax Status

The Plan, which is maintained using a prototype plan document, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC") and therefore not subject to tax. The Plan has been amended since this date; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Transactions with Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Plan investments at December 31, 2024 and 2023, are pooled separate accounts and shares of investment contracts managed by LNL as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company. Investment related expenses are included in net realized and unrealized appreciation of fair value of pooled separate accounts.

Note 8. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
